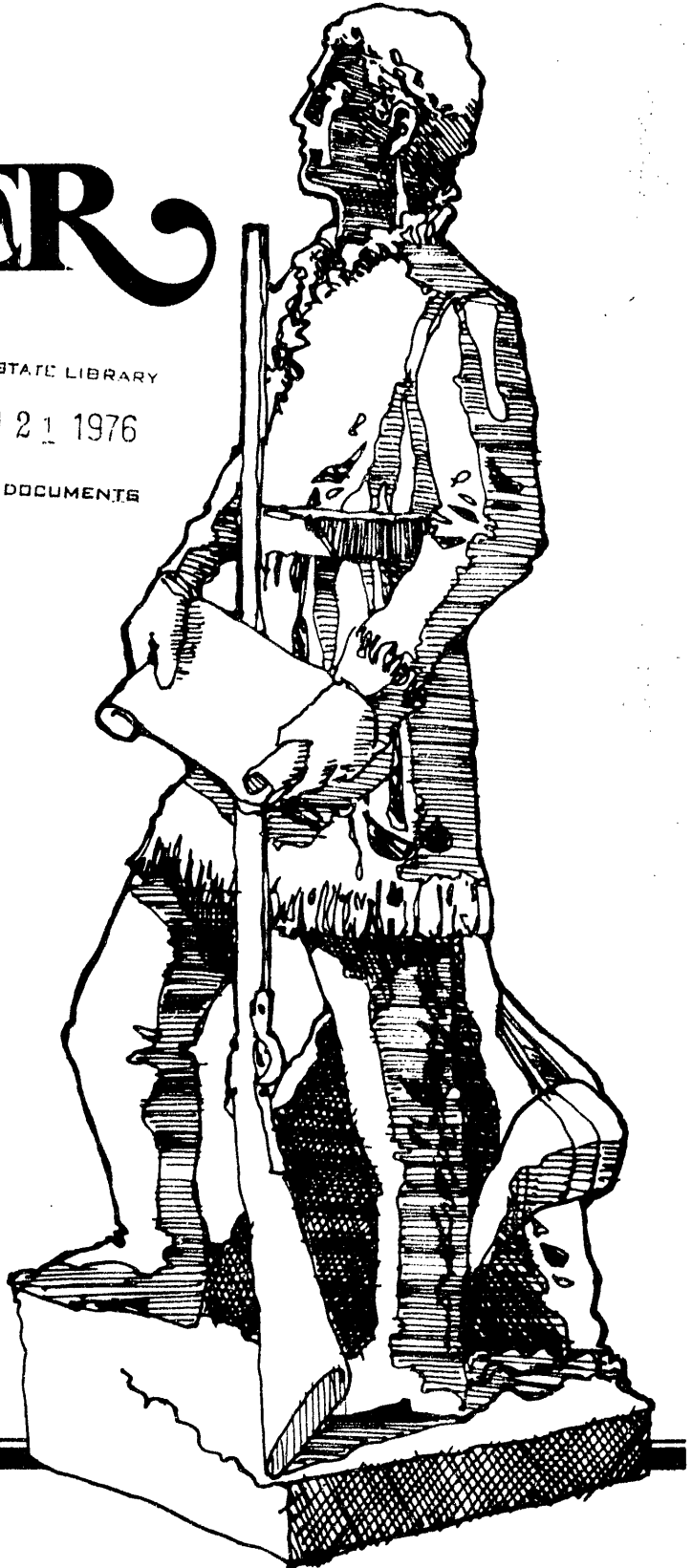

NOTES ON THE ISSUE

Because a state holiday, Confederate Heroes Day, on January 19 shortened our deadline period for this issue, we received fewer documents than usual for publication. Most of the issue consists of notices of open meetings.

We call your attention to the opinion of the Attorney General concerning construction and rehabilitation costs of facilities at institutions of higher education. The opinion was requested by Bevington Reed, Commissioner of Higher Education. Of special note, too, is the Texas Water Quality Board's proposal to adopt by reference the State of Texas Continuing Planning Process, which was prepared by that agency pursuant to the Federal Water Pollution Control Act (as amended).

The "In Addition" section contains a notice of investigation and hearing to be held by the U.S. International Trade Commission to determine whether shrimp is being imported into this country in quantities detrimental to the domestic shrimp industry. The notice was submitted to this division by the Office of State-Federal Relations.

Request for opinion from Ted Butler, Criminal District Attorney, Bexar County, San Antonio.

Summary of Opinion: Independent school districts not holding an election for independent school district trustees on the day set for the election of county school trustees in counties having a population in excess of 500,000 are required to hold county school trustee elections within the school district. Independent school districts holding simultaneous elections for district trustees on that day cannot be required to provide voting places for voters from the school districts not holding such a simultaneous election.

Summary of Opinion No. H-761

Request for opinion by Rep. Bill Presnal, Chairman, House Appropriations Committee, House of Representatives, Austin, Texas.

Summary of Opinion: There is no minimum requirement for time served in the military during World War II in order for an individual to qualify for the tuition exemption provided by section 54.203 of the Education Code. A discharge in satisfaction of a personal request for release from military service during World War II constitutes a basis for disqualification from tuition exemption eligibility under section 54.203, regardless of the time served prior to the request for release. A veteran need not have been eligible for or received G.I. educational benefits from the federal government in order to qualify for the tuition exemption of section 54.203.

Response to request by Bevington Reed, Commissioner, Coordinating Board, Texas College and University System, Austin, Texas.

Summary of Opinion: The Coordinating Board, Texas College and University System, does not have the authority to regulate the expenditure of construction funds or to consider cost as a factor in determining whether to approve or disapprove an institution's application for the construction, rehabilitation, or repair of buildings or facilities at institutions of higher education. However, its

promulgation of space utilization standards and determination of an institution's program, role, and scope will indirectly affect the amount of funds expended for construction and rehabilitation of buildings.

Supplementary Rules and Regulations

THFC Emergency Rule and Regulation No. 11 315.07.06

Promulgated pursuant to Article 4418(h), Vernon's Annotated Civil Statutes.

.001. *Time Extension and Transfer of Certificate Procedures.* The Texas Health Facilities Commission, hereinafter referred to as the Commission, has determined and hereby finds and declares that an imminent peril to the public health, safety, and welfare requires adoption of this emergency rule for the reason that no procedure or rule currently exists for making application to the Commission for transfer of certificates or time extensions. The enactment of said rule or procedure being necessary for the proper administration of Article 4418(h), Vernon's Annotated Civil Statutes, and for applying for relief from conditions placed in orders up to this date and issued by this Commission, and further, for the reason that any delay in enacting such rule and procedure would delay the development of health care facilities and services for the people of Texas.

(a) *Time Extension.* Any completion, partial completion, development, or other time deadline established by Article 4418(h), Vernon's Annotated Civil Statutes, the rules and regulations promulgated thereunder, or orders of

the Commission, which apply to Declaratory Rulings or Exemption Certificates, may be extended by the Commission upon an affirmative finding of good cause.

(b) *Transfer of Certificates.* Exemption Certificates and Declaratory Rulings are not transferable without the written consent of the Commission, upon an affirmative finding of good cause.

(c) *Procedures.* Applications for time extensions or transfers under paragraphs A and B above, shall be filed with the Commission utilizing THFC Forms 21 and 25, with supporting documentation attached. Procedures for notice to the public, eligibility as a party, and hearing shall be as prescribed in THFC ERR No. 8, paragraphs A, B, C, D, E, and F; provided however that where the Chairman, or his designee, determines that a different means of notification and process is appropriate, the Chairman, or his designee, will notify the applicant of the procedures which will apply in the place of those prescribed in THFC ERR No. 8.

(d) No application received by the Commission by 5 p.m., January 31, 1976, for an extension of time or transfer of certificate will fail for the reason of lack of ruling by the Commission by February 1, 1976.

Texas Water Quality Board Continuing Planning Process 130.21.00

The Texas Water Quality Board is proposing to adopt the Continuing Planning Process for the State of Texas. The broad goals of the Continuing Planning Process are to insure that necessary institutional arrangements and management programs are established to make and implement coordinated decisions designed to achieve water quality goals and standards; to develop a statewide (state and areawide) water quality assessment, and to establish water quality goals and state water quality standards which take into account overall state and local policies and programs, including those for management of land and other natural resources; and to develop the strategic guidance for preparing the annual state program plan required for submission to the United States Environmental Protection Agency.

Public hearings are being held in order to receive testimony which is relevant and material to proposed revisions of the state's Continuing Planning Process. These proposed revisions were developed pursuant to Title 40 of Federal Regulations Part 30, Policies and Procedures for Continuing Planning Process, effective November 28, 1975.

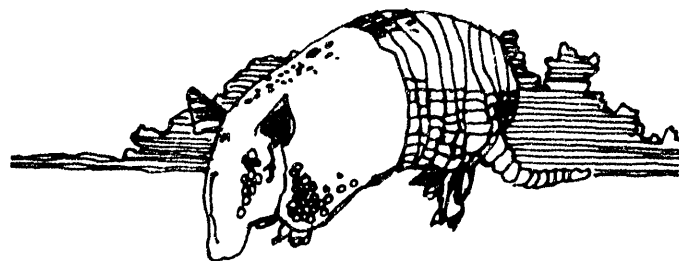

The Open Meetings Act (Article 6252-17, Texas Civil Statutes) requires that an agency with statewide jurisdiction have notice posted for at least seven days before the day of a meeting.
