Note from IRS: "If you do not file your e-Postcard on time, the IRS will send you a
reminder notice but you will not be assessed a penalty for late filing the e-Postcard.
However, an organization that fails to file required e-Postcards (or information returns –
Forms 990 or 990-EZ) for three consecutive years will <u>automatically lose its tax-exempt</u>
<u>status</u>. The revocation of the organization's tax-exempt status will not take place until
the filing due date of the third year."

As of December 31, 2012, 11 out of 45 chapters (24%) have properly filed their respective 2012 IRS Form 990-N (e-postcard) As of March 15, 2013. All chapters need to adopt a calendar year tax year.

<u>Patriot Funds Projects Committee</u> –A 'Roll Forward Report' based upon the By-Laws, Awards Budget, and Investment Earnings Realized and Donations. The report provides guidance to the Patriot Fund trustees for making awards.

<u>Chapter Banking Information</u> I have received banking information for 27 of the 45 Chapters. By transferring the chapter dues via ACH it will eliminate the large group of outstanding checks as shown above.

Chancellor's Report and Report of the Bylaws Committee

March 17, 2013

Since my last report there have been several issues pertaining to the Texas Society. These are summarized below.

Pending Litigation: None

Potential Litigation: None

Contract Review: No contracts have been presented since the Fall 2012 Board of Managers

meeting.

Constitution and Bylaws: Proposed changes to the TXSSAR Constitution and Bylaws have been submitted to the State Secretary and distributed in accordance with the Constitution and Bylaws. The proposed changes are as follows:

Recommended Changes to TXSSAR Constitution:

Article V, Section 1:

The officers of this Society shall be a President, President Elect, State Secretary, Staff Secretary, Communications Secretary, Treasurer, Registrar(s), Historian, Chancellor, Chaplain, Vice-president for Americanism Contests and Awards, and District Vice Presidents, whose duties shall be prescribed by the Bylaws. They shall be elected by a majority vote of the delegates present at the Annual Meeting of the Society, be installed at the Annual Meeting at which they were elected, shall hold office for one year and or until their successors are elected and qualified.

Any other officer except the President may hold the office of Chancellor.

Recommended, Bylaws Committee. Approved, Board of Managers

Article VIII, Section 3:

Local chapters shall hold an Annual Meeting not less than thirty days prior to the Annual Meeting of this Society for the election of officers and the transaction of business. The said officers shall be elected to serve for the same fiscal year as the state officers as provided in Article V of the Society. Names and addresses of officers elected shall be immediately forwarded to the State Secretary. The outgoing local Chapter President or his designee shall file the Chapter's annual report as specified by the Americanism Contests and Awards Committee.

Recommended, Bylaws Committee. Approved, Board of Managers

Recommended Changes to TXSSAR Bylaws:

Article XVII, section 7: change "member at large" to Communication Secretary. **Recommended, Bylaws Committee. Approved, Board of Managers**

Article XVIII, section 9: delete the reference to \$8.00 reinstatement fee. **Recommended, Bylaws Committee. Approved, Board of Managers**

Article XVIII, section 13: delete the reference to the transfer fee and add a provision to provide copy of the Record Copy of the individual's application or to pay the fee specified by the National Society for the Record Copy.

Recommended, Bylaws Committee. Approved, Board of Managers

Article XX, section 1: Clarify number of delegates in subsections B and C to determine if each chapter gets one delegate at large plus one delegate for 7 members or the delegate at large covers the first seven members.

Recommended, Bylaws Committee. Approved, Board of Managers

Article XX, section 1: Move "all delegates must be members of this Society in good standing" from subsection C to the preamble so that it reads:

"If a member is in good standing, the following shall be members of the Annual Meeting or any meeting and entitled to vote therein:"

Recommended, Bylaws Committee. Approved, Board of Managers

Article XX, section 1(F): delete as redundant with Article 18, section 3. Recommended, Bylaws Committee. Approved, Board of Managers

Article XXVIII, section 13: The "Patriots Fund" shall consist of Principal Funds acquired according to Section 2 above, and also include those certain "Available Funds" acquired as a portion of the earnings (interest, dividends, and capital gains) on the investment of said Principal Funds. The definition of "Available Funds" is described as those certain funds derived solely from earnings (the aggregate of realized capital gains reduced by realized capital losses, but not below zero, interest earned, and dividends earned) on the investment of the Principal Funds and Patriot Fund Expenses donations for the designated period of time as from January 1st through December 31st of the year prior to the preceding year, e.g., realized capital gains reduced by realized capital losses, but not below zero, interest earned, and dividends earned, and Patriot Fund Expense donations from January 1, 2009 2011, through December 31, 2009 2011, considered "Available Funds" at the Annual Meeting in March 2011 2013. In addition, "Available Funds" shall include Patriot Fund Expense donations received during the current and prior years. Such Available Funds may be obligated only at the Annual Meeting and should be awarded prior to December 31 of the same Meeting year. Any Available Funds not awarded prior to December 31 of the same current Annual Meeting year shall accumulate as Available Funds from year to succeeding year. However, projects duly

and properly approved by the Texas Society delegates at the Annual Meeting, pursuant to Section 15 below, shall represent appropriation of Available Funds and, remain open for expenditure until the approved project is completed, with the exception that scholarship awards shall be *deemed an apportionment of* "Available Funds" for a period of five years only.

Recommended, Bylaws Committee. Approved, Board of Managers

Article IX – TREASURER

SECTION 1. The Treasurer, in addition to his general duties, shall have the general supervision of collecting, safekeeping, depositing and disbursing all funds and securities of this Society, and shall conform to the following:

A. All funds shall be deposited in the name of the Texas Society Sons of the American Revolution in such accounts and depositories as shall be designated by the Board of Managers. B. Disbursements shall be made by check signed as designated from time to time by the Board

of Managers.

C. He shall be placed under bond for the faithful performance of his duties in such amounts as

D. The accounts of this Society shall be audited by a Certified Public Accountant selected by the Board of Managers at the pleasure of the Board of Managers and whenever there is a change in the position of the Treasurer.

SECTION 2. The Treasurer shall assist the State Secretary in the completion of the Annual Report to the NSSAR.

SECTION 3. This position requires high-level computer skills to include a basic understanding of databases, spreadsheets and various word processors. The current system operates using Microsoft Office XP.

The Treasurer is elected at the annual meeting of TXSSAR to hold office for a two-year term or until a successor is elected and qualified, and is eligible for re-election for one additional consecutive two-year term.

Requirements:

1. Financial knowledge of the organization.

shall be determined by the Board of Managers.

- 2. Should have a Bachelor's degree in accounting or finance.
- 3. Should be a CPA, CMA or MBA or other profession with extensive accounting training.
- 4. Personal commitment to devote the time necessary to perform the responsibilities of Treasurer.
- 5. Understanding of financial accounting for nonprofit organizations.

Responsibilities:

- 1. Serves as Chair of the Finance Committee.
- 2. Manages, with the Finance Committee, the Board of Manager's review of, and action related to, the Board of Manager's financial responsibilities.
- 3. Works with the President and finance manager to ensure that appropriate financial reports are made available to the Board of Managers on a timely basis.

- 4. Assists the President and financial manager in preparing the annual budget, and presenting the budget to the Board of Managers for approval.
- 5. Works with the Finance Committee and the President to develop Fiscal Policies for recommendation to the Board to ensure the financial integrity and sustainability of the organization.
- 6. Works with the Finance Committee and the President to develop long-term financial strategies.
- 7. Keeps currently informed of legal, regulatory and sector developments relating tote Board of Manager's financial responsibilities.
- 8. Coordinates with the State Compliance Officer on Sarbanes-Oxley matters.

Recommended, Bylaws Committee.

Article XVII (A) - COLOR GUARD AND COLOR GUARD COMMITTEE

SECTION 1.The Color Guard Committee is a standing committee of the Texas Society of the Sons of the American Revolution. The chairman of the committee shall be appointed by the president of the society, who may, in his discretion, appoint the commander of the Color Guards the chairman. If the president appoints a person other than the commander of the Color Guard, as the chair of the committee, the commander of the Color Guard shall be a voting member of the committee and shall serve as *ex officio* vice-chairman of the Color Guard Committee. Other members of Color Guard Committee shall be appointed as provided in these Bylaws. The Color Guard Committee shall be responsible for the following:

- a. Organizing and notifying the Color Guard commander of various events the Color Guard is to participate in;
- b. Determining the awards of the Texas Society of the Sons of the American Revolution Color Guard and promulgating the requirements for those awards;
- c. Determining whether a Color Guard event shall be considered a chapter event or a state event and making appropriate petition to the National Society of the Sons of the American Revolution for the recognition of Color Guard events in Texas as national events; and, d. Such other matters as may be directed to the committee.

SECTION 2. There is created as an official and major component of the Texas Society of the Sons of the American Revolution a Color Guard. The Color Guard, by the wearing of revolutionary war period clothing, promotes the Texas Society of the Sons of the American Revolution and the patriotic, educational, and historical mission of the Sons of the American Revolution and fosters respect for and education about the flag of the United States of America at TXSSAR and community functions.

SECTION 3. The TXSSAR Color Guard, subject to the approval of the Color Guard Committee and the Board of Managers, may promulgate (1) a command structure and criteria for the selection and removal of officers, (2) bylaws necessary for the proper function of the Color Guard and (3) such incidental documents, such as handbooks, uniform guides, drill manuals or the like that may be necessary for the proper functioning of the Color Guard.

SECTION 4.The TXSSAR Color Guard may accept donations of materials for the proper functioning of the Color Guard, including, but not limited to flags and flag holders, muskets, rifles, side arms and clothing. Such items shall be held by the TXSSAR Color Guard in the name of and on behalf of the State Society.

SECTION 5. As the Texas Society of the Sons of the American Revolution is a 501(c)(3) charitable organization under the United States Internal Revenue Code, neither the Color Guard Committee nor the Color Guard shall take any action which demonstrates or implicates support of a particular partisan or political point of view. For example, a Color Guard may perform a flag ceremony at a political campaign event, but should leave the site after the event, or, if staying, should do so out of their color guard uniform or after removing any devices or medals that would reflect their membership in the Sons of the American Revolution.

Recommended, Bylaws Committee.

Other Matters:

An issue has arisen concerning the TXSSAR Archives at the University of North Texas. Currently, the materials in the archives have been donated to "the Friends of the UNT Library." The UNT Library is requesting that the materials be donated to the UNT Library. This change would mean that the archives would become property of the State of Texas and would generally be accessible to the general public under the Texas Open Records Act. It would also mean that materials in the archives could be disposed of by the library in accordance with the library's deaccession policy.

A second proposal is to adopt a TXSSAR "Handbook." This would be akin to the SAR Handbook, but would contain material that does not belong in either the TXSSAR Constitution or Bylaws. Items that might be in such a handbook could include Sarbaines-Oxley compliance, material that is appropriate for donation to the TXSSAR archives, and TXSSAR medal precedence.

Our previous primary contact, Jennifer Sheehan, resigned from UNT in February to relocate with her husband to New York. Morgan has been working diligently with me to keep things moving with regard to the TXSSAR Archives ("Archives").

In order to process the Archives it was required that they first be transferred from the Friends of the UNT Libraries ("Friends") to the UNT Libraries. A new Gift Agreement was negotiated with UNT Libraries, essentially replicating the existing agreement with the Friends. That agreement was reviewed and approved by the Chancellor. Officer Report -TXSSAR Vice President, Americanism

There are seven (7) items on which to report.

- 1. **Manual for Contests, Medals, and Awards**. The TXSSAR Society Manual dated in March 2000 is outdated and many topics are no longer used. A new manual will be prepared and presented to the CMA Committee for review and approval.
- 2. **Youth Contest Programs Updates on the TXSSAR web site**. Information on Youth Contests posted to the TXSSAR web-site needs to be updated each year.
- 3. Increase participation in Public Service Awards and Non-SAR/DAR Awards.
 - a. On May 29, 2009, President Tom Lawrence asked TXSSAR Officers, Youth Contest Chairmen, and District Vice Presidents to work together to increase participation and recognize and present medals, certificates, and awards to citizens other than SAR and DAR members in 2009. We need to continue this important outreach effort in 2013.
 - b. Chairman Public Service Awards Committee, Art Munford worked with District VP's and various Chapters to focus on the TXSSAR Society's goal. The effort led to the presentation of 68 Public Service Medals to Fire, Law, EMS, and Heroism Award recipients, versus 78 in 2011. Four Chapters presented all four of the Public Service Medals in 2012. We need to work hard in 2013 to get back to where we were in 2010 when 118 medals were presented.
 - c. Based on the 2012 Consolidated Chapter Report thirty-seven (37) medals were presented to non-SAR citizens 36 BGC and 1 SGC Medals versus thirty-two (32) medals the prior year. Our goal is to increase recognition of non-SAR citizens who tell the SAR story. Local Chapters with the help of District VP's are in the best position to achieve the goal Past President Lawrence set for TXSSAR. Local Chapter Presidents are our first line of contact with this group of people. I hope we can improve the effort in 2013.

4. Increase participation in TXSSAR Youth Contests.

The TXSSAR Youth Contest Chairmen, using Youth Contest Brochures and working with District VP's, are encouraged to motivate TXSSAR Chapters to actively reach out to schools and teachers to attract more participation in TXSSAR Youth Contests.

5. Annual Chapter Report Form and Instructions Revised in 2012.

The Annual Chapter Report Form and Instructions were revised in 2012 to be compatible with NSSAR PG and Americanism Reports and to include the Texas report as a part of the National Report. Most reports were made in a timely manner. We had 22 Chapters respond on the TXSSAR Form which is a 45.8% response rate, much lower than we have had in the past. We had 19 Chapters respond on the National Report, which is a response rate of 39.6%. We need to work hard during 2013 to get Chapters to do their reports for 2013.
