Texas Society, Sons of the American Revolution March 27-30, 2014 San Antonio

# President Stephen Rohrbough

The Board of Managers (BOM) meeting at the Hilton Garden Inn in Houston, TX, October 11–13, 2013 was in my opinion a resounding success. My letter inviting fellow TXSSAR Compatriots to attend this BOM turned out to be everything I promised. The three Chapters (Freedom, Piney Woods, and Robert Rankin) hosting the meeting did an absolutely First Class job in planning, coordinating, organizing, and executing the meeting. The teamwork between the leaders of these Chapters was outstanding and the plan came together as planned. I am most pleased with the outcome and what was accomplished for the State Society.

The "Meet the Candidates" forum for Officers running for National offices for 2014-2015 was outstanding. Attendees got to meet the candidates and learn what their goals were, how they planned to achieve them, and how SAR will benefit. Most positions were uncontested, but we got to hear their messages and meet them. Only two positions were contested–Treasurer General and Librarian General. Larry Cornwell (ALSSAR) and Mike Tomme (GASSAR) are running for Treasurer General; and Larry Guzy (GASSAR) and Bruce Pickett (ALSSAR) are running for Librarian General. Candidates in each race presented their credentials and what they wanted to do if elected. Afterwards, the BOM endorsed all uncontested candidates. By close votes, the BOM endorsed Mike Tomme for Treasurer General; and Larry Guzy for Librarian General.

With a last minute change in plans, we were most please to have President Pamela Wright, Texas Society DAR join us for the dinner on Saturday evening. She brought greetings for Texas Society DAR to TXSSAR. President Wright was presented with the SAR Martha Washington Medal for her service during the Presidential term of President Bob Clark. Additionally, I presented her with the SAR Daughters of Liberty Medal and Certificate for her continued support of the Texas Society and working together for the benefit of both DAR and SAR.

As the BOM came to an end, I was energized by the work of the three hosting chapters, knowing that TXSSAR is committed to hosting the National Congress in Houston, TX in 2018. I know we were building our skills and talents to show we can pull together and make Houston and Texas the showcase for an outstanding National Congress in 2018, as we did in 2006 when we hosted the National Congress in Dallas, TX.

Just a quick look back to our trip to Texas Panhandle in mid September 2013 – It was more eventful than mentioned in my remarks in the last edition of the Compatriot Newsletter. Past TXSSAR President George West and District Vice President Bill Harper joined us in Lubbock. After a short Chapter meeting, we had a joint DAR and SAR meeting. We had a great evening with the ladies DAR Chapter. We were greeted with a warm welcome and had a very nice dinner. As the honored speaker, I was most surprised with the interest everyone took with my presentation on the "German Immigration to Pennsylvania in the mid 1750's." There was much conversation and dialogue with the ladies who wanted to tell me about their ancestors and family history. It was an exciting evening for all.

Marie and I then drove to Canyon, TX and had a wonderful visit with George and Judy West. We toured Palo Duro Canyon, Canyon Texas, and had a great dinner at the Amarillo Club in Amarillo, Texas. George and Judy were excellent Host and Hostess. They showed us how it done in the Panhandle. As we had planned to return to San Antonio earlier on Saturday, September 21, 2013, we realized a great opportunity was staring us in the face. We had a wonderful opportunity to join George and Judy to celebrate "Constitution Day" with the DAR. It was hosted by two Amarillo area DAR Chapters at the prestigious Amarillo Club, high above the city with a fantastic view of the Panhandle plains. George and I wore our period uniforms, presented the Colors, and told the story of our respective uniforms. It was fun and we had a great day with the ladies and DAR. I was impressed and wondered why SAR does not celebrate Constitution Day in a similar fashion, as does DAR and add it to our calendar of events.

On November 9, 2013, Marie and I attended the 100<sup>th</sup> Anniversary on the Alamo Chapter DAR at the Petroleum Club in San Antonio, TX; where I was an invited guest representing TXSSAR. We enjoyed the singing by the Texas Youth Singers who have performed in Washington D.C throughout the U.S. and countries overseas as well. The Chapter looked back over 100 years and recognized their many accomplishments through a skit that was a wonderful program. The San Antonio SAR Chapter honored a San Antonio Police Officer for her heroism saving the life of her fellow Police Officer in a shooting incident recently. She was presented a SAR Heroism Medal and Certificate for her service. The picture and presentation was in the San Antonio Express Newspaper the following week.

Marie and I visited the Alexander Hodge Chapter on Tuesday, November 26, 2013 and had a great evening with the members of the Chapter. This visit was a result of contacts during the Battle of Medina Ceremony in August 2013 and Past President Tom Green's interest to visit the Alexander Hodge Chapter.

Marie and I attended the joint meeting of the San Antonio de Bexar DAR and San Antonio Chapter Christmas meeting that has been an annual affair for 14 years. It is held at the San Antonio Country Club, a wonderful venue. I participated in the Color Guard with the San Antonio Chapter. This annual event is special and is shared with the local societies of the Children of the American Revolution.

We have successfully had several meeting on "GoToMeeting.com" with District 8 and the Houston area Chapters. On December 15 and 22, 2013, we had meeting with DVP John Thompson and Chapter Officers. We had a very good agenda to discuss National, State, and local topics. These are informational and training sessions for Districts and Chapter Officers. There is so much to gain in these sessions. There is an exchange of information between State Officers, District VPs, and Chapter Officers. District VPs are the catalyst for the introduction and education of Chapter Officers. It is an opportunity to learn how to perform important duties and take responsibility taking credit of what is done in the Chapter. This translates to doing what is required when preparing Chapter Annual Reports and receiving credit for the work and activities done in the Chapter.

In January 2014, we have been to three chapters in North Texas area installing new Officers at Plano, Athens, and Dallas Chapters on 7<sup>th</sup>, 9<sup>th</sup>, and 11<sup>th</sup> of the month respectively. Marie sold all of her Ladies Auxiliary Quilt fund raising tickets. Visits are planned for the Boerne and Independence Chapters as well.

In February, visits are planned with the Heart of Texas Chapter in Temple, TX and the Laredo Chapter. The big event is the 111<sup>th</sup> Annual George Washington Parade in Laredo, TX. It will be held on Saturday, February 22, 2014 with a Bridge Ceremony with City dignitaries from Nuevo Laredo, Mexico and Laredo, Texas. The parade will have over 170 units, bands, and floats with over 50,000 people in attendance. It is the largest George Washington Celebration and parade in the US.

President General Joseph Dooley will lead the SAR participants and other National Officers with 20-40 Color Guardsmen and wives marching and/or riding on the Laredo Chapter SAR float. The Laredo Chapter will hold its Annual meeting and all out of town SAR and TXSSAR guests will attend this chapter event. It is sponsored by Compatriot Rick Ramirez and his brothers and family members.

Many of the TXSSAR Officers and wives will attend the 2014 Spring Leadership meeting in Louisville, KY February 27-March 1, 2014. The big topic of the day is the funding for the Center for Advancing America's Heritage (CAAH), one five of President General Joe Dooley's PG Initiatives. The State Society has contributed \$2,750 to support the PG' Initiatives for 2013-2014. TXSSAR donated \$1,500 and received a 100% match from Mr. and Mrs. Sam Powell \$1.5 million gift in 2012. The Society also contributed \$750 for the USO Initiative recognizing the three major airports in Texas including DFW, HIA, and San Antonio. And, TXSSAR also contributed \$500 to Mount Vernon Ladies Association for George Washington Portraits to go to two Elementary Schools in Texas, specifically Pin Oak Middle School in Katy, TX and St. Mary's Hall in San Antonio, TX. TXSSAR will be recognized for its participation in the PG Initiatives during the National Congress in 2014 in Greensboro, S.C.

The TXSSAR Annual State Meeting is set for March 27-30, 2014 in San Antonio, TX. It will held be at the Omni Hotel at the Colonnade at Wurzbach and IH-10 West. This is the same hotel where TX DAR held their Annual Meeting in 2012. It is a step up in hotel facilities and dining to the hotels we normally use for Annual Meetings. We negotiated a rate at \$99 per night and reserved 2012 food pricing as well.

Genealogist General Larry Cornwell will present his program of "Best Practices for the application process" of handling application for membership in SAR. With his 3 year experience as Genealogist General, he will tell us how best to make the best of time and energy when talking to new applicants.

for three consecutive years will <u>automatically lose its tax-exempt status</u>. The revocation of the organization's tax-exempt status will not take place until the filing due date of the third year."

As of December 31, 2013, 44 out of 45 chapters (98%) have properly filed their respective 2012 IRS Form 990-N (e-postcard).

RE: Proposed Amendment to TxSSAR Constitution

Dear Hank,

I have received one proposed amendment to the Texas Society's Constitution ("Constitution"), and no proposed amendments to the State Bylaws, for consideration at the 2014 Annual Meeting.

### PROPOSED AMENDMENT.

The amendment in red-lined version to Article VIII, Section 3 of the Constitution has been proposed for consideration at the Texas Society's 2014 Annual Meeting. See the attached PDF.

The amended section, as proposed and without red-line, shall read:

"SECTION 3. Local chapters shall hold an Annual Meeting not less than thirty days prior to the Annual Meeting of this Society for the election of officers and transaction of business. The said officers shall be elected to serve for a one year term, to be determined by the Chapter. The retiring President (or current President if re-elected to office) shall immediately forward to the State Secretary the names, addresses and email addresses of officers elected."

#### ANALYSIS.

The amendment is proposed to correct a conflict in practice that exists in Article VIII, Section 3 of the Constitution. State President-Elect Robert Cohen brought this conflict to our attention at the recent Board of Managers meeting in Houston. At that meeting the Board of Managers requested that the Constitution be reviewed and a resolution to the conflict be prepared for consideration at the Annual Meeting. Compatriot Cohen and I jointly drafted this proposed amendment in response to that request.

Article VIII, Section 3 of the Constitution currently requires all local chapter officers to serve the same fiscal year term as the state officers. This is contrary to the prevailing practice of many of our local chapters. A recent proposal to rectify the conflict by requiring all chapter officers to serve on a calendar year basis was rejected. It is my understanding that the prevailing reason for that proposal's failure was that many local chapters wanted the flexibility of setting officer terms convenient to their needs, rather than by State Society mandate. So this amendment instead proposes to rectify the conflict by providing that local chapter officers shall serve a one year term to be determined by the local chapter.

This amendment also proposes to identify the local chapter officer that is responsible for notifying the State Society of the results of the annual local chapter election. Currently, the Constitution does not specify who the responsible local chapter officer is. It is proposed that the responsible party be the outgoing local chapter President.

#### REQUIRED NOTICE TO CHAPTERS.

Per Article XI of the Constitution, notice of the proposed amendment must be provided to the local chapter Presidents and Secretaries prior to the State's Annual Meeting (or special meeting called for such purpose).

Notice of such proposed New Constitution, Amendments, or change may be given by the deposit of said copy by the state Secretary in the United states Mail, first class postage prepaid, not less than thirty-three days prior to said convention and separately addressed to each President and Secretary at the last known mailing address of each respectively, or by e-mailing it to each President and Secretary not less than thirty-three days prior to said convention and separately addressed to each President and Secretary not less than thirty-three days prior to said convention and separately addressed to each President and Secretary at the last known e-mail address of each respectively as shown by the records of the State Secretary, shall constitute a compliance with the requirements of this provision.

Please send out the required notice of the proposed amendment to the Constitution by no later than Sunday, February 23, 2014. If you need any assistance with this, please let me know. I have copied the State President and State President-Elect on this email so that they may add this item to the Annual Meeting's agenda.

- 1 An update was given on the status of processing the Archives at UNT. The University of North Texas Intern, Thomas Pickens, Jr., has completed an initial processing of the TXSSAR Archives. This project including identifying contents and organizing materials for accessibility. Things to note:
  - The Archives consist of 105 linear feet of materials, including unprocessed materials.
  - The collection needs to grow so all chapters are asked for materials to add to the collection. Most desired are copies of old newsletters, photos, scrapbooks and documentation of events.

# Vice President Americanism, Contests, Medals, & Awards Russell Dart

There are seven (7) items on which to report.

- 1. Manual for Contests, Medals, and Awards. The TXSSAR Society Manual dated in March 2000 is outdated and many topics are no longer used. A new manual will be prepared and presented to the CMA Committee for review and approval.
- 2. Youth Contest Programs Updates on the TXSSAR web site. Information on Youth Contests posted to the TXSSAR web-site needs to be updated each year.

### 3. Increase participation in Public Service Awards and Non-SAR/DAR Awards.

- a. On May 29, 2009, President Tom Lawrence asked TXSSAR Officers, Youth Contest Chairmen, and District Vice Presidents to work together to increase participation and recognize and present medals, certificates, and awards to citizens other than SAR and DAR members in 2009. We need to continue this important outreach effort in 2014.
- b. Chairman Public Service Awards Committee, T. L. Holden worked with District VP's and various Chapters to focus on the TXSSAR Society's goal. The effort led to the presentation of 66 Public Service Medals to Fire, Law, EMS, and Heroism Award recipients, versus 68 in 2012. Seven Chapters presented all four of the Public Service Medals in 2013 versus 4 in 2012.
- c. Based on the 2013 Consolidated Chapter Report thirty-nine (39) medals were presented to non-SAR citizens 36 BGC and 3 SGC Medals versus thirty-seven (37) medals the prior year. Our goal is to increase recognition of non-SAR citizens who tell the SAR story. Local Chapters with the help of District VP's are in the best position to achieve the goal Past President Lawrence set for TXSSAR. Local Chapter Presidents are our first line of contact with this group of people. I hope we can improve the effort in 2014.

### 4. Increase participation in TXSSAR Youth Contests.

The TXSSAR Youth Contest Chairmen, using Youth Contest Brochures and working with District VP's, are encouraged to motivate TXSSAR Chapters to actively reach out to schools and teachers to attract more participation in TXSSAR Youth Contests.

### 5. Annual Chapter Report Form and Instructions Revised in 2013.

The Annual Chapter Report Form and Instructions were revised in 2013 to be compatible with NSSAR PG and Americanism Reports and to include the Texas report as a part of the National Report. Most reports were made in a timely manner. We had 18 Chapters respond on the National Report, which is a response rate of 38.2%. We need to work hard during 2014 to get Chapters to do their reports for 2014.

# 6. Youth Contest Budget and Funding for 2014 Youth Program Awards.

During the Convention, at the recommendation of the Projects Funding Committee, the BOM approved the Youth Budgets for 2014 at \$24,370.

### 7. Need Compatriots to fill key position in the ACMA Committee.

Need compatriots to work with Chapter Annual Reports Sub-Committee. There is an opening in the Reports Sub-Committee for anyone wishing to learn how the Chapter Annual Reports are handled and consolidated for preparation of Society Reports to NSSAR.

#### District 6 - Summary:

All three (3) District 6 Chapter (Dallas, Plano and East Fork Trinity) continue to prosper with regular wellorganized and planned monthly meetings with respectable attendance, consisting of educational and interesting programs - all are very active and very busy. I have managed to attend all of the monthly meetings of each of the chapters with the exception of one for each chapter when I was on business travel or ill. The leadership team of each chapter is fairly stable and consistent to what each has experienced in the past. There is a decent inflow of new prospects to each chapter. In each chapter, these prospects are well-received and best efforts are made to assist and process their applications when they are ready. All three chapters continue to do very well with follow-up with new prospects during the registration process.

All District 6 chapters continue to participate and support a good mix of community, veterans and school-related activities. The ongoing cooperation and synergy between these geographically close chapters and others in neighboring districts helps all those involved and presents a more significant SAR presence in District 6.

### District 6 - Individual Chapter Reports:

- **Dallas #2:** The Dallas Chapter, while not showing any significant signs of growth, has managed to maintain their support of all their recent past activities. They have passed off a select few of their youth awards to the Plano chapter who are geographically better equipped to handle some of those schools. With so many schools, it is an ongoing challenge for Dallas each year to cover the large number of schools and awards that they have to support. Regardless, they still continue to be the state's largest chapter and appear to have fresh leadership in place again this year and more coming over the next few years to maintain that position. Meetings continue on Saturday mornings in a more organized and formal atmosphere and attendance appears to be pretty stable at around 10-15% each month. The current membership count is about 285. Their future is dependent on lining up future chapter leaders and workers which appears to still be a growing concern as many of their newer members are not that active in most of the Dallas activities.
- Plano #37: The pace of the Plano Chapter has slowed somewhat over the past year due to the injury, illness, death and job relocation of some of their key leaders and participants or their spouses. There 2014 President is also a former president and no other members stepped up to take that position. That being said, their support of the veterans,

community, scouts, JROTC and schools with SAR awards programs continues at previous levels, if not higher. Despite being stretched thin, they continue to support some of the smaller chapters (Denton, East Fork Trinity and Ambassador Fletcher Warren) with their color guard when possible. Their support for the VA Hospital in Bonham has been outstanding and continues to grow. Their Stark report showed an increase of nearly 50% over what was submitted last year. Request for their color guard continue to come in at increasing rates as their visibility in the community has reached significant proportions in the Plano and Collin County areas. Meeting attendance continues to be very good (15-20% or better) and business casual is typical at most meetings. Plano took a few hits in 2013, but continues to be model example of organization and getting things done. The current membership is about 115. They have a new registrar this year, which may impact the rate at getting new members in - that is still TBD. Plano's future is also dependent on lining up their next generation of chapter leaders which appears to be a growing concern as the majority of their newer members seem to be of the "wallhanger" variety. They did add several new very active contributors in the past several months which will be a huge help to their ongoing growth. As always, solid participation across the entire spectrum of SAR activities continue to be well-supported by the current leadership team and chapter for 2013. Like 2013, they have a candidate for every youth award.....Few chapters can make that claim.

**EFT #47:** The East Fork Trinity continues to thrive in their new location on the edge of Garland and Rockwall by Lake Ray Hubbard in far NE Dallas County. They seem to be able to draw good numbers from the Rockwall community and surrounding areas. The relocation of the meeting location to Texas Land & Cattle overlooking the lake has been a huge success and savior for the chapter who at one time, was down to 3-4 attending members. Their chapter meetings are typically exceptionally well-attended - about 30%. There is no lack of enthusiasm in this chapter! They have paired up with the Plano Chapter on several activities and the synergy has been good for both chapters. There are several dual members now from both. Likewise, EFT has now grown to also support Ambassador Fletcher Warren up I-30 on selected events in the Greenville area - again good for both chapters. Meeting organization has improved and members meet in an informal atmosphere with good speakers each month. The current membership is about 45. Their list of activities is growing and they continue to prosper.

# District 7 Vice President Lawrence K. Casey

I completed multiple visits to 5 of the 6 Chapters in District 7. I have been well received and brought greetings from the Texas Society and President Stephen Rohrbough. Each Chapter has a unique plan which works for them. Also the variety of programs and events is very positive. **Bernardo de Galvez #1, Galveston:** This Chapter meets on a Regular Basis at Galveston Nicks at Noon on the 3<sup>rd</sup> Saturday of each Month for an excellent \$20 lunch.
