Archives and History Committee

MISSION

Our continuing goal is to acquire significant historical documentation, photographs and recorded membership participation in Texas Society's State & Chapter activities as well as all SAR promotional events for archiving in the TXSSAR Collection. In addition the Committee will endeavor to expand its base by encouraging all Chapters to assign "Historian" officer positions, periodically publishing our state society's history and securing donations of memorabilia and financial aid for future projects.

MEETING REPORT

Held in the Trinity Room (Hilton Garden Inn) at 3:00 pm, Chairman Tom Whitelock opened the meeting with a "door prize" drawing and then directed the attendees' attention to the first subject on the agenda – The status of the new 54 member Archives communication network of Chapter Historians, Officers, interested Compatriots and Committee representatives.

A number of Chapter Presidents had assigned a Compatriot member or other Chapter Officer to serve as their historian of record.

After a second prize drawing (and much levity), the second agenda topic –Funds for the TXSSAR Collection projects – was discussed. Committee Treasurer Donald Stone noted that with recent TXSSAR History Book sales and donations from individuals or Chapters like Denton, our current balance of funds was now a little over \$2,000. Peter Baron offered the motion to reimburse Don for expenses that he has incurred over the last few months. The committee voted approval.

A report from George Harcourt pointed out that his discussion with HEB grocery store chain was not favorable for them setting up a "rebate program" similar to the Albertsons' fund raiser for our Archives Collection.

The Chairman reminded the committee that \$600 will be placed in the TXSSAR Budget each year (starting in 2009) for use in maintaining and expanding the Archives Collection at UNT in Denton.

The committee said they were ready for the third prize drawing prior to the next agenda subject – Recovering Chapter and Texas Society Records & BIOs.

The Chairman reported he had received most of the original TXSSAR Compatriot's SAR applications for transfer to the Archives Collection. In addition an increasing number of Chapters have gathered up documents and photo records to send up to Denton.

The Athens' Chapter was especially lauded for their effort to collect BIO information on new members and their Patriots. Additional forms are being distributed during the BOM and will also be sent out to the Archives network members throughout the year. The "BIO" information is desired in order to prepare for TXSSAR History book Vol. III.

This year's Yearbook competition will have two basic changes:

- 1) No special events envelope will be required since a State Society Scrapbook is not needed for the NSSAR any longer.
- 2) A "Cash Award" is being offered to First Time Chapters who have never entered the yearbook competition and turn in at least their 2008 minutes, newsletters, a list of their officers and a couple of identified activity photos.

Under pressure of the "Committee" another door prize drawing was held just prior to discussion of the final topic -TXSSAR History tab on the website.

The Chairman reported that not enough volunteers for researching "trivia" on the Past State Presidents had come forward and that each member in today's session needed to select one of the remaining PSPs to write up trivia /short stories of unique historical interest. These will be added as links to the existing new tab. Other history stories will also be assigned as well as a link to the TXSSAR Archives Collection records prepared by the University of North Texas Rare Books & Texana staff. They will also scan and enter the President's SAR Application into the link.

Before adjourning the session, the Chairman quickly announced that proposed projects for the months ahead: Presentation of a set of History Books to President George H.W. Bush, Placing History Books on eBay, Creating a video tour of the Archives location and new promotion brochures.

II. **Mission Statement**: The Americanism, Contests, Medals, and Awards Committee is composed of as many sub-committees as deemed necessary by the BOM to conduct the Awards Program and Youth Contests of the Texas Society, Sons of the American Revolution. Sub-Committee Chairmen conduct and administer the Awards and Youth Programs including Orations, Knight Essay, Eagle Scout, JROTC/ROTC, Poster, CAR Essay, and History Teacher Contests. Other Sub-Committee Chairmen include Chapter Annual Reports, Public Service and Law Enforcement, Color Guard, Yearbook, Newsletter, CAR Activities, CAR Liaison, and CAR Award Programs.

III. Goals/ Projects to implement mission.

- a. Chapter Annual Reports All 49 Chapters submit Annual Reports by January 30th each year. (Note that suspense date is January 10th of each Year).
- Chapter Activities. Chapters participate in nine (9) of the twelve (12) reporting elements
 of the Chapter Annual Report and participate in at least one (1) Youth Contest or
 Program.
- c. Youth Contest Due Dates Develop a Handout to reflect Due dates of Youth Contest Programs.
- d. Youth Budget Develop a budget for Youth contests to include scholarship amount, travel expenses, meals, and hotel.
- e. Youth Program Expense Matrix Prepare a Matrix to clarify who pays for what expenses; i.e. Patriots Fund, Richie Fund, War of 1812, Chapter, Escort, or Sponsor. These expenses should be highlighted in Youth Contest and Program Instructions.
- f. Youth Program Brochure Develop and provide a Youth Program Brochure to encourage Chapter to invite contestants to participate in Youth Contests.
- g. Youth Programs 30 Chapters participate in at least one (1) Youth Contest.
- h. Poster Contest Rules Revised Revise contest rules to address problems with posters being submitted that have artistic value, but do not conform to the guidelines required for National competition.
- i. Youth Medals Awarded Track the number of medals presented to youth contestants to determine how to increase youth participation in Youth contests.
- j. Flag Presentations 30 Chapters present a flag certificate to an individual, company, or organization that flies the flag proudly and deserves recognition.
- k. Monetary Donations to Patriots Fund 25 Chapters make annual contributions to the Patriot fund or a selected Youth Program.
- I. CAR Activities and Awards 20 Chapters participate in the John K. Harrell Awards Program by submitting end of year CAR Activities Report.
- m. History Teacher Award 6 Chapters to nominate outstanding history teachers for this Award and recognize their work to educate the Youth in public, private, and home school programs.
- n. CAR Essay Contest 10 Chapters nominate an applicant from the TSCAR to compete in the TXSSAR CAR Essay Contest.
- o. Medal for Veterans Genealogist General Joe Dooley suggested that there was a need to create a medal to give to deserving Veterans. There is no SAR Medal that is appropriate for presentation to Veterans.
- p. Establish a sub-committee for Awards the person holding this position determines who receives Society Contests Awards presented at the state convention. Also, he maintains an inventory of TXSSAR Award Streamers, handles the TXSSAR Service Medals, and sells medals to Chapters.
- q. Establish a sub-committee for Annual Reports The chairman for this sub-committee receives Chapter Annual Reports and consolidated them into a Consolidated Summary Report in order to provide data and information to prepare Society Reports for national awards; and determine TXSSAR Awards for Chapters.
- r. Brochure for Public Service Awards Tom Lawrence asked the Committee to develop a
 Brochure to help chapters and fellow Compatriots to market and participate in the
 Society's Public Service Awards. NEW Item.

s. Cash Awards to replace the current method of funding scholarships for all Youth Contests – Compatriot John Knox raised a point about paying cash awards to Youth Contest winners in lieu of sending funds to University Registrars and eliminating the cumbersome process used by the State Treasurer. The BOM voted to refer the motion to CMA Committee for review and presentation at the next BOM meeting during the Annual Convention in March 2009. **New Item**.

Hill Patriot Fund Streamers, Karl E. Wallace Award, Col. Joe M. Hill Membership Award, Marshall Hunter Attendance Award, E. A. Limmer Award , Outstanding Chapter Award, Frank Watkins Award, Wilbur S. Strong Award, Galveston Award, TXSSAR Americanism Award, Hartsell Stephens Award , TXSSAR Flag Recognition Award.
- b. The Committee encourages Chapters to compete for National Awards including the President General's Chapter Activities Award, President General's Cup Award, and USS Stark Memorial Award. More information is found on the NSSAR web site.
- c. The Committee supports the TXSSAR Society by completing Award Report Forms to compete for National Awards by using the Consolidated Chapter Annual Reports Summary to prepare Society Reports. Reports are submitted to NSSAR to compete for President General's State Society Award, USS Stark Memorial Award, CAR Activities Award, Admiral Furlong Flag Award, and the Graham T. Smallwood, Jr. Newsletter Award.
- VI. **Special Presentation.** The Chairman, Council of Chapter Presidents Charles Luna asked the CMA Committee to make a presentation to the committee reflecting an in-depth overview of the content, instructions, calculations, and methods used to determine Chapter winners for all TXSSAR Contests and Awards.

Chairman Bud Schwart opened the meeting and provided attendees an agenda, handouts, and summary of the Annual Consolidated Report used to determine Chapter winners for TXSSAR Contests and Awards. An Overhead Slide presentation was used for clarity of topics presented.

Stephen Rohrbough presented information on the TXSSAR Society Awards and the Introduction for Chapter Annual Reports.

Bob Cohen presented information regarding the specific items contained in the Chapter Annual Report and discussed specific Instructions for preparing the Annual Reports.

Russell Dart presented the Consolidated Annual Report for all reporting Chapters and showed how the Consolidated Report was used to determine winners for the various TXSSAR Society Awards.

The COCP held its meeting at 8:00 AM, 25 October 2008 at the Temple BOM.

Chairman Luna called the meeting to order and established a quorum was present. There were 31 Compatriots in attendance, representing 24 TXSSAR Chapters.

Chairman Luna requested that COCP Secretary Edwards give the invocation. Upon conclusion of the invocation, Chairman Luna welcomed guests, COCP members and introduced members of the team presenting the Chapter Annual Report Program. In an effort to conserve time and in as much as the minutes of the Tyler BOM had been published, the decision to forego the reading of minutes was declared by Chairman Luna.

The Chapter Annual Report was the primary focus of the COCP meeting at the October 2008 Temple BOM. Fully realizing the importance in completing the Chapter Annual Report in an accurate and timely manner, a working seminar re the Chapter Annual Report was conducted for CCP members and any other interested parties by TXSSAR Americanism VP Rohrbough, District 11 VP Walker, CMA Co-Chairs Schwart, Cohen and Compatriot Dart. The program was presented in a very detailed and informative manner utilizing an overhead projection format to present the program. A question and answer session conducted by COCP V-Chair Stevens followed. Genealogy Committee

Mission Statement:

The Mission of the Genealogy Committee is to serve as a resource to TXSSAR and individual chapters with respect to application preparation and genealogical research.

Short Term Goals:

Prepare a chapter registrar's manual explaining in detail how to properly prepare an application. Include examples of "dos" and "don'ts". Outline acceptable genealogical documentation that must be submitted with the application, including examples. Publish the manual on the TXSSAR web site so that it will be readily available for all chapter registrars and other interested persons and can be easily updated as necessary.

At the October 2008 BOM meeting in Temple, conduct a seminar for interested persons concerning application preparation and necessary genealogical proofs using the above chapter registrar's manual as a guide.

Long Term Goals:

As requested by the various district vice-presidents, present application preparation/genealogical proof seminars for small groups of chapters in different parts of the state.

Review the different hand outs now available describing requirements for membership in the SAR. Develop a new hand out if deemed necessary. Contact genealogy libraries across the state to have these handouts displayed to create interest in the SAR.

Information and Technology Committee

Several chapters are now using the state website to avoid having to have their own domain names and hosting services, and thereby save money.

The Committee is proceeding with plans to change its website hosting service from iPowerWeb to Blue Host. This will make possible several goals that are not possible with the current hosting service:

- Better E-mail service for officers of TXSSAR
- 2. Bulk mailer service
- 3. Information-gathering capabilities such as conference registration, surveys, etc.

It is expected that at least the first two of these goals will be accomplished before the 2009 State Meeting in Nacogdoches. The third item is a longer-term goal which will involve much more effort.

Long Range Planning Committee

The meeting was called to order by chairman Tom Lawrence and it was determined that a quorum was present.

Old business was discussed and State Meeting chairman Larry Stevens reported that no hosts were locked up for 2010 as yet except for Paul Carrington for the convention. He also stated that the committee sent a proposal to the Executive Committee regarding the issue of how the host chapter and state split the revenue from a convention.

The first order of business was a discussion by Staff Secretary Don Pugh of the new procedures for the BOM's. This included the officer reports, committee reports and the committee meeting schedule. The LRP members felt the new procedures were working well and were cutting down the general session time wasted on long reports that could be easily read. Putting committee and officer reports on the website was also working well as it gave all members the opportunity to see what had been done at prior committee meetings and by officers. The schedule of committee meetings was also working well and there were fewer conflicts so members could attend more meetings.

IT Committee chairman and Webmaster Charles Baker discussed the status of the various projects. He reported that several chapters were now using the TXSSAR site to host their chapter pages. He was still working on the bulk mailing software and had not yet made improvements to the web page appearance.

Don Pugh discussed how to get more chapters involved in the state organization. Many suggestions were made but no specific action was taken by the committee.

John Greer had submitted a written proposal to have TXSSAR sell various medals to members and chapters. This would assist those members and chapters who could get the medals faster than from national and could result in some income to the state if the medals could be purchased in bulk at a discount. The committee felt it was too much of an administrative burden for TXSSAR and declined to take any action.

President Harry Fife brought up the problem of the make-up of the Nominating Committee. It is made up of the immediate past state president as the chairman and a representative of each chapter. He said that often the chapters do not send representatives and the actual nominating process is carried out by only a handful of members. He suggested we change the make-up of the committee in order to get better participation. The committee felt that even though the process was somewhat flawed it did allow for broad representation and should be kept. No action was taken.

There was a discussion raised by PG Nathan White and Mark Hansen about raising the cost for the application fee for both new members and supplementals. It was referred to the Fee Committee for further action.

Staff Secretary Don Pugh raised an issue about whether or not TXSSAR should redistrict the district into new configurations. After some discussion the matter was referred to a sub-committee of Mark Hansen and George West to report back at the state convention.

The meeting was adjourned.

Chairman Charles Luna called the meeting to order and the Committee immediately got down to business. Chairman Luna told the committee that if we really concentrated on the list of Corporate Giving Programs, distributed and assigned by Committee Secretary Everheart, at the Committee's first meeting at the Tyler BOM, there was no reason why the Committee could not attain our goal of increasing the TXSSAR youth related programs scholarship amounts to \$5.000 per program on an annual basis. Charles informed the group that the only thing that might cause the extension of our goal from one to two years is the current downturn in the economy.

One of the things that Chairman Luna wanted to talk about at this meeting was his concern over naming the awards and recognition of support levels. He also reported to the Committee that he planned to submit a grant request to Chesapeake Energy Corporation in the near future and stressed, Chesapeake only considers and restricts grant requests to those geographical areas in which they are drilling or engaged in active production. Charles informed the committee that his cover letter detailed the number of members and Chapters in the Dallas-Ft. Worth area and using that letter as an example, emphasized that each cover letter

will have to be customized to conform to restrictions of each grant submitted. Compatriot Luna told the Committee members that in order to award \$5,000 annual scholarship for TXSSAR youth related programs and becoming self sufficient, the Patriot Fund will have to generate at least \$35,000 in funds from the current endowment and grant monies we receive from supporting entities.

Next, Chairman Luna discussed the different levels of recognition to be given to "supporting entities" based on the level of support to the Patriot Fund. All "supporting entities" will be presented with a Texas Society Certificate of Appreciation, recognition of the "supporting entity" on the TXSSAR website, and press releases recognizing the entity for their support. Secondly, those entities that give support in an amount of \$25,000 or greater, would receive additional recognition for their support of the TXSSAR youth related educational programs. Charles asked the Committee's opinion on this suggestion. Among the other suggestions, was one that recommended we give the "SAR Alexander Hamilton Medal" to the supporting entities. Another proposal was that we should give a more impressive award. FPG Nathan White stated that his fraternity had once spent over \$1000.00 for an award for a \$50, 000.00 contributor to the fraternity. After discussion, a distinctive custom made plaque that would hang in the entity's boardroom, main lobby or other place of prominence was determined as being an appropriate award. An additional suggestion was made to name the recognition level awards after our Countries first three Presidents, George Washington, John Adams and Thomas Jefferson, designate the three levels of special recognized support and include the words "FOUNDING FATHERS" in the awards' title.. Chairman Luna stressed that we must be careful not to infringe on anyone's copyright or violate SAR restrictions in naming awards. After much discussion and debate, the Committee approved the following three support level awards. The three approved award levels are:

- 1. Texas Society George Washington Founding Father's Award.(\$100,000+)
- 2. Texas Society John Adams Founding Father's Award (\$50,000 99,000)
- 3. Texas Society Thomas Jefferson Founding Father's Award (\$25,000 49,000)
