■ Note from IRS: "If you do not file your e-Postcard on time, the IRS will send you a reminder notice but you will not be assessed a penalty for late filing the e-Postcard. However, an organization that fails to file required e-Postcards (or information returns – Forms 990 or 990-EZ) for three consecutive years will <u>automatically lose its tax-exempt status</u>. The revocation of the organization's tax-exempt status will not take place until the filing due date of the third year."

Texas Society Sons of the American Revolution

The Internal Audit Committee conducted its semi-annual review of the books and records of the Texas Society Sons of the American Revolution (the Organization) using the review procedures and guidelines as enumerated in the audit guide and herein and such other procedures as deemed necessary and appropriate by the Review Committee. This review was conducted was conducted August 4, 2012

The review included but was not limited to the following transactions for the period January through June 30, 2012:

Cash, cash receipts, cash disbursements, donations, and Pay Pal

- Select review of all bank statements and monthly bank reconciliation reports
- Review of cash receipts from dues
 - o 100 % of the funds deposited for dues were examined
 - For the two largest deposits and one out of seven batches, receipts were traced from individual checks to the bank statements and to the database for correct recording. This resulted in a detail review of 20.5% of total deposits.
- Review of Patriot Fund donations received and traced to appropriate bank account
 - 100 % of the donations received and disbursements from the Patriot Fund were examined
- Review of Pay Pal procedures, posting, and controls
- Review of Registrar transactions
- The 2011 Audit report was not complete as of the completion of the Interim audit. This should be accomplished by the October Board of Managers Meeting.
- Review of cash disbursement files and support
 - o 85.9 % of all disbursements from the operating account were examined
 - o 80.1 % of all deposits to the operating account were examined
 - o 100 % of all transfers to and from the operating accounts were examined
- Investment accounts were examined and traced to statements (please see separate report)

Audit Sub-Committee Report of Immaterial Exceptions and Recommendations

For the period

January 1, 2012 through June 30, 2012

Members participating were: Tom Jackson, Marvin Morgan, Russell Dart, Stephen Tanner, Jim Jones, Peter McLellan, Wendell Edwards and John Beard, Treasurer

Recommendations from the Audit Committee:

- 1. Youth award winners should be listed on the website prior to be distribution and a link to the treasurer's state e-mail address for any questions.
- 2. Chapter sponsor of the State Annual meeting each year should provide records of the fees and expenses with the reimbursement check to TXSSAR
- 3. Request Registrars bring bank statements to BOM (January September) and to the Annual Meeting (October December) for examination by the Audit Committee.
- 4. There should be uniformity in the preparation of summary information from the registrars. This information provides the basis of documentation for journal entries into the books and records of the Society.
- 5. Separate files should be kept for each of the two registrar accounts. Deposits from the two registrars should not be comingled on the same deposit slip. This will permit a simplified audit trail. Account analysis will also be simplified.
- 6. The Society Secretary is requested to provide a copy of the original minutes of the Board of Managers Meeting where stipends were authorized.

Texas Society, Sons of the American Revolution Audit Sub-Committee Report of Immaterial Exceptions and Recommendations For the period January 1, 2012 through June 30, 2012

Recommendations and Notes to the Audit Committee:

- 1. The Internal Audit started at 9 am and ended at 2 pm with abreak to hold the committee meeting over lunch.
- 2. The committee meeting was held over lunch and took an hour and a half, including travel time.
- 3. John Beard furnished five blank flash drives and 1 drive with the trial balance and transaction register transferred to excel. Tom Jackson transferred the excel files onto all of the flash drives in addition to prior period report and prior period minutes prior to the audit. This process worked and should be repeated.
- 4. The following were assignments that consumed the time allotted.
 - a. Marvin Morgan served as resource and collector of digital work papers, recording of minutes, and recording of exceptions. This is a function critical to producing a report.
 - b. Russell Dart was in charge of reviewing the operations account for deposits and disbursements. The audit workpapers for the operating account were digitally prepared prior to the event.
 - c. Wendell Edwards was in charge of shredding documents.
 - d. Jim Jones reviewed marketable securities and the profit/loss items.
 - e. Stephen Tanner reviewed the dues accounts.
 - f. Peter McLellan reviewed the Patriot Fund & Bank Reconciliations.
 - g. Tom Jackson served as support and reviewed the registrar accounts.
- 5. Finailization of the report and minutes required 9.5 hours.

Texas Society, Sons of the American Revolution Audit Sub-Committee Report of Immaterial Exceptions and Recommendations For the period

January 1, 2012 through June 30, 2012

Summary of significant changes to the accounting process implemented during 2011/2012

- 1. Accounting software upgrade: We upgraded the accounting system to QuickBooks Premier for Non Profits in November 2011. This will allow us to produce a Balance Sheet by fund or classification. There are several unclassified balances in the Equity section of the Balance Sheet. These will be determined as a part of the 2011or 2012 audit.
- 2. Audit fees initially submitted for 2012 by the auditor were revised to be more in line with 2011 with a modest increase.
- 3. Enhanced deposit process: The high-speed scanner and the cooperation of Patriot Bank in Houston have been very good. By coordinating the membership database posting process with the electronic scanning and production of detailed deposit support the controls over cash receipts handling has been enhanced and a substantial reduction in time has been achieved.
- 4. Accounting recommendations made by Frank Melvin have been implemented. A summary of the more significant items are as follows:
 - Dues collected on behalf of National and Chapters are recorded as liabilities when received, not included in revenue as in prior years.
 - Working with the State Registrars, we are accounting for application fees as non-refundable and will pay out on the same periods as chapter dues remittances. Registrars send information in Excel so that disbursements to enhance accuracy and organization.
 - In coordination with Frank Melvin, contra accounts associated with the investment funds have been eliminated. Investment activity is booked to the statement.
 - With the 2011 audit, we will be able to account for the funds on a more proper basis since we can produce a Balance Sheet by Class. The auditor has been requested to make unrestricted fund balance allocations as part of his audit for 2011.
 - An inter-fund clearing account has been instituted. This, along with modified processes on recording inter-fund activity, should eliminate one-sided class entries.
 - Audit adjustments are booked in a timely manner and are reviewed for correctness.

<u>Summary of Immaterial Exceptions Noted and Resolutions</u>

- 1. All Bank statements were received and reviewed. The following exceptions were noted:
 - **a.** 1025 · Patriot Bank Dues Acct, Note: 06/30 Reconciled balance should be \$63,543.61, was 63,554.61.
 - b. 1020 · First United -- Perpetual Ck, Note: 06/30 Bank balance should be \$2,854.13.
- 2. Treasurer did not retain processed check copies for transactions over \$1,000 as required in Treasurer's approved procedures.
 - a. Resolution: The front and obverse of all **cleared check** disbursements in excess of \$1,000 will be retained. All disbursements in excess of \$1,000 need documentation of approval by the TXSSAR President.
- 3. In the review of Patriot Account (Patriot Fund, GL Code 1027) Deposits & Disbursements through 06/30/2012), the following items were noted:
 - a. 03/30/2012 -- Check # 1005 -- Copy of check and letter to Alexandra Bette is missing.
 - b. 03/31/2012 -- Check # 1006 -- Mileage amount paid exceeded expense allowance by \$.03 per mile or \$12.00 total overpayment.
 - c. 04/14/2012 -- Check # 1012 to Fidelity Investments "lost in mail." No STOP PAYMENT transaction was initiated. Check was replaced with Check # 1017.
 - d. 04/21/2012 -- Check # 1016 to San Antonio Chapter -- No back-up receipts (hotel, meals, etc.) attached to disbursement paperwork.
 - e. 04/30/2012 -- TXSSAR Annual Meeting Receipts -- No back-up receipts were submitted with the \$1130.00 remitted from the silent auction.
 - f. 05/06/2012 -- \$10,000.00 Check to Fidelity Investments -- No attached copy of cleared check.
 - g. 05/17/2012 -- Check # 1018 -- Copy of check and letter to Michael T. Block is missing.
- 4. In the review of Chase Bank Account (Registrar Account, GL Code 1036), Deposits & Disbursements through 06/30/2012), the following items were noted:
 - a. Deposit dated 04/28/2012 in the amount of \$1,861.00 per schedule doesn't agree to actual deposit of \$1,978.00
 - b. Two deposits dated 02/13/2012 in aggregate do not agree to the scheduled amounts and are different by \$50.00.
- 5. In the review of Patriot Bank Account (Operations Account, GL Code 1036), Deposits & Disbursements through 06/30/2012), the following items were noted:
 - a. Check #611 payable to Center for Advancing American Heritage in the amount of \$1,719 is not available. The front of check was with the Bank Statement but the back of check needed to be reviewed.
 - b. The documentation for check #639 in the amount of \$500 payable to NSSAR could not be located in the operations disbursement file. It did clear the bank in May 2012.
 - i. Resolution: The documentation was in the registrar support file.
- 6. In the review of Patriot Bank Account (Dues Account, GL Code 1025), Deposits & Disbursements through 06/30/2012), the following items were noted:
 - a. March 27, 2012 Deposit for \$52.00 needs description changed to reflect payment by member.

- 7. Profit and Loss Statement by Class:
 - a. Account Numbers 5031 and 66900 included entries that had not been classified.
 - b. Dues paid from the Perpetual Membership Fund for National, State, and Chapter were not entered as Perpetual Membership Fund expenses.
 - c. State Dues received from the Perpetual Membership Fund were not entered as Operations income.

<u>Summary of Immaterial Exceptions Noted and Resolutions</u>

Review procedures, exceptions and resolutions

Investment accounts - Brinker Capital and Vanguard

The review included the following for the period January 1 through June 30, 2012:

- 1. Reviewed the Brinker Capital and Vanguard statements for the six months ending June 30, 2012 for all five-investment accounts.
- Compared the Fee Expense, and Income items (Dividends, Interest, and Realized Capital Gains/Losses) from the monthly Brinker Capital and Vanguard statements to the QuickBooks investment accounts.
- 3. Gains/Losses) from the monthly Brinker Capital and Vanguard statements to the QuickBooks investment accounts.
- 4. Verified the beginning and ending balances of the Brinker Capital and Vanguard monthly statements to the Quick Books investment accounts.

Verified the monthly Unrealized Gains/Losses posted to the Quick Books investment accounts.

Observations:

- 1. All investment accounts are listed at fair market value on the Balance Sheet.
- 2. No investments have been pledged as debt collateral.
- 3. Posting errors for fees paid (Brinker Patriot & Perpetual June), dividends received (Brinker Perpetual May, Vanguard Perpetual February & March), realized gains and losses (Brinker Perpetual March), and ending balances (Vanguard Patriot January) were provided to the State Treasurer for correction.
- 4. Posting errors resulted in changes to unrealized gains and losses for Brinker Patriot (June), Vanguard Patriot (January), Brinker Perpetual (March, May & June), Vanguard Perpetual (February & March), and Vanguard Ritchie (March) were provided to the State Treasurer for correction.

Recommendation:

The State Treasurer correct the posting errors noted under Observations above, so the TXSSAR Balance Sheet agrees with the Investment Account Statement balances. A spreadsheet was provided with the corrections

Chancellor's Report and Report of the Bylaws Committee

September 25, 2012

Since my last report there have been several issues pertaining to the Texas Society. These are summarized below.

Pending Litigation: None

Potential Litigation: None

Contract Review: I have reviewed the contract for the 2013 Annual Meeting and approved it for execution.

Constitution and Bylaws: Following the 2012 Annual meeting, revised versions of the TXSSAR Constitution and Bylaws were posted to TXSSAR website at http://www.txssar.org/pdf/Constitution.pdf and http://www.txssar.org/pdf/Bylaws.pdf, respectively. There is one new issues pertaining to the TXSSAR Constitution and Bylaws for consideration by the Bylaws committee for possible presentation to the 2013 Annual Meeting. This is:

Bylaw Article XXVIII, Section 13 as amended with changes in red:

Section 13. The "Patriots Fund" shall consist of Principal Funds acquired according to Section 2 above, and also include those certain "Available Funds" acquired as a portion of the earnings (interest, dividends, and capital gains) on the investment of said Principal Funds. The definition of "Available Funds" is described as those certain funds derived solely from earnings (the aggregate of realized capital gains reduced by realized capital losses, but not below zero, plus interest and dividends earned) on the investment of the Principal Funds and Patriot Fund Expenses donations for the designated period of time as from January 1st through December 31st of the year prior to the preceding year, e.g., realized capital gains earned-reduced by realized capital losses, but not below zero, interest earned, and dividends earned, and Patriot Fund Expense donations from January 1, 2009 2011, through December 31, 2009 2011, considered "Available Funds" at the Annual Meeting in March 2011 2013. In addition, "Available Funds" shall include Patriot Fund Expense donations received during the current and prior years. Such Available Funds may be obligated only at the Annual Meeting and should be awarded prior to December 31 of the same Meeting year. Any Available Funds not awarded prior to December 31 of the same current Annual Meeting year shall accumulate as aAvailable Funds from year to succeeding year. However, projects duly and properly approved by the Texas Society delegates at the Annual

Meeting, pursuant to Section 15 below, shall represent appropriation of Available Funds and, remain open for expenditure until the approved project is completed, with the exception that scholarship awards shall be deemed an apportionment of "Available Funds" for a period of five years only.

Other Matters:

There is a circulating resolution concerning the honors to be afforded to Spain and the Spanish Society of the Sons of the American Revolution.

An issue has arisen concerning the TXSSAR Archives at the University of North Texas. Currently, the materials in the archives have been donated to "the Friends of the UNT Library." The UNT Library is requesting that the materials be donated to the UNT Library. This change would mean that the archives would become property of the State of Texas and would generally be accessible to the general public under the Texas Open Records Act. It would also mean that materials in the archives could be disposed of by the library in accordance with the library's deaccession policy.

A second proposal is to adopt a TXSSAR "Handbook." This would be akin to the SAR Handbook, but would contain material that does not belong in either the TXSSAR Constitution or Bylaws. Items that might be in such a handbook could include Sarbaines-Oxley compliance, material that is appropriate for donation to the TXSSAR archives, and TXSSAR medal precedence.

President Clark and I met with Dr. Martin Halbert, Dean of the UNT Libraries, Morgan Davis, Head of Archives and Rare Books, Jennifer Sheehan, Curator of Rare Books and Sue Parks, Asst Dean for Special Libraries in August to discuss the TXSSAR Archives (hereinafter "Archives"). It should be stressed here that UNT very much wants this Archives Collection. During that conversation two primary points were discussed:

One, the UNT Libraries can only assist with the digitization of the Archives if the UNT Libraries owns the Archives. This is a change and would involve TXSSAR needing to ask the Friends of the UNT Libraries to return the Archives back to TXSSAR and then TXSSAR gifting the Archives to UNT Libraries. I have forwarded copies of the existing Friends/TXSSAR Gift Agreement and the UNT Libraries Gift Agreement to Chancellor Voegtle and President Clark for their review and approval of a suitable agreement with the UNT Libraries.

Two, assuming a suitable agreement has been reached UNT can move forward with processing the Archives, organizing them, creating suitable finding aids and then digitizing them. Timing is such they could begin within the next year if funds are available to do so, and TXSSAR would need to provide the funds. Attached please find a copy of a memorandum from the Head of Archives and Rare Books at UNT containing the costs of various projects related to the Archives. The first option appears to be all inclusive and essentially results in 1/2 FTE at UNT. The other options are pieces of the digitization project.

All of the above to say I wanted recent Historians who have fought for, handled, donated to, cared about and begged donations for the Archives to be aware of where we are. At the BOM I will be raising the subject of funds needed for UNT. I'm open to any and all possibilities as long as we can move forward soon. The funds in the current budget should be used, more funds requested, donations from the chapters should be solicited as well as private donations and grants applied for.

Thank you for all of your collective hard work. We have been waiting for this moment and it's time to push forward.

Vice President Americanism, Contests, Medals, & Awards Russell Dart

There are seven (6) items on which to report.

- 1. **Manual for Contests, Medals, and Awards**. The TXSSAR Society Manual dated in March 2000 is outdated and many topics are no longer used. A new manual will be prepared and presented to the CMA Committee for review and approval.
- 2. **Youth Contest Programs Updates on the TXSSAR web site**. Information on Youth Contests posted to the TXSSAR web-site needs to be updated for current year contests..
- 3. Increase participation in Public Service Awards and Non-SAR/DAR Awards.
 - a. On May 29, 2009, President Tom Lawrence asked TXSSAR Officers, Youth Contest Chairmen, and District Vice Presidents to work together to increase participation and recognize and present medals, certificates, and awards to citizens other than SAR and DAR members in 2009. We need to continue this important outreach effort in 2012.
 - b. Chairman Public Service Awards Committee, Art Munford worked with District VP's and various Chapters to focus on the TXSSAR Society's goal. The effort led to the presentation of 77 Public Service Medals to Fire, Law, EMS, and Heroism Award recipients, versus 118 in 2010. Six Chapters presented all four of the Public Service Medals in 2011. We need to work hard in 2012 to get back to where we were in 2010 and to make an improvement on that.

4. Increase participation in TXSSAR Youth Contests.

The TXSSAR Youth Contest Chairmen, using Youth Contest Brochures and working with District VP's, are encouraged to motivate TXSSAR Chapters to actively reach out to schools and teachers to attract more participation in TXSSAR Youth Contests.

5. Annual Chapter Report Form and Instructions Revised in 2012.

The Annual Chapter Report Form and Instructions were revised in 2011 to be compatible with NSSAR PG and Americanism Reports. For 2012 there will be one annual report with the information needed by TXSSAR for its awards being a supplement to the National Report. There will be training provided at the October 2012 Board of Managers meeting in Temple, Texas.

Youth Contest Budget and Funding for 2012 Youth Program Awards.

During the Convention, at the recommendation of the Projects Funding Committee, the BOM approved the Youth Budgets for 2012 at \$18,120.

6. Need Compatriots to fill key position in the ACMA Committee.

Need compatriots to work with Chapter Annual Reports Sub-Committee. There is an opening in the Reports Sub-Committee for anyone wishing to learn how the Chapter Annual Reports are handled and consolidated for preparation of Society Reports to NSSAR.
