

COLORS: To be determined.

NATERIAL: Hood is to be clear, kiln-dried Hedwood with 1/4" AC plywood splines. All give must be waterproof. Paint

is to be chromatic sign paint or equal. All stains are

to be cil base.


CONSTRUCTION: All glue joints are to be kerfed 1/2" deep with depth with sharp edges. Blasted depth to be 3/8" to 1/2". not acceptable. Blast in one direction for a uniform plywood splines inserted to strengthen joint. Dowels are All areas to receive two coats of paint or stain.










Short Form Lease Agreement
