

PUBLIC HEARINGS ARE SCHEDULED FOR PROPOSED STATE HEALTH PLAN

The 1985 Proposed Texas State Health Plan of the Statewide Health Coordinating Council (SHCC) will undergo public scrutiny during the month of August in 14 regions of the state and at one statewide hearing as part of the federally mandated public hearing process.

## TEXAS HEALTH DATA COOPERATIVE MEETS TO REVIEW HOSPITAL DATA QUESTIONNAIRE

Members of the Texas Health Data Cooperative, somewhat inactive since the phase-out of the state's 12 Health Systems Agencies, met July 31, 1984 at the Texas Department of Health in Austin to consider the Department's 1984 Hospital Data Questionnaire. According to the Texas Department of Health Data Collection Rules, data collection instruments such as the questionnaire are to be reviewed by the Cooperative.

About 20 entity representatives attended the meeting and comments were received in the areas of diabetes, physical therapy and podiatry.

## SHCC ESTABLISHES COMMITTEE ON NMR

The Statewide Health Coordinating Council (SHCC) has established a new committee to develop guidelines for the introduction of nuclear magnetic resonance (NMR) units in Texas. The NMR Advisory Committe, the result of a recommendation by the Resource Development and Implementation Committee (RDIC) of the SHCC, is a 12-member group chaired by Irwin R. Salmanson of Austin, SHCC parlimentarian and a health consumer of that group. Other representation includes two radiologists, one physicist, one radiologic technician, one economist, one representative each from the Texas Health Facilities Commission, the Texas Medical Association and the Texas Hospital Association, and three other SHCC members.

In a letter to Louis E. Gibson, M.D., SHCC Chair, Jose L. Gonzales, Chair of the RDIC, said "due to the uncertain need, significant costs and probable obsolescence of . . . (NMR) units, the . . . Committee requests that a special advisory committee on NMR be established under the SHCC." Gonzales continued, "the special committee's charge (will) be to develop

Gonzales continued, "the special committee's charge (will) be to develop guidelines for the introduction and use of NMR (units) into Texas, addressing availability, accessibility, quality, continuity and cost of care, as well as data collection requirements."

The NMR unit, considered by many to be the most significant diagnostic invention since x-ray, produces pictures of the body's interior and chemical analyses of tissues which, authorities say, are capable of revealing the extent of a cancer spread, defects within the heart's chamber, nerve degeneration from multiple sclerosis, areas of the brain damaged by stroke, painful bulges of the backbone's disks and a host of other problems.
