SENATOR TURNER, REPRESENTATIVE STILES HONORED AT AGENCY'S BANQUET

State Senator Jim Turner of Crockett and State Representative Mark Stiles of Beaumont were recently honored for their support and assistance to the Texas Youth Commission during the agency's annual awards banguet July 23 in Kerrville.

Pete Harrell of Austin, a member of the TYC Board, presented the award to Senator Turner.

"The Youth Commission is indeed fortunate that such a key member of the legislature and leader in the area of criminal justice also happens to reside in a community in which one of our facilities is located," said Harrell in presenting his award. "Senator Turner is acutely aware of the tremendous problems facing the adult criminal justice system and has become very knowledgeable of the unique issues facing the Youth Commission," he continued. "He has taken the time to visit with Crockett State School employees to understand the consequence of legislative proposals such as those contained in the Comptroller's study last summer," said Harrell.

Comer J. Cottrell of Dallas, TYC Board Vice Chairman, made the announcement of the award to Representative Mark Stiles in Kerrville, July 23. Representative Stiles was unable to attend the awards banquet and received the award during the board meeting in Beaumont September 17.

"Elected to the Texas House of Representatives in 1982, Representative Stiles is recognized as a key leader in this legislative body," said Cottrell in announcing the award. "He was listed by *Texas Monthly* magazine in 1991 as an Honorable Mention recipient in their list of Best Legislators,

and received the 1991 Legislator of the Year award given by both the Texas Public Employees Association and the Texas Municipal League," continued Cottrell.

1993 Kerrville Workshop Scheduled

The 1993 administrator's workshop has been scheduled for Wednesday July 14, 15, and 16, 1993 at the Best Western Inn of the Hills in Kerrville.

Specific information on next year's workshop will be forthcoming.

Board Adopts 6-Month Minimum Length of Stay

The Youth Commission's Board during its regular meeting in Beaumont on September 17, 1992, approved implementation of a proposed rule establishing a minimum six month length for all youth committed to TYC on or after October 1, 1992. In presenting this policy change to the Board, Jay Lindaren, Deputy Executive Director, reminded the Board that with increased funding to juvenile probation departments, the legislature expected commitments to TYC be reduced. Reduced commitments will enable TYC to retain all youth for at least six months in a residential program prior to being released on parole.

The Board also discussed the increasing number of minority youth committed to TYC. In Fiscal Year (FY) 1989, 26% of commitments were Anglo (517 youth), 37% Hispanic (744 youth), and 36% Black (723 youth). For the Fiscal Year ending August 31, 1992, the number of Black youth had risen to 44% (929 youth) of all commitments. The number of Hispanic youth (797) had remained relatively the same, at 37% of commitments and Anglo commitments had declined to 18% of commitments (380 youth). The Board asked staff to examine this alarming trend and provide a report on the disproportional number of minority youth committed to

the Youth Commission. The Board also instructed staff to include an analysis of the number of minority youth involved at all levels of the juvenile justice system and provide any information on national studies on this issue.

Cisneros Speaks At Awards Banquet

The Honorable Henry G. Cisneros, Chairman of Cisneros Asset Management Company and former mayor of San Antonio, was the keynote speaker at the agency's annual employee awards banquet in Kerrville, July 23.

The Texas Youth Commission has had the honor of hearing Cisneros at the groundbreaking of the Evins Center in 1986 and the dedication ceremonies in 1990. As a former mayor of San Antonio, he became the first Hispanic mayor of a major U.S. city and helped develop San Antonio into one of the nation's most progressive cities. He gained national attention throughout his tenure as mayor and was interviewed as a potential vice- presidential candidate in 1984.

Cisneros, a professor as well a public figure, has a doctorate in public administration and taught urban economics at Trinity University in San Antonio. He was recently elected deputy chairman of the Federal Reserves Bank of Dallas and is chairman of the National Civic League and co-chair of the National Hispanic Leadership Agenda. He is host of Texans, a television show produced quarterly in Texas and Adelante, a national Spanish-language radio commentary series.

Senator Turner - -

Senator Turner currently represents Senate District 5, which encompasses 18 central and east Texas counties. His newly redrawn district will now also include Lee County and the Giddings State School. Senator Turner currently serves on the Senate Finance, Economic **Development and** Intergovernmental Relations Committees. He also serves on the Interim Committee on Criminal Justice and was appointed by Lt. Governor Bullock as a member of the **Punishment Standards** Commission. The Senator received the distinction of being named by Texas Monthly magazine as an up and coming first term member of the Senate.

As a member of the Finance Committee, Senator Turner will play an integral role in the deliberations regarding the Youth Commission's budget and legislative action on providing hazardous duty pay for TYC line staff. He will continue to be at the forefront of discussions dealing with the entire criminal justice system and will undoubtedly play a key role in any discussions involving the Youth Commission and issues facing the juvenile justice system.

"Prior to serving in the Senate, Senator Turner served in the Texas House from 1981 to 1984 during which time he was named an "Outstanding Legislator" by Texas Business magazine. From 1984 - 85 he served as Special Counsel for Legislative Affairs and as Executive Assistant to Governor White. Senator Turner received both his bachelor and law (Continued from Page 1)

"In addition to his involvement in consumer affairs as a member of the House Committee on Insurance. Representative Stiles has been a leader in issues dealing with the criminal justice system," said Cottrell. "In 1989, Stiles was appointed to the conference committee that resolved the differences in the legislation that created the **Texas Department of Criminal** Justice," said Cottrell. "Last session, he and Representative Hightower were the key House members involved in the deliberations dealing with the settlement of the county jail overcrowding lawsuit." Stiles currently serves as a member of both the Texas Punishment Standards Commission and the Legislative Criminal Justice Oversight Board," said Cottrell.

During the 72nd Legislature, **Representative Stiles was** involved in numerous issues that directly impacted the Youth Commission. He sponsored legislation to authorize the payment of hazardous duty pay for TYC line staff. While the bill was not adopted due to a technical point of order. It is hoped that raising this issue before the legislature last session will improve the chances of passage next session. He was successful, however, in enhancing the sanction for a youth convicted of assaulting a TYC employee. He offered a floor amendment that assured that Youth Commission construction projects were included in the bond package that was eventually approved by Texas voters last November. In addition to his efforts in sponsoring legislation of importance to the Youth Commission, Representative Stiles led the House floor debate in favor of not including the Youth Commission under the auspices of the Commission on Health and Human Services. The issue of consolidation will be back before the legislature when it convenes in January of 1993," continued Cottrell.

A native of Houston, Representative Stiles resides in Jefferson County. He attended Sam Houston State and Lamar Universities. He and his wife, Sandra Kay, have three children. Effective with the 1992 elections his legislative district will include the western and southern portions of Jefferson County.

TYC Hosts Groundbreaking

The Texas Youth Commission hosted groundbreaking ceremonies for the construction of its new state school on September 17 in Jefferson County.

Texas Comptroller John Sharp provided the keynote remarks during the event. Also speaking during the groundbreaking were Senator Carl Parker, Representative Mark Stiles and Jefferson County Judge Richard P. LeBlanc, Jr.

Texas voters approved the issuance of general obligations bonds authorized by the legislature last session for construction of this new secure facility which has a residential capacity of 150. Generally, youth who have been adjudicated for serious felony offenses are placed in TYC's secure facilities. This state school will house youth from the east and southeast areas of Texas.

The 50 acre campus style site will be located near other criminal justice agencies under construction in the area. This facility will consist of six dormitories housing 25 youth each and separate buildings for security placements and medical needs, academic instruction, vocational training, recreational activities, maintenance functions and administrative offices. Construction is scheduled to begin in early 1993 and is expected to last approximately 24 months.

Bonilla has held his current position since 1986 when he was named Regional Director of the West Region, encompassing the various parole offices and Schaeffer Halfway House.

In accepting his award, Bonilla applauded his various mentors in the agency and peers in the West Region.

TYC Benefits From Two Grant Awards

"The Texas Youth Commission has successfully applied for funding through the Criminal Justice Division of the Governor's Office to support two projects," reported Susan J. Saperstein, Federal Relations Coordinator in Central Office. The grant period is fiscal year 1993, with continuation funding available at decreasing levels for up to five years.

1. Drug Education and Prevention: This \$107,674 grant will provide culturally sensitive substance abuse and delinquency prevention activities to siblings and peers of youth currently committed to TYC from Austin and San Antonio. Two Chemical Dependency Prevention Counselors and two support staff will be hired to coordinate with community programs and incorporate drug and delinquency prevention activities and support groups into existing neighborhood services.

2. In-Service Training: Developed in collaboration with Sam Houston State University, this \$132,367 grant goes to the University to support in-service training for TYC community services staff through the creation of a Community Services Training Institute at Sam Houston State. The training will concentrate on issues critical to employee safety and job performance. Members of TYC's Training and Community Services Divisions are developing the curriculum with the University to ensure the program addresses staff interests and needs. The grant covers the provision of all training services, as well as staff meals and lodging costs.

Sixty-seven TYC volunteers and groups were nominated in all categories. Many of them were present for the awards ceremony on Saturday, September 12.

The following awards were given to Outstanding Volunteers in six categories:

Named Outstanding Individual Volunteers for 1992 were John Bustillos, parole volunteer in Dallas and Judy Ehrke, one-to-one volunteer and advisory council member in Brownwood.

Sarah Tellez, Brownwood State School, received the **Religious Individual Volunteer** Award for 1992. Named **Outstanding Student** Volunteers for 1992 were Joe Ramon, Schaeffer House student, and all the Ayres House students. Named **Outstanding Staff Employee** was Joe Rickey, West Texas State School. H.E.B. Food Store in Corsicana was named Outstanding Civic Group or Business for 1992. **Rick White, Store Director** accepted the award. Northwest Baptist Church of Houston was named **Outstanding Religious** Volunteer Group for 1992.

Award presentations were made by Jay Lindgren, Deputy Executive Director; Neil Nichols, Asst. Executive Director for Professional Services; Dwight Harris, Director of Institutions; and Adrian Moore, Central Region Director.

Dr. Leonard E. Lawrence, TYC Board Member from San Antonio, was guest speaker at the event. Edna Tamayo, TYC Board Member from Harlingen, was master of ceremonies.

Next year's volunteer conference will be held in Houston, and the 1992 conference will be held in the Valley.

Giddings Receives Safety Award

The Giddings State School was named the recipient of TYC's Institutional Safety Award during the agency's annual workshop in Kerrville in July.

The award was presented to Superintendent Calvin Crenshaw in recognition of the facility's injury rate of 7.0% (number of injuries per 100 employees) compared to their previous rate of 17.1% for FY 1991-92.

Crenshaw accepted the award on behalf of Giddings' employees who have "worked hard and conscientiously in making the facility a safer place to work."

Brookhaven Boys Ranch Named Outstanding Contract Program

The Brookhaven Boy's Ranch in Waco was named Outstanding Contract Program for 1992 during the agency's annual awards banguet July 23 in Kerrville.

Four other Texas Youth Commission contract programs were nominated to compete for the Statewide Award including the Rio Grande Marine Institute in South Region; Texas Key Intensive Supervision, East Region; East Texas Open Door, Inc., North Region; and Aliviane, Inc. No-AD, West Region.

"Brookhaven was started over five years ago by Bob Drake as a TYC approved and sole source provider to TYC," said Pete Harrell, TYC Board Member from Austin in presenting the award. "Bob, who was a former TYC administrator, developed his program into a DHS licensed residential treatment center with a number of referral providers, but the program never abandoned TYC," he continued. "In fact, the program currently guarantees more than one-third of its bed space solely to our youth in need of Level V treatment services," said Harrell.

Brookhaven has evolved into an outstanding example of consistency and expertise in working with highly emotionally disturbed students. They have worked hard to develop a number of creative approaches to working with this population. One of the most effective for TYC students is Brookhaven's independent living program in Waco. This program combines traditional independent living preparation with the adult setting of the **Texas State Technical** College campus. The

"David is a very busy staff member--he has served on more than two dozen agencywide committees and task forces ranging from policy development and review, staff development, and management of aggressive behavior to providing technical assistance to all TYC institutions," said Harrell.

David has participated in countless local projects in an overall effort to provide quality care to the youth committed to the agency. He demands quality work from the 23 staff he supervises and provides the necessary front-line leadership to make things happen.

"Due to his efforts to stay abreast of all agency programs and practices, David is frequently called upon by staff at all levels for assistance," continued Harrell. This program was shared with all facilities and has evolved throughout TYC into what we know today as Outside Security," said Harrell.

TQM Initiatives

Cathy Negrel, Quality Coordinator for the Texas Youth Commission, reported to the TYC Board during its July meeting in Kerrville, on the agency-wide implementation of Total Quality Management (TQM).

TQM was identified as a different way of conducting business whereby TYC's customers will be identified internally and externally. The agency's three common goals are customer and employee satisfaction, and business results.

Nearel enlightened the board on Quantum Solutions, the company selected to help provide training for the agency's implementation of TQM. The contract with Quantum Solutions began in June, 1992 and concludes in May, 1993. There are three phases in the Action Plan for Year 1. Management will be trained with new skills and educated on the cultural shift that needs to take place to support the new processes. Phase I, which is now complete, entailed three twoday workshops which involved 160 TYC managers, supervisors and some staff positions. This workshop was conducted to create buy-in, an overall awareness and acceptance of TQM concepts. One hundred Phase I participants will volunteer to continue with Phase II of the training. Participants in Phase Il will attend seven monthly training sessions to learn teamwork and facilitation skills, process improvement and process redesign

techniques to apply in their daily work and to share what they learn with other TYC employees. Phase III will involve 17 of TYC senior managers to be trained to serve as the Agency's Quality Council. The Quality Council will meet two days a month for six months, and then onehalf day a month for three months. During this process, the Quality Council will review TYC's Performance Appraisal System, recognition and reward system and other items to better support TYC's Quality Improvement Process. A group of managers and supervisors will share their skills with other TYC staff.

The ultimate goals of TQM are to improve services to the youth, improve services internally, customer and employee satisfaction, organizational effectiveness and to develop a culture open to creativity and innovation, and to improve TYC's success overall.

Linda Reyes has been appointed Chief of Mental Health Services. Dr. Reyes previously served as psychologist at the Giddings State School where she began her career with TYC in 1988.
