March for equality

Organizers called it "Wheels of Justice," the biggest-ever nonviolent direct action in support of disability rights.

Five hundred disability advocates, many of them persons with severe disabilities, marched to the nation's Capitol calling for congressional and public support for the Americans with Disabilities Act.

Called landmark civil rights legislation, the ADA will provide equal access for people with disabilities to public housing,

transportation and employment opportunities, among other things.

Resistance to the bill comes from small business lobbies concerned about renovation costs for accommodating people with disabilities and from certain sectors of the transportation industry. Organized by American Disabled for Accessible Public Transit (ADAPT) and supported by the National Rehabilitation Association, the march, along with speeches on the

steps of the Capitol, drew immediate public media attention and rallied support from sympathetic congressman.

Simultaneous marches and press conferences at state capitols around the nation, including Austin, solidified ADA support.

USA Today ran the following quotes from important congressional supporters of the ADA:

- ♦ "What we did for civil rights in the '60s, we forgot to do for people with disabilities." – Rep. Pat Schroeder, D-Colorado
- ♦ "Yes, there are costs associated with this bill, but these costs are mangageable." – Rep. Norman Mineta, D-California
- ♦ "It will reach the floor, we will have a conference with the Senate, and it will become law." – House Speaker Thomas Foley, D-Washington

At this writing, the House Energy and Commerce Committee and the House Public Works and Transportation Committee have finalized their versions of the proposed ADA.

The Judiciary
Committee has yet
scheduled sessions to
"mark-up" the measure
early this month.

Corpus Christi leadership conference builds committees' strength

Betty Turner, Mayor of Corpus Christi, gave a warm welcome and some inspiring advice to 49 representatives of mayor's committees attending the Governor's Committee annual leadership conference this year in Corpus Christi. Mayor Turners' involvement with the Corpus Christi Mayor's Committee began years before she was elected mayor and continues today with the high level of enthusiasm she encourages among mayor's committee volunteers. Mayor Turner offered the following tips:

- ♦ Be enthusiastic.
- Have the support of your chief elected official.
- Propose that each community consider creating a mayor's committee. Form an alliance with other cities and towns in your area.
- Give everyone an opportunity for employment.
- Target a certain percentage of your employee base to be considered for persons with disabilities.
- ♦ Compile, publish and distribute a directory of businesses that are accessible.
- ♦ Create awareness.


"Go back to your home communities with new enthusiasm and help other small communities build their committees.

Outreach: regional outreach to establish mayor's committees in surrounding communities Mayor Betty Turner of Corpus Christi thanked Dik Johnson the chairperson of the Corpus Christi Mayor's Committee for his drive, enthusiasm and ability to get the job done.

One award winner, Janice Miles, KENS - TV 5, explained her feelings so well. "When I was growing up as a kid out in West Texas in the 50s, I couldn't help but notice there were certain people who were left out of the American dream. That exclusion was very much apparent in the lives of persons with disabilities. I felt like I wanted to do something to change things. When I graduated from the University of Texas at Austin I went to work as a Social Worker. Yet even after seven years, it didn't seem like I had made much of a dent in these problems.

"Working in television has helped me increase the impact of a message I've tried to carry all my life. Awareness is the key which will unlock the doors which have been closed to people with disabilities. As I profile the lives of those people who were forgotten

in the 50s, I try to do so by concentrating on their strengths.

"It is my fervent hope that my stories may raise the consciousness of people to the concrete barriers in their communities, and help dispel the negative connotations about people with disabilities in our language and in our minds."
