## COUNCIL HOLDS INITIAL MEETING

The Texas Commission for the Blind hosted the initial meeting of the State Independent Living Council, January 25-26 in Austin. The fifteen member advisory group will provide guidance for the development and expansion of independent living programs and concepts on a statewide basis and will advise both the Texas Rehabilitation Commission and the Texas Commission for the Blind on issues specifically related to the independent living services.

A primary challenge for the new Council will be the development of a five year state plan addressing long-term goals and recommendations for expanding independent living programs and services in Texas. During the January meeting, Council members had an opportunity to hear from Commission Executive Director Pat Westbrook and TRC Commissioner Max Arrell. The Council also elected Dr. Thomas D. Carter of El Paso as Chairman.

"We are wholeheartedly committed to the mission of this new Council, and we look forward to working together towards the enhancement of independent living programs and services for all Texans who are disabled," said Westbrook. He stressed the importance of identifying the special independent living needs of populations such as the state's elderly blind so as to ensure that the needs of all disabled citizens in this area are fully identified and addressed.

### CONGRESS WILL LOOK AT AIRLINE POLICIES

A bill to amend the Federal Aviation Act of 1958 to prohibit discrimination against blind individuals in establishing restrictions on seating in aircraft has been filed in Congress by U.S. Representative James A. Traficant, Jr. of Ohio.

Titled as the "Air Travel Rights for Blind Individuals Act," H.R. 3883 would prohibit an air carrier from using a passenger's visual acuity or use of a white cane or dog guide as the basis for establishing any restriction on seating in aircraft.

The Bill has been referred to the Committee on Public Works and Transportation.

# A Word from the Director

It seems like only last week we were talking with many of you about the 1987 session of the Texas Legislature and the legislative budget process. With the beginning of 1988, we are once again beginning the process of developing our legislative budget request, this time for state fiscal year 1990 and 1991. Even though it will be nearly ten months before the legislature returns to Austin we have just received the initial instructions from the legislative and governor's budget offices. First submission of the agency's budget request will be due by early July. Again, your input is important to us in developing the funding request priorities. In my last correspondence to you I mentioned the consumer forums which are being held in various parts of the state during this year. We look forward to receiving your input at these forums so that it can be considered during the development of our request.

Based on current economic information we receive from various sources we expect the 1990-91 budget to be one in which funds may be as limited as during the last biennium. Not only will funding be an issue but I also expect a significant amount of activity surrounding the reports and recommendations of the numerous committees studying various segments of state government and its structure. Just like your vote is important, your input to this agency is important in determining the direction we will proceed in providing future services to Texans who

are blind and visually impaired.

# DESCRIPTIVE TV HITS THE AIRWAVES

A 1976 study conducted by the American Foundation for the Blind revealed that blind people watched up to six hours of television every day. Recognizing the powerful role the medium plays in the lives of most Americans, it is safe to assume that television viewing has not decreased for persons who are blind during the last twelve years.

Descriptive Video Service (DVS) is a new concept that is based on audio descriptions of action, settings, costumes and other details which are transmitted over a channel available on the stereo television sets. The descriptions can be heard during pauses in the dialogue.

The first national test of this new service began in January. Nine public television stations, including KERA in Dallas, are now testing DVS which is airing on PBS's "American Playhouse" series. The test will run through July.

"The eye complications associated with AIDS are so new, many doctors don't consider the possibility of AIDS in their diagnosis. But an eye disorder may be the first sign that AIDS has begun in a person infected with the human immunodeficiency virus. Diagnosis is further complicated by the fact that the eye disease symptoms may mimic those caused by other diseases."

The Commission has awarded contracts to the Texas School for the Blind, Goodwill Industries in San Antonio, and the Lighthouse of Houston for supported employment services. The purpose of each contract is to expand employment options for severely disabled clients for whom competitive employment has not been a viable option. Under the contract agreements, job coaches will be available at job sites to help clients participating in this program to learn how to adequately perform their jobs. Job coaches will also provide on-going support to ensure that the clients have every opportunity to keep their jobs.

- "From School to Work: A Weekend Seminar for High School Visually Impaired Students and Their Parents" will be held May 27-29 at the Criss Cole Rehabilitation Center in Austin. Sponsored by the Texas Education Agency, Education Service Center - Region XIII and the Commission, the workshop gives participants an opportunity to explore various issues that impact the lives of young persons who are blind or visually impaired as they make the transition from high school to higher education or employment. - The Texas Energy Extension Service (EES), a program of the Governor's Energy Management Center, offers information about conserving energy in homes, offices and small businesses. - Community Integration: Here to Stay" will be held June 8-10 in Austin. The conference will explore various issues that impact on total integration into communities by persons who are disabled. - The Lighthouse of Houston has broken ground on a \$1.8 million Community Services Center. The new building (slated for completion in June) will house the therapeutic recreation department, volunteer services, low vision clinic, social services and counseling, library and day activity program for older adults and a new day care for children. The 28,000 square foot facility will feature an indoor swimming pool, an exercise room, auditorium and a rehabilitation training area.

Commenting on her impressions from touring the San Antonio Association for the Blind recently, Heloise noted "The people there are selfsufficient and very capable." In an interview with the San Antonio Light, Heloise noted that her interest in the lives of blind persons stems from her childhood when she underwent several operations to correct her crossed

eyes.

"I think many people just don't know how to react to a blind person. The best thing to do is just ask if they would like any help," she points out.
