TEXAS

Weekly broiler placements totaled almost 4.30 million chicks, up 7 percent from last year but down 3 percent from the previous week. The placements were off 5 percent from a month earlier.

Producers hatched 5.00 million chicks, 83 percent of the eggs set during the week of July 13. The weekly hatch was 5 percent above a year ago but 2 percent below last week.

The weekly eggs set reached 6.10 million, an increase of 5 percent from last year. The set was down 1 percent from a week

Texas producers shipped 670,000 broiler chicks to Alabama and Arkansas, while no inshipments were received.

NINETEEN STATES

In the nineteen leading broiler producing states, weekly placements totaled 87.22 million chicks, up 3 percent from a year ago but sown slightly from the previous week.

Producers set 109.01 million eggs, 5 percent above a year earlier. The set was down 2 percent from last week.
