Forfeited land opens opportunity for agents

Texas real estate agents could earn up to \$650,000 in commissions by selling \$13 million in forfeited Texas Veterans Land Board (VLB) tracts through the recently-extended Real Estate Agent Pilot Program.

The pilot program, which gives real estate professionals exclusive rights to market certain forfeited tracts, will continue until midnight, August 31. The tracts can be sold to eligible Texas veterans and the general public, with the general public paying a slightly

The board's current inventory includes more than 700 tracts located in 138 counties throughout the state. The tracts have an appraised value of more than \$13 million.

higher interest rate.

"More than \$2.2 million worth of land

has been sold by real estate professionals since the pilot program began," said Garry Mauro, chairman of the VLB.

Mauro noted that the VLB will continue to give Texas veterans the first opportunity to bid on forfeited land tracts. All tracts included in the pilot project have previously been offered exclusively to Texas veterans.

The Texas Veterans Land Board will finance the entire amount of all winning bids. No down payment is required. Eligible Texas veterans will receive an interest rate of 8.75 percent while the

interest rate for all others bidding on the tracts will be 10.25 percent. All loans carry a 30-year term and there is no penalty for early payoff.

The buyer will be responsible for the current year's taxes only.

Under the terms of the sale, agents can receive up to 5 percent in commission on each sale. Anyone may make an offer on the tracts but all

offers must be made through real estate agents.

Agents and brokers can obtain official bid forms and a detailed description of each tract by calling

1-800-252-VETS or (512) 463-5350.

To sell a tract, a real estate agent must submit a bid to the board that equals or exceeds the minimum bid set for each tract.

The board will review any purchase offer on a "first-come, first served" basis and retains the right to refuse any offer. Offers will be reviewed immediately and accepted or rejected within days of review.

All offers must include a combined earnest money contract and completed bid form. If an offer to

the board is revoked by the buyer after acceptance, all earnest money will be forfeited to the agent.

Mauro stressed that the pilot project does not involve a listing arrangement and there are no arrangements between the board and any agent.

VLB holds land loan interest rate at 8.75%

Despite rising interest rates throughout the nation, the Texas Veterans Land Board (VLB) will hold the interest rate for land loans to Texas veterans at 8.75 percent, Land Commissioner Garry Mauro announced recently.

"We are very pleased to be able to continue offering Texas veterans this outstanding interest rate," said Mauro, who serves as chairman of the board. "Because we had such a successful bond sale, Texas veterans can continue receiving land loans at 8.75 percent."

To continue funding the popular Texas Veterans Land Program, the VLB sold \$45 million in bonds in April to J.P. Morgan Securities, Inc.

"While other interest rates continue to rise, we have been able to keep our loan interest rate stable and well below anything else on the market today," Mauro said.

The highly successful loan program lends eligible Texas veterans up to \$20,000 for the purchase of five or more acres of land.

Since the first loan was made in 1949, Texas veterans have used the program to buy 4.5 million acres of land— an area roughly the size of New Jersey.

"The land program offers Texas

veterans the best opportunity around for buying raw land," Mauro said. "Our 8.75 percent interest rate is well below conventional financing and we only require a five percent down payment."

The VLB has loaned more than \$1.2 billion through the land program to nearly 100,000 Texas veterans over the last 40 years.

While funding for the program comes from the sale of tax-exempt bonds, Mauro pointed out that the program is completely self-sustaining since fees from the veterans are used to administer the program.

In addition, Rice Food Markets,


Inc. have promoted the VLB programs by distributing flyers through 25 of their Houston-area stores.

"I want to thank Krogers, Fiesta and Rice Food Markets for helping Texas veterans learn more about



Texas Veterans given first chance to bid on forfeited tracts in August sale

The bidding deadline for 312 tracts of land recently forfeited by the Texas Veterans Land Board has been set for August 23 at 1 p.m. Information on the tracts will be available in late June.

Located throughout the state, all the tracts are being offered exclusively to Texas veterans who are eligible to participate in the Texas Veterans Land Program. The interest rate will be 8.75 percent for a 30-year loan.

At a February forfeited land sale VLB sales hit a six-year high when 119 forfeited tracts were sold for nearly \$2.5 million. The February sale continued an upward trend first seen in August, 1988, when the VLB sold 107 tracts totaling \$2.2 million.

In addition to the sealed bid sale on August 23, the VLB is also conducting a Type II sale which runs until August 31.

Type II sales consist of tracts that have previously been offered to Texas veterans and are now for sale to the general public through real estate agents. (See page 1.)

The Texas Veterans Land Board will finance the entire loan amount of all winning bids. There is no limit on the amount loaned. The buyer will be responsible for the current year's taxes

only. All back taxes will be paid by the VLB.

"I'd like to encourage Texas veterans who have been looking for quality land to take advantage of this sale," said Garry Mauro, who chairs the VLB. "Everybody has an equal shot at winning and the VLB will finance the entire loan amount."

with the minimum bid set by the board. Winning bidders will be notified by mail within one week of the sale. The VLB may reject any bids for any reason.

Bidders must submit a \$25 non-refundable bid fee for each bid and \$320 to cover closing costs with their bid form. Unsuccessful bidders will have all money refunded except the \$25 bid fee.

Periodic sales of forfeited tracts are consistent with the Texas Veterans Land Board's commitment to run the Texas Veterans Land Program in a cost-effective, businesslike manner at no cost to the Texas taxpayers. Prompt action on these infrequent delinquencies will continue to ensure that not a single dollar is wasted on this program.

"It's unfortunate when we have to conduct a forfeited land sale, but a fair and aggressive policy toward delinquencies is necessary so we can continue to offer such good terms to our Texas veterans," said David Gloier, Deputy Commissioner of the VLB.

The VLB currently conducts two types of forfeited land sales. One sale offers forfeited * tracts exclusively to Texas

veterans while a separate sale offers tracts to both Texas veterans and the general public through real estate professionals.

A bid form, the list of forfeited tracts included in the sale, bidding instructions and directions as to how to reach each tract for inspection will be available in late June from the Texas Veterans Land Board. Call 1-800-252-VETS
