Commissioner Arrell outlines focus for new millennium

fter clearing the Year 2000 milestone, TRC's automated resources were safe and secure and ready to move forward. TRC began the year with a strong message from the leadership. A new "Conversation with the Commissioner" videotape outlines Commissioner Arrell's key themes for all staff.

On this videotape "Conversation with the Commissioner" Commissioner Arrell shares his views on many issues affecting TRC and its services, including:

- Changes in our daily operations and their effect on our delivery of client and applicant services;
- Issues relating to the budget and employee compensation;
- Issues resulting from the "Sunset" review of the agency including statewide changes in monitoring, training, and regional conferences.

Commissioner Arrell discusses in this videotape certain operational changes and the importance of accountability for all staff. Changes in some TRC policies and a greater emphasis on monitoring are directed at ensuring greater accountability for decisions and performance. Indeed, accountability has been a key message in training sessions, conferences, and meetings throughout the agency.

Accountability and oversight are nothing new in TRC, but the agency is following through with recommendations made by the Sunset Commission during the last legislative session. The Sunset Commission report emphasizes monitoring and accountability in a significant number of their recommendations for TRC. These recommendations have been passed into the state law that governs TRC and its operations.


TRC's emphasis on accountability will serve the agency well for the upcoming periodic on-site monitoring that will be conducted by the TRC's federal partner, the Rehabilitation Services Administration (RSA). In the next few months, a team from RSA will conduct town meetings and visit TRC to ensure compliance with the federal requirements for the Vocational Rehabilitation Program. RSA is conducting these reviews on several state VR agencies, TRC being one of them. Based on these reviews, RSA provides technical assistance to improve the quality of VR services and establishes corrective action plans, if necessary.

Beginning in the next few months, RSA staff will initiate the periodic on-site monitoring review by arranging meetings with state VR agency personnel, State Rehabilitation Council members (the RCT, in Texas), Workforce Investment Act (WIA) partners, the Client Assistance Program (CAP) staff, and others interested in the Vocational Rehabilitation Program.

The RSA review team is expected to ask questions about a number of issues, some of which are: (1) Informed Client Choice in the VR program; (2) implementation of the Comprehensive System of Personnel Development (CSPD)—the plan that sets forth the educational goals for rehabilitation professionals; and (3) Workforce Investment Act (WIA) implementation throughout the 28 Local Workforce Development Boards and the workforce centers across the state.

Governor appoints new RCT members

he Rehabilitation Council of Texas (RCT) met Jan 27-28 to welcome newly appointed members. Anticipating the appointments from Gov. Bush to be made in April 1999, several members continued to serve on the Council even though their terms had expired. "The Governor's Office did an outstanding job appointing the new members and they are an enthusiastic and participatory group," said Anne Brown, Chairperson for the RCT. "We are looking forward to working with TRC to better serve the disabled communities of Texas."

GROUP 2 - Cathy Davis


Cathy Davis, a dedicated and conscientious employee at DDS Austin, has the reputation of doing whatever is necessary to get the job done, even if the job is not hers. In addition to her daily assignments, Davis finds time to help others. She served as a mentor when the new computer system was implemented at DDS, but her assistance did not end there. Other staff members ask her for help because she is friendly, approachable and explains in terms that others can understand.

Davis truly believes that sharing what she learns makes the agency stronger and helps everyone do a better job. She developed a new approach to helping staff learn the new computer equipment- a computer training program she calls "TechnoFriday." Every Friday (time and workload permitting), the staff gather to learn a function of their PC's they would not normally use. With the success of each project, the employees gain more self-confidence as well as marketable skills that enhance opportunities for growth and promotions.

GROUP 3 - Randy Smith

Randy Smith, Information Specialist in the Central Office PIO, is a straight shooter who enjoys super working relationships. Other staff often gather around his monitor to see the impeccable technical work and creative designs he creates. Sometimes, among the pearls, there are limitations we need to hear about. We know they are real because we are working with someone whose technical competence is beyond question. Just as important, Smith shines as a communicator, with a calm, open, professional style.

As a professional role model, Smith is at the top. It's everyday business for him to help with multi-media packages. Wherever there are limits, Smith is often there, pushing the envelope. He frequently finds new and different ways to display that tired old information. One administrator said that "Smith invigorated the information in a mission-critical presentation with classy digital photos by taking a short trip through the capitol complex with a camera, and the presentation was a home run in the big league."



The largest disability examiners (DE) class assembled at one time at TRC-DDS graduated on Oct. 7. The class incorporated 40 new DE's into the DDS workforce, filling vacancies created when a substantial number of people retired or were promoted. "These vacancies all hit at the same time," says Perry Watson, HRD director at DDS. "We generally have 20-25 vacancies to fill when we start a new class. But, this time, we had over 40 vacancies and we started another class on Dec. 1 to fill more vacancies that have come up since we hired this group." Watson said they accommodated the extra trainees by doubling the size of the main classroom and adding one computer training room to the existing two rooms. "Timing was perfect," continued Watson. "This class immediately followed the computer conversion we completed last spring so we had the extra room already set up to enable us to train everyone at DDS at the same time. Watson says things should go back to normal with the next DE class.

TRC mourns deaths of two employees


Jim Talley

Pam Eaker

The First Responder Team has a new automatic external defibrillator (AED) that will be dedicated to a beloved friend and coworker, Pam Eaker, who passed away



on Dec. 13, 1999. Eaker, a member of the First Responder Team for two and a half years, died from complications from a motor vehicle accident that occurred on Dec. 10. She was a 17-year employee of TRC.

The First Responder Team provides interim care to the 950 employees at DDS in Austin and is often called upon to help employees keep track of blood pressure and other medical conditions. (see our March/April 1999 issue). An AED is used to deliver an electrical shock to the heart (defibrillation) when someone experiences sudden cardiac arrest (SCA) and it is the best treatment to restore an ineffective heart rhythm. Responders will take the AED on all emergency calls as a standard procedure, whether a situation is initially considered a cardiac call or not. Funds to purchase the AED came from donations made by staff at the Health Fair Committee Drawing and Silent Auction, from Health Fair presenters, and TADE.
