So, a plan has been worked out so students can get as much help as possible without dropping out of school. This plan is called the TRC School Program.

Frank Perdue and Milt Lege' worked closely with Staff Development - Instructional Media in the development of the School Program materials. The materials include a tape/slide presentation, flip chart and handbook for high school personnel, brochures and a Student Health Survey that help to identify students who may be eligible for TRC services.

Copies of the A/V presentation can be checked out from regional offices. Due to the request for materials, additional paper has been ordered for the printing of the publications. TRC Supply has issued stock numbers for the brochure, #0522; and handbook, #0523; and the Student Health Survey, #0524. These will be available in a few weeks.

DDD Hosts SSA Managers, Directors

Last month, for the first time in recent history, the Disability Determination Division hosted a conference for Social Security Administration Area Directors and District Managers. Approximately 30 directors and managers met with DDD personnel to discuss mutual goals and concerns related to disability programs and, at the same time, to learn more about DDD's operation.

The SSA representatives were treated to a tour of DDD and viewed a slide presentation detailing the DDD operation. They also heard from TRC Commissioner Harvey, who emphasized the

Harvey, who emphasized the need for continual concern for improving the delivery of services to the public in order to offset recent increases in negative public attitudes toward government workers at all

levels.

Assistant Deputy Commissioner Dale Place briefed the gathering on the current and projected case processing profile, stressing that the primary goal has been to improve the quality of service.

Noel Wall, Assistant Regional Commissioner for Programs in the Dallas SSA Region, also addressed the conference. He complimented DDD for maintaining a high degree of professionalism and for being willing to innovate and cooperate with recommendations, initiatives and changes.
