Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

This bill amends the Special District Local Laws Code by adding Chapter 6916 relating to the Kaufman County Fresh Water Supply District No. 1-D (District). The bill also: specifies that the following laws apply to the District: Chapters 49, 51, and 53, Water Code, Chapters 372 and 375, Local Government Code, and Chapter 257, Transportation Code; grants the District authority for road projects and joint road projects; specifies that a county or municipality may not impair the district's ability to exercise its powers; The District may reimburse expenditures as provided by Sections 257.003(a) and (b), Transportation Code, without the approval required by Section 257.003(c), Transportation Code; The District may reimburse for road projects and joint road projects without the approval from the Executive Director, required by Section 49.107(f), Water Code; specifies that Sections 49.181 and 49.182, Water Code, and Section 375.208, Local Government Code do not apply to road projects and joint road projects, bonds secured by an assessment of revenue, or bonds issued under Chapters 372 and 375, Local Government Code; The District may enter into a contract for road projects in the same manner as Chapter 257, Transportation Code, except that competitive bidding is governed by Subchapter I, Chapter 49, Water Code; allows the District to divide; and validates and confirms the creation of the District
