

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The passing of William Parks Johnson on January 1,
2 2017, at the age of 93, has brought great sorrow to his loved ones
3 and neighbors in the city of Wimberley, where he was greatly admired
4 for his extraordinary generosity and kindness; and

5 WHEREAS, Bill Johnson was born in Houston in 1923 to Louise
6 Johnson and Parks Johnson, whose career in radio took the family to
7 nearly every state and another dozen countries during Bill's
8 childhood; after graduating from high school, he enrolled at The
9 University of Texas but interrupted his education to join the U.S.
10 Marine Corps when the United States entered World War II; as a first
11 lieutenant, he fought with his regiment in the Battle of Iwo Jima,
12 until being wounded and forced to return home with an honorable
13 discharge; and

14 WHEREAS, Resuming his studies at UT, Mr. Johnson pursued a
15 degree in geology and competed in swimming, serving as captain of
16 multiple conference championship swim teams; in 1947, following his
17 graduation, he married the love of his life, the former Mary Frances
18 Brown, with whom he shared a rewarding union that spanned nearly
19 seven decades; the couple moved to his family's ranch in Wimberley
20 and went on to raise five children, Lynn, Jock, Clay, Blake, and
21 Scott; and

22 WHEREAS, Mr. Johnson first attempted to make a living through
23 ranching before taking a job as director of a start-up summer camp
24 under his old swimming coach; the environment at Camp Longhorn

1 proved to be an ideal fit for him, and he showed a special knack for
2 finding solutions to problems and a stubborn resistance to giving
3 up until a solution was found; he retired as camp director in 1978,
4 having left an indelible mark on the lives of many campers and
5 counselors, to whom he was always there to provide encouragement
6 and a sympathetic ear; and

7 WHEREAS, A proud resident of Wimberley for the better part of
8 a century, Mr. Johnson served as a longtime leader in the chamber of
9 commerce and as a founding member of Cypress Creek Church, and he
10 also dedicated a great deal of time to collecting and publishing
11 information about Wimberley history; and


12 WHEREAS, Throughout the course of his life, Bill Johnson

15 memories of his unfailing compassion, integrity, and friendship;

20 further


21 RESOLVED, That an official copy of this resolution be


