- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 61.9772, Education Code, is amended by
- 7 amending Subsection (c) and adding Subsection (d) to read as
- 8 follows:
- 9 (c) For a student to continue to receive a scholarship
- 10 awarded under this subchapter, the student must maintain
- 11 satisfactory academic progress as determined by the board
- 12 [institution in which the student is enrolled].
- (d) If the board determines that a student appointed under
- 14 Subsection (b) to receive an initial scholarship under this
- 15 <u>subchapter</u> has failed to maintain eligibility or otherwise meet the
- 16 requirements to continue receiving the scholarship, beginning with
- 17 the academic year following the determination, the elected official
- 18 who appointed the student may appoint another eligible student
- 19 under this subchapter to receive any available funds designated for
- 20 the student who no longer meets the requirements for the
- 21 scholarship.
- 22 SECTION 2. This Act takes effect September 1, 2018.
