

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, Eugene Adrian Van Zelfden Jr. of Austin has  
2 dedicated much of his life to serving his fellow citizens, and his  
3 noteworthy efforts indeed merit special recognition; and

4           WHEREAS, A Distinguished Honor Graduate of the U.S. Air Force  
5 Academy Class of 1969, Mr. Van Zelfden proudly served his country  
6 as a member of the armed forces, eventually rising to the rank of  
7 captain; as a civilian, he earned an MBA from Southern Illinois  
8 University in 1972 and a juris doctor degree from the Case Western  
9 Reserve University School of Law in 1978; jointly licensed as a  
10 certified public accountant and an attorney, he has practiced in  
11 both fields since 1979, and he currently works at the Fowler Law  
12 Firm in Austin and teaches business courses as an adjunct faculty  
13 member at Wizard Academy; and

14           WHEREAS, In 1985, Mr. Van Zelfden founded the Texas  
15 Grassroots Coalition with the goal of informing the public of civic  
16 and governmental affairs; he also wrote and published a monthly  
17 newsletter about Texas government and wrote, produced, and voiced  
18 the daily radio program the *Texas Minute*, which aired on 24 stations  
19 across the state; he went on to organize the Tax Practice Group in  
20 2002, where he served as a volunteer coordinator, teaching updates  
21 in federal and state tax laws to CPAs, tax attorneys, and other tax  
22 preparers in Central Texas, and in 2008, he created *Tidbits in Time*  
23 *Almanac*, a modern version of Benjamin Franklin's *Poor Richard's*  
24 *Almanack*; and


1           WHEREAS, Adrian Van Zelfden is truly a public-spirited Texan,

3 commended; now, therefore, be it


4           RESOLVED, That the 85th Legislature of the State of Texas

10 Texas House of Representatives and Senate.






