| 7 | Sec. 1.016. OATHS BY ELECTION OFFICERS. (a) An oath or |
| 8 | statement required by the Texas Constitution or this code prior to |
| 9 | an election officer entering service may be administered and a |

| 12 | of state's staff, or a state inspector appointed by the secretary; |

- 11 (b) An oath, statement, or certificate described under
- 12 <u>Subsection (a)</u> is valid for the duration of the election officer's
- 13 term of office and shall be filed with election records for the
- 14 <u>election in which the election officer is serving.</u>
- (c) The secretary of state may prescribe a form of oath,
- 16 statement, or certificate that incorporates any oaths or statements
- 17 required by the Texas Constitution or this code for an election
- 18 officer into a single oath or statement.
- SECTION 2. Sections 31.092(b), (d), and (e), Election Code,
- 20 are transferred to Section 31.093, Election Code, redesignated as
- 21 Sections 31.093(c), (d), and (e), Election Code, respectively, and
- 22 amended to read as follows:
- 23 (c) [(b)] On request of the county chair of a political
- 24 party holding a primary election in the county, the [The] county
- 25 election officer shall [may] contract with the county executive
- 26 committee of the [a political] party [holding a primary election in
- 27 the county of perform election services, as provided by this

- 1 subchapter, in the party's general primary election and [or] runoff
- 2 primary election in accordance with a cost schedule agreed on by the
- 3 contracting parties[ror-both].
- 4 (d) In a contract required [authorized] by Subsection (c)
- 5 $[\frac{b}{b}]$, the county election officer may not prevent the county chair
- 6 or the chair's designee from supervising the conduct of the primary
- 7 election, including the tabulation of results, as required by
- 8 Chapter 172. A county election officer who violates this
- 9 subsection commits an offense. An offense under this subsection is
- 10 <u>a Class B misdemeanor</u>.
- 11 (e) A [If a] county election officer [enters into a contract
- 12 with a county executive committee under Subsection (b) to perform
- 13 election services, the officer] must offer to contract on the same
- 14 terms with the county executive committee of each political party
- 15 holding a primary election in the county.
- SECTION 3. Section 31.093(a), Election Code, is amended to
- 17 read as follows:
- 18 (a) If requested to do so by a political subdivision [or
- 19 political party], the county elections administrator shall enter
- 20 into a contract to furnish the election services requested, in
- 21 accordance with a cost schedule agreed on by the contracting
- 22 parties.
- SECTION 4. Section 32.002, Election Code, is amended by
- 24 adding Subsection (c-1) to read as follows:
- 25 (c-1) For purposes of this subsection, the county chair
- 26 shall provide a list of names of persons eligible for appointment as
- 27 election judges. Judges of countywide polling places established

- under Section 43.007 must be appointed from the list of names of 1 persons submitted by the county chair in compliance with Subsection 2 (c) except that in appointing a person from the list the 3 4 commissioners court shall apportion the number of judges in direct 5 proportion to the percentage of precincts located in each county 6 commissioners precinct won by each party in the last gubernatorial election, the commissioners court is not required to make the 7 8 appointments based on specific polling locations or precincts, a presiding judge or alternate presiding judge is not required to 9 10 serve in a polling place located in the precinct in which the judge 11 resides, and more than one presiding judge or alternate presiding 12 judge may be selected from the same precinct to serve in polling places not located in the precinct in which the judges reside. The 13 14 county chairs may submit, and the commissioners court may preapprove, the appointment of more presiding judges or alternate 15 16 presiding judges than necessary to fill available positions. The 17 county clerk may select an individual whose appointment was preapproved by the commissioners court to fill a vacancy in a 18 19 position that was held by an individual from the same political party. Other than a judge's party affiliation, nothing in this 20 21 subsection precludes a county clerk from placing an election officer at a countywide polling place based on the need for services 22 23 at that location.
- SECTION 5. Section 32.002, Election Code, is amended by adding Subsection (g) to read as follows:
- 26 (g) Following an oral warning to the election judge and with 27 the concurrence of the county chair of the same political party with

- 1 which the judge is affiliated or aligned, the county clerk may
- 2 remove, replace, or reassign an election judge who causes a
- 3 disruption in a polling location or wilfully disobeys the
- 4 provisions of this code. A vacancy created under this subsection
- 5 shall be filled in the same manner as an emergency appointment under
- 6 Section 32.007.
- 7 SECTION 6. Section 32.006(a), Election Code, is amended to
- 8 read as follows:
- 9 (a) The county chair of a political party holding a primary
- 10 election shall appoint for each primary[, with the approval of the
- 11 county executive committee, the judges for each precinct in which
- 12 the election will be held in the county and fill any vacancy that
- 13 occurs in the position of presiding judge or alternate presiding
- 14 judge.
- SECTION 7. Section 32.009(d), Election Code, is amended to
- 16 read as follows:
- (d) A notice to a presiding judge must state the name, [and]
- 18 address, and any available telephone number and e-mail address of
- 19 the alternate, and a notice to an alternate must state the name,
- 20 [and] address, and any available telephone number and e-mail
- 21 address of the presiding judge.
- SECTION 8. Subchapter A, Chapter 32, Election Code, is
- 23 amended by adding Section 32.012 to read as follows:
- 24 Sec. 32.012. PROVISION OF INFORMATION RELATING TO ELECTION
- 25 JUDGES APPOINTED BY COMMISSIONERS COURT. (a) After the
- 26 commissioners court appoints a presiding election judge and an
- 27 alternate presiding judge, the county clerk shall provide to the

- 1 county chair of each political party a list of the individuals
- 2 appointed by the commissioners court.
- 3 (b) The appointment list must be provided in writing.
- 4 SECTION 9. Section 32.034, Election Code, is amended by
- 5 adding Subsection (f) to read as follows:
- 6 (f) Following an oral warning to the election clerk and with
- 7 the concurrence of the county chair of the same political party with
- 8 which the election clerk is affiliated or aligned, the county clerk
- 9 may remove, replace, or reassign an election clerk who causes a
- 10 disruption in a polling location or wilfully disobeys the
- 11 provisions of this code. A vacancy created under this subsection
- 12 shall be filled by the presiding judge, who shall appoint a
- 13 replacement election clerk who is affiliated or aligned with the
- 14 same political party as the original clerk, if possible.
- SECTION 10. Section 32.114(e), Election Code, is amended to
- 16 read as follows:
- 17 (e) An election judge, early voting clerk, or deputy early
- 18 voting clerk in charge of an early voting polling place is entitled
- 19 to compensation for attending the training program at an hourly
- 20 rate fixed by the appropriate authority in an amount that is equal
- 21 to or greater than the federal minimum wage [not to exceed \$7].
- SECTION 11. Section 43.007, Election Code, is amended by
- 23 amending Subsection (a) and adding Subsections (m) and (n) to read
- 24 as follows:
- 25 (a) The secretary of state shall implement a program to
- 26 allow each commissioners court participating in the program to
- 27 eliminate county election precinct polling places and establish

- 1 countywide polling places for:
- 2 (1) each general election for state and county
- 3 officers;
- 4 (2) each election held on the uniform election date in
- 5 May and any resulting runoff;
- 6 (3) each election on a proposed constitutional
- 7 amendment;
- 8 (4) each primary election and runoff primary election
- 9 if:
- 10 (A) the county chair or county executive
- 11 committee of each political party participating in a joint primary
- 12 election under Section 172.126 agrees to the use of countywide
- 13 polling places; or
- 14 (B) the county chair or county executive
- 15 committee of each political party required to nominate candidates
- 16 by primary election agrees to use the same countywide polling
- 17 places; and
- 18 (5) each election of a political subdivision located
- 19 in the county that is held jointly with an election described by
- 20 Subdivision (1), (2), (3), or (4).
- 21 (m) In adopting a methodology under Subsection (f), the
- 22 <u>county must ensure that:</u>
- (1) each county commissioners precinct contains at
- 24 <u>least one countywide polling place; and</u>
- 25 (2) the total number of permanent branch and temporary
- 26 branch polling places open for voting in a county commissioners
- 27 precinct does not exceed more than twice the number of permanent

- 3 (n) To the greatest extent possible, countywide polling
- 4 places shall be located in a precinct where the political party that

- 8 SECTION 12. Section 61.003(b)(1), Election Code, is amended
- 9 to read as follows:
- 10 (1) "Electioneering" includes the posting, use, or
- 11 distribution of political signs or literature. The term does not
- 12 include the distribution of a notice of a party convention
- 13 <u>authorized under Section 172.1114.</u>
- SECTION 13. Section 85.009(b), Election Code, is amended to
- 15 read as follows:
- 16 (b) Before July of each year, the county chair of each
- 17 political party holding a primary election in the county shall
- 18 submit in writing to the county clerk a list of names of persons in
- 19 order of preference for each early voting polling place who are
- 20 eligible for selection as an election officer. The county chair
- 21 may supplement the list of names of persons until the 30th day
- 22 before early voting begins in case an appointed election officer
- 23 becomes unable to serve. The county clerk shall appoint the first
- 24 person meeting the applicable eligibility requirements from the
- 25 list submitted in compliance with this subsection by the party with
- 26 the highest number of votes in the county as the presiding judge
- 27 [election officer] of that polling place and the first person

- 21 SECTION 15. Subchapter A, Chapter 87, Election Code, is

- 24 IDENTIFICATION. (a) A member of the early voting ballot board

- 27 every eligible voter's vote is accepted and counted, and that only

- 1 the ballots of those voters who violated the Texas Election Code
- 2 will be rejected. I will make every effort to correctly reflect the
- 3 voter's intent when it can be clearly determined. I will not work
- 4 alone when ballots are present and will work only in the presence of
- 5 a member of a political party different from my own. I will

- 8 (b) A member of the early voting ballot board who arrives
- 9 after the oath is made shall repeat the oath aloud before performing
- 10 any duties as a member.
- (c) Following administration of the oath, each member of the
- 12 early voting ballot board shall be issued a form of identification,
- 13 prescribed by the secretary of state, to be displayed by the member
- 14 during the member's hours of service on the board.
- 15 SECTION 16. Subchapter G, Chapter 87, Election Code, is
- 16 amended by adding Section 87.127 to read as follows:
- Sec. 87.127. RESOLUTION OF INCORRECT DETERMINATION BY EARLY
- 18 VOTING BALLOT BOARD. (a) If a county election officer, as defined
- 19 by Section 31.091, determines a ballot was incorrectly rejected or
- 20 accepted by the early voting ballot board before the time set for
- 21 convening the canvassing authority, the county election officer may
- 22 petition a district court for injunctive or other relief as the
- 23 court determines appropriate.
- (b) In an election ordered by the governor or by a county
- 25 judge, the county election officer must confer with and establish
- 26 the agreement of the county chair of each political party before
- 27 petitioning the district court.

- 1 SECTION 17. Subchapter A, Chapter 127, Election Code, is
- 2 amended by adding Section 127.0015 to read as follows:
- 3 Sec. 127.0015. CENTRAL COUNTING STATION OFFICERS: OATH AND
- 4 IDENTIFICATION. (a) Election officers appointed under this
- 5 subchapter shall repeat the following oath aloud:
- 6 "I swear (or affirm) that I will objectively work to be sure
- 7 every eligible voter's vote is accepted and counted, and that only
- 8 the ballots of those voters who violated the Texas Election Code
- 9 will be rejected. I will make every effort to correctly reflect the
- 10 voter's intent when it can be clearly determined. I will not work
- 11 alone when ballots are present and will work only in the presence of
- 12 a member of a political party different from my own. I will
- 13 faithfully perform my duty as an officer of the election and guard
- 14 the purity of the election."
- (b) An officer who arrives after the oath is made shall
- 16 repeat the oath aloud before performing any duties as an election
- 17 <u>officer.</u>
- (c) Following administration of the oath, each election
- 19 officer shall be issued a form of identification, prescribed by the
- 20 secretary of state, to be displayed by the officer during the
- 21 officer's hours of service at the central counting station.
- SECTION 18. Section 127.004(b), Election Code, is amended
- 23 to read as follows:
- 24 (b) To be eligible for appointment, a person must:
- 25 <u>(1)</u> have the competence, training, and experience
- 26 required for the proper performance of the work assigned; and
- 27 (2) in a county with a population of less than 60,000,

- 1 be a registered voter of the political subdivision served by the
- 2 authority establishing the counting station or an employee of the
- 3 political subdivision that adopts or owns the voting system.
- 4 SECTION 19. Section 127.007, Election Code, is amended by
- 5 adding Subsection (c) to read as follows:
- 6 (c) The plan required under this section must be available
- 7 to the public on request not later than 5 p.m. on the fifth day
- 8 <u>before the date of the election</u>.
- 9 SECTION 20. Section 127.096, Election Code, is amended by
- 10 adding Subsection (a-1) to read as follows:
- 11 (a-1) If the test is being conducted for a primary election,
- 12 the custodian of the automatic tabulating equipment shall notify
- 13 the county chair of the test at least 48 hours before the date of the
- 14 test. The county chair shall confirm receipt of the notice.
- 15 SECTION 21. Section 129.023, Election Code, is amended by
- 16 adding Subsection (b-1) to read as follows:
- 17 (b-1) If the test is being conducted for a primary election,
- 18 the general custodian of election records shall notify the county
- 19 chair of the test at least 48 hours before the date of the test. The
- 20 county chair shall confirm receipt of the notice.
- 21 SECTION 22. Section 141.031(a), Election Code, is amended
- 22 to read as follows:
- 23 (a) A candidate's application for a place on the ballot that
- 24 is required by this code must:

- Sec. 172.1111. POSTING NOTICE OF CONVENTIONS [PRECINCT
- 24 CONVENTION] REQUIRED. (a) Before the opening of the polls, the
- 25 presiding judge shall post at each outside door through which a
- 26 voter may enter the building in which the polling place is located a
- 27 written notice in bold print of the date, hour, and place for each

- 1 [convening the] precinct, county, senatorial, or state convention
- 2 that a voter in the precinct may be eligible to attend during the
- 3 <u>election year</u>.
- 4 (b) Notice posted under this section may include:
- 5 (1) the website of the county party and state party;
- 6 and
- 7 (2) any other information deemed necessary by the
- 8 state executive committee.
- 9 (b-1) The state chair shall develop a form for the notice
- 10 that may be used statewide. The judge is not required to use an
- 11 officially prescribed form for the notice, but must include any
- 12 information required by this section.
- 13 (b-2) A state chair, county chair, or precinct chair shall
- 14 provide the presiding judge with the necessary information
- 15 respecting the chair's associated convention.
- 16 (c) The notice must remain posted continuously through
- 17 election day.
- SECTION 31. Section 172.1112(a), Election Code, is amended
- 19 to read as follows:
- 20 (a) The county <u>clerk</u> [chair] shall post a notice of the
- 21 election and a notice of consolidated precincts, if applicable, in
- 22 the manner prescribed by Section 4.003(b) for general and special
- 23 elections. The notice of the election shall be posted on the
- 24 party's Internet website, if the party maintains a website. If the
- 25 party does not maintain a website, the notice shall be posted on the
- 26 bulletin board used for posting notice of meetings of the

The provisions of the bill addressing felony sanctions are the subject of this analysis. Under the provisions of the bill, the punishment for unlawful participation in party affairs would be enhanced and it would be punished at the misdemeanor and felony level, with the punishment based upon the specific circumstances of the offense. The bill would also create the offense of engaging in organized election fraud which would be punishable at one level higher than the most serious underlying offense committed or conspired to commit, unless the individual meets the standard to show the individual took certain actions to withdraw from the harvesting organization and prevent the underlying offense, in which case the offense would be punishable at its statutory level.

A first degree felony is punishable by confinement in prison for life or a term from 5 to 99 years; a second degree felony is punishable by confinement in prison for a term from 2 to 20 years; a third degree felony is punishable by confinement in prison for a term from 2 to 10 years; and a state jail felony is punishable by confinement in a state jail for a term from 180 days to 2 years or Class A misdemeanor punishment. In addition to confinement, most felony offenses are subject to an optional fine not to exceed \$10,000.

Creating a new criminal offense and enhancing an existing offense are expected to result in increased demands on the correctional resources of the counties or of the State due to longer terms of supervision in the community or longer terms of confinement within state correctional institutions and due to a potential increase in the number of individuals placed under supervision in the community or sentenced to a term of confinement within state correctional institutions. In fiscal year 2016, 24 individuals were arrested, fewer than 10 were placed under community supervision, and fewer than 10 were admitted into state correctional institutions for offenses under the applicable titles of the Election Code. This analysis assumes the provisions of the bill addressing felony sanctions would not result in a significant impact on the demand for state correctional resources.
