4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 964.052(a), Insurance Code, is amended
6	to read as follows:
7	(a) A captive insurance company may provide reinsurance to
8	an insurer covering the operational risks of the captive insurance
9	company's affiliates, or risks of a controlled unaffiliated
10	business, that the captive insurance company may insure directly
11	under Section 964.051 and:
12	(1) employee benefit plans offered by affiliates;
13	(2) liability insurance an affiliate must maintain as
14	a prerequisite for obtaining a license or permit if the law requires
15	maintenance of the liability insurance; [and]
16	(3) credit life insurance and credit disability
17	insurance offered as a part of, or directly relating to, the
18	operational risks of an affiliate; and
19	(4) workers' compensation insurance and employer
20	liability policies issued to affiliates if the insurer that
21	directly issues workers' compensation insurance and employer's
22	liability policies or its licensed, if required by law,
23	administrator or adjuster:
24	(A) services all claims incurred during the

policy period; and (B) complies with all requirements for an insurer under this code, including Chapter 462, and under Title 5, Labor Code. SECTION 2. This Act takes effect September 1, 2017.


