4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 264, Family Code, is
6	amended by adding Section 264.1251 to read as follows:
7	Sec. 264.1251. SUMMER INTERNSHIP PILOT PROGRAM. (a) The
8	department shall establish a summer internship pilot program that
9	provides foster youth with the opportunity to develop marketable
10	job skills and obtain professional work experience through a summer
11	internship with a participating business, nonprofit organization,
12	or governmental entity.
13	(b) The department may collaborate with other state
14	agencies, as appropriate, to establish the pilot program. The
15	pilot program may be implemented in more than one department
16	region.
17	(c) The department may enter into an agreement with one or
18	more entities described by Subsection (a) to allow the entity to
19	award internships to youth who participate in the pilot program.
20	Internships provided under the pilot program may be paid or unpaid.
21	(d) Not later than April 1 of each year, the department
22	shall select foster youth or former foster youth who are 15 years of
23	age or older to participate in the pilot program. Each youth
24	participating in the pilot program shall enter into an agreement

- 1 with the organization awarding the internship and the department
- 2 relating to the terms of the youth's internship.
- 3 (e) The department shall complete an evaluation of the pilot
- 4 program not later than the second anniversary of the date the
- 5 program begins.
- 6 (f) The department shall submit a report on the evaluation
- 7 of the pilot program to the governor, the lieutenant governor, and
- 8 the speaker of the house of representatives. The report must
- 9 <u>include:</u>
- 10 (1) the number of youth who participated in the pilot
- 11 program;
- (2) the location and type of internships provided
- 13 under the pilot program; and
- 14 (3) details of the department's efforts to recruit
- 15 eligible youth to participate in the pilot program.
- 16 (g) The executive commissioner may adopt rules necessary to
- 17 implement this section.
- (h) This section expires September 1, 2021.
- SECTION 2. Not later than January 1, 2018, the Department of
- 20 Family and Protective Services shall establish the pilot program
- 21 required by Section 264.1251, Family Code, as added by this Act.
- 22 SECTION 3. This Act takes effect immediately if it receives
- 23 a vote of two-thirds of all the members elected to each house, as
- 24 provided by Section 39, Article III, Texas Constitution. If this
- 25 Act does not receive the vote necessary for immediate effect, this
- 26 Act takes effect September 1, 2017.
