9	(j) The board shall make training on water loss auditing
10	available without charge from the board's website. The board may
11	provide training in person or by video or a functionally similar and
12	widely available medium. Training provided under this subsection
13	must include comprehensive knowledge of water utility systems and
14	terminology and any tools available for analyzing audit results.
15	In creating training materials, the board may consider other
16	organizations' training programs.
17	SECTION 2. This Act takes effect September 1, 2017.
