2           WHEREAS, Senate Bill No. 1450 has been adopted by the house  
3 of representatives and the senate and is being prepared for  
4 enrollment; and

5           WHEREAS, The bill now contains technical errors that should  
6 be corrected; now, therefore, be it

7           RESOLVED by the 85th Legislature of the State of Texas, That  
8 the enrolling clerk of the senate be instructed to make the  
9 following corrections to the enrolled version of Senate Bill  
10 No. 1450:

11           (1) In SECTION 1 of the bill, in the heading to amended  
12 Section 36.004, Insurance Code, strike "INTERIM".

13           (2) In SECTION 1 of the bill, in amended Section 36.004(a),  
14 Insurance Code, strike "that version of".

15           (3) In SECTION 1 of the bill, in added Section 36.004(b)(1),  
16 Insurance Code, strike "that version" and substitute "the  
17 commissioner to adopt rules consistent with the rule, regulation,  
18 directive, or standard".


19           (4) In SECTION 1 of the bill, in added Section 36.004(c),  
20 Insurance Code, strike "an interim" and substitute "a".


21           (5) Add the following appropriately numbered SECTION to the  
22 bill and renumber SECTIONS of the bill accordingly:

23           SECTION \_\_\_\_\_. Section 36.004, Insurance Code, as amended by  
24 this Act, applies only to a rule adopted or amended on or after the



2 date of this Act and not amended on or after that date is governed by  
3 the law applicable to the rule immediately before the effective  
4 date of this Act, and that law is continued in effect for that  
5 purpose. \_\_\_\_\_




