16	device in promoting tourism around this state and at the locations
17	or organizations designated under this section; and
18	(4) to the extent funds are available, the development
19	of itineraries and maps to guide tourists to locations or
20	organizations designated under this section.
21	(c) The commission shall adopt:
22	(1) eligibility criteria for a designation under this
23	section; and
24	(2) procedures to administer the program created under

2	(d) To implement this section, the commission may, as
3	necessary, enter into a memorandum of understanding with:
4	(1) the Texas Economic Development and Tourism Office,
5	including the divisions of the governor's office responsible for
6	tourism and music, film, television, and multimedia;
7	(2) the Texas Commission on the Arts; or
8	(3) the Texas Department of Transportation.
9	(e) The commission may solicit and accept gifts, grants, and
10	other donations from any source to implement this section.
