Chapter 375

1 AN ACT 2 relating to the designation of a portion of Interstate Highway 20 as the Trooper Billy Jack Zachary Memorial Highway. 3 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Subchapter B, Chapter 225, Transportation Code, is amended by adding Section 225.123 to read as follows: 6 7 Sec. 225.123. TROOPER BILLY JACK ZACHARY MEMORIAL HIGHWAY. 8 The portion of Interstate Highway 20 in Ward County between (a) 9 mile marker 80 and mile marker 82 is designated as the Trooper Billy Jack Zachary Memorial Highway. The designation is in addition to 10 any other designation. 11 12 (b) Subject to Section 225.021(c), the department shall: (1) design and construct markers indicating the 13 highway number, the designation as the Trooper Billy Jack Zachary 14 Memorial Highway, and any other appropriate information; and 15 (2) erect a marker at each end of the highway and at 16 17 appropriate intermediate sites along the highway. SECTION 2. This Act takes effect immediately if it receives 18 a vote of two-thirds of all the members elected to each house, as 19 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2017. 22


