1 AN ACT

2 relating to the designation of State Highway 191 in Ector County as  
3 the Chris Kyle Memorial Highway.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subchapter B, Chapter 225, Transportation Code,  
6 is amended by adding Section 225.123 to read as follows:


7 Sec. 225.123. CHRIS KYLE MEMORIAL HIGHWAY. (a) The portion  
8 of State Highway 191 in Ector County is designated as the Chris Kyle  
9 Memorial Highway.


10 (b) Subject to Section 225.021(c), the department shall:

11 (1) design and construct markers indicating the  
12 designation as the Chris Kyle Memorial Highway and any other  
13 appropriate information; and


14 (2) erect a marker at each end of the highway and at  
15 appropriate intermediate sites along the highway.

16 SECTION 2. This Act takes effect September 1, 2017.





**IN RE: HB1483** by Landgraf (Relating to the designation of State Highway 191 in Ector County as the Chris Kyle Memorial Highway.), **As Engrossed**

**No significant fiscal implication to the State is anticipated.**

The bill would require the Texas Department of Transportation (TxDOT) to design, construct, and erect highway markers designating a portion of State Highway 191 as the Chris Kyle Memorial Highway, subject to Section 225.021 (c), Transportation Code.

Section 225.021 (c), Transportation Code, specifies that TxDOT may not design, construct, or erect the marker unless a grant or donation of funds is made to the department to cover the cost.
