1 AN ACT 2 relating to weight limitations for natural gas motor vehicles. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 621.101, Transportation Code, is amended 4 5 by adding Subsection (b-1) to read as follows: 6 (b-1) Notwithstanding any other provision of this section, 7 a vehicle or combination of vehicles that is powered by an engine 8 fueled primarily by natural gas may exceed any weight limitation 9 under this section by an amount that is equal to the difference 10 between the weight of the vehicle attributable to the natural gas 11 tank and fueling system carried by that vehicle and the weight of a 12 comparable diesel tank and fueling system, provided that the 13 maximum gross weight of the vehicle or combination of vehicles may 14 not exceed 82,000 pounds. 15 SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 16 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2017.
