THE COTTON SEED REGISTRATION AND CERTIFIED LAW.

Outline of Specifications for State Approved Seed.

Registered Cotton Seed.

1. Registred Cotton Seed are seed of a useful strain of cotton, the pedigree of which is known to the Board of Plant Breeder Examiners.

2. The strain of cotton is one that will transmit to its progeny its characteristics without any great variation therefrom.

3. The seed are produced under the direct supervision of a Registered Cotton Seed Breeder.

4. The seed have been produced from plats or fields showing a varietal purity of 95 per cent or more, as determined by an official inspector provided by law.

5. The seed are ginned and stored in accordance with strict State regulations.

6. Registered seed are labeled with *blue tags as* illustrated in this bulletin.

Certified Seed.

1. Certified seed are the first year progeny of Registered seed.

2. The seed have been produced from fields showing a varied purity of 90 per cent or more as determined by an official inspector provided for by law.

3. The seed are ginned and stored in accordance with strict State regulations.

4. Certified seed are labled with *red* tags as illustrated in this bulletin.

Recertified Seed.

1. Recertified seed are the first year progeny of certified seed.

2. The seed have been produced from fields showing a varietal purity of 85 per cent or more as determined by an official inspector provided for by law.

3. The seed are ginned and stored in accordance with strict State regulations.

4. Recertified seed are labelled with *white tags* as illustrated in this bulletin.

Qualifications of a Registered Cotton Seed Breeder.

1. The applicant must appear before the Board of Plant Breeder Examiners in person and establish the fact that he or his concern is a person, firm or corporation of good character and with a reputation for honesty and fair dealing.

2. One or more persons in the employment of each firm must have the standing of a qualified and competent cotton seed breeder and must have taken a written examination on the principles of plant breeding, and have passed same with a satisfactory grade. 3. The applicant must own or control the land necessary for the breeding and production of his seed.

4. The applicant must show that he has complete control of a gin. In the event of limited production, ginning must be done under the supervision of an inspector.

5. The applicant must be in possession of a uniform strain of cotton, the pedigree of which is known to the Board of Plant Breeding Examiners.

6. The applicant must agree to abide by the rules and regulations promulagated by the Board and to sell only such cotton seed as that which is approved by the Commissioner of Agriculture after a through field inspection and investigation.

Qualifications of "Certified Cotton Seed Grower" and for "License to Produce Certified Cotton Seed."

1. An applicant for license as "Certified Cotton Seed Grower" to produce certified cotton seed, as provided for in this Act, shall be a person, firm or corporation of good character and reputation for honesty, comptency and fair dealing.

2. It must be shown to the Board that the person, firm or corporation seeking license to produce "Certified Cotton Seed" owns or controls land necessary in the production of seed of high purity and excellence. If such applicant does not own his land, it will then be necessary to furnish the said Board with copies of all contracts showing actual possession of such land.

3. The applicant must show that he has complete control of a gin. In the event of limited production, ginning must be done under the supervision of an inspector.

4. All applicants to produce "Certified Cotton Seed" shall have in his or its possession sufficient quantity of Registered Cotton Seed to plant the acreage applied upon; provided that, if said applicant has grown Certified Seed the previous year, which was the first year progency of Registered Seed, and which Certified Cotton Seed upon field examination has shown 92 per cent varietal purity or more, then he may be licensed to produce Certified "Cotton Seed" from this stock which shall be known as "Recertified Seed."

Firms And Fields That Are Eligible to Inspection

Any person or firm engaged in the breeding of cotton and who desires official inspection of his or their fields must first qualify as registered cotton seed breeder or certified cotton seed grower before the State Board of Plant Breeder Examiners. In other words, the applicant must show that he has facilities for doing cotton breeding work and that he is actually doing something toward improving or maintaining a valuable strain of cotton. If the applicant convinces the Board that he is qualified and equipped, his fields are recommended to the Commissioner of Agriculture for inspection. The acreage of the breeder is limited by the Board after investigation as to the amount of acreage that the applicant is capable of taking care of in the opinion of the Board. If the inspection reveals a cotton that is worthy of registration or certification it is so recognized; if it does not registration or certification is denied.

State Supervsion.

The Commissioner of Agriculture is charged with the enforcement of the law. Inspectors are employed to see that all State Registered Cotton Seed Breeders and Certified Cotton Seed Growers comply with rules and regulations promulgated by the Board. All transactions and records of Registered Breeders and Certied Seed Growers are subject to investigation by the inspectors. Frequent visits are made to the gins, and records pertaining to the seed production are obtained. In addition to this, Registered Breeders and Certified Seed Growers are required to file weekly with the Commissioner a gin certificate of every bale ginned, giving the name of the contractor, amount of the seed and other information of importance. Registered Cotton Seed Breeders and Certified Seed Growers must agree to sell only such cotton seed that has been registered or certified by the State, and it is the inspector's duty to carefully check up on matters pertaining to production and sales.

Licenses and tags of any Registered Breeder or Certified Seed Grower are subject to revocation for violation of any of the provisions of the law or rules and regulations promulgated by the State Board of Plant Breeder Examiners. Any person who falsely advertises himself as a Registered Cotton Seed Breeder or Certified Cotton Seed Grower or who offers cotton seed for sale and falsely represents it to be Registered or Certified is subject to conviction and penalty.

Gin Inspection.

Many good strains of cotton have been mixed by carelessness at the gin. The requirement of the law with reference to the exclusive gin, together with official inspection, eliminates the possibility of their becoming mixed. Gin regulations and inspections are made for the following reasons: (1) To see that only seed from the fields that have been inspected and approved are ginned. (2) To prevent any possible mixing with other seed. (3) To determine lint percentage and other lint qualifications. (4) To determine actual number of bushels of seed produced by each Firm.

Field Inspection

The varietal purity of cotton cannot be determined except by actual field inspection of the growing crop, consequently great stress is given this phase of the work.

After all requirements of the State Board of Plant Breeder Examiners have been met the applicant is issued a certificate which licenses such applicant to produce Registered and Certified Seed subject to official inspection.

Application for inspection must be filed with the Commissioner of Agriculture before June 1st of each year. This application contains the name with the respective acreage of each and every contractor or grower for the firm applying, together with the number of bushels of seed used to plant the acreage involved.

Each contractor's crop constitutes a unit and is inspected as such. Those crops showing purity counts below the prescribed percentages are rejected and if the average for the entire crop falls below the prescribed percentages the entire acreage is discarded. Likewise when the acreage meets the requirements of purity, field inspection is approved. It should be understood, however, while this final inspection is the most important it is by no means the only field knowledge that the inspector has of the strain in question.

A close study and check is made of all progeny rows, and increase work each season and therefore the field inspection is overlapping one year with another. Purity counts and records are made each season not only on the acreage producing the commercial seed and the acreage which will plant the commercial acreage for the next season, but also the increase plots that will be used to plant the commercial acreage several years in the future. Counts and purity determinations are made on all progenies over the period of years necessary to increase the selection to a commercial size.

On the final field inspection systematic counts are made at various intervals over the entire acreage applied upon. Units of 100 stalks are taken and each plant carefully studied and all off type plants noted, thus the percent of purity is determined. In this determination many factors are considered, plant characters, boll size and shape, length, strength, and uniformity of staple. In addition to this test 100 bolls are taken from 100 consecutive plants for a further laboratory test to determine lint index, percentage of lint, and character of staple.

Plots or fields showing more than five percent off type plants are disqualified for Registration and occurance of more than ten percent of such plants eleminates the production of certification.

How To Recognize State Certified Seed

Red and blue seed labels or tags are at the present time used by a great many seed dealers and the word "certified" has been used to apply to certain guarantees made by the seller or vendor of the seed. Persons desiring Texas State Certified Cotton Seed should see to it that the tag on the sacks are exactly as pictured herein bearing the State Seal. The State assumes no responsibility as to the purity of the cotton seed other than those bearing tags as shown herein.

Some Confusion About the Word "Pedigree."

The word "pedigree" as applied to cotton seed has reference to the history and origin of the seed. Therefore all Certified Cotton Seed are pedigreed. The preformance record of the planting stock of certified seed is determined by actual field inspection by State Inspectors.

Inasmuch as the word "pedigreed" has reference to the history of the seed it may readily be seen that the history and pedigree may be good or bad. The State has approved the pedigree of all Certified Seed. This explanation is made to counteract the wrong impression that has been formed in the minds of some that State Certified and Pedigreed Seed are two distinct classes of seed when in fact all State Certified Seed are pedigreed but all pedigreed seed are not State Certified.
