GCEH Executive Director Roberts to Join TRC

On January 12th, Virginia Roberts will join TRC as the new Executive Director of the Governor's Committee on Employment of the Handicapped. The decision was announced December 8th following a day long meeting of the GCEH.

Before coming to TRC, Roberts, a native Austinite, served as Governor Clements' Administrative Assistant for Handicapped Affairs. Her responsibilities in the Governor's Office included doing liaison work and staffing the Task Force for Handicapped Citizens. The position was funded by a grant from TRC.

Roberts graduated from the University of Texas at Austin in 1967 with a Bachelor's degree in Psychology and a Master's degree in Social Work. She completed one year of post graduate study at Regent College, Vancouver, British Columbia, Canada. Roberts worked for more than seven years at the Texas Department of Mental Health and Mental Retardation and three and a half years at the Texas Department of Human Resources.

On the personal side, Roberts says she enjoys travel to visit friends (she's been to England and Canada several times), church activities, quiet gatherings of friends, reading and concerts. She is a member of several professional and handicapped consumer advocacy organizations.

TRCA Seeks Counselor of the Year Nominations

TRC Facts for FY 1980

In compiling information for the 1980 Annual Report to the Governor, we ran across some facts from fiscal 1980 that may interest you.

Vocational Rehabilitation

The Vocational Rehabilitation program served a total of 100,264 clients.

The total cost of services to clients was \$57,725,074.

It cost an average of \$3,565 for each successfully rehabilitated client.

Of all clients served, 14,876 cases were closed as successfully rehabilitated.

Before vocational rehabilitation, the total client income amounted to \$19,627,764 (this figure includes income from state and federal public assistance funds).

After rehabilitation, total client income was \$110,012,240.

At the end of FY 1980, 29,692 clients remained on the active caseload, meaning their cases were carried over to FY 1981.

Disability Determination Division

On an average day, DDD processed approximately 620 claims.

Over the entire year, the Division processed a total of 147,652 claims by Texans for Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI) benefits.

Of the total number of claims, 35,823 were determined eligible to receive SSDI or SSI benefits.

These claims resulted in a total payment of \$63,477,000 in monthly benefits.

Of the total payment, \$49,416,000 was paid to SSDI workers and dependents and \$14,061,000 for SSI workers and dependents each month.

Approximately 25% of the applicants for disability benefits were referred to Vocational Rehabilitation for consideration for rehabilitation services.

The statistics hold some good news for TRC concerning employee turnover. In FY 1980, the turnover rate for Salary Groups 2-21 was 21.2 percent. That's about eight percent below the turnover rate in FY 1979, when it was 29.5 percent.

Keeping it in the Family

Actor Tony Orlando is starring in a movie about a father who runs 300 miles on his mentally retarded daughter's fifth birthday. The movie entitled "300 Miles for Stephanie", will be shown on NBC's Monday Night at the Movies, January 12th.

One of the stars of the production is a relative of TRC's own Marcia Haley, a secretary in the Wichita Falls Field Office. Mrs. Haley's great-niece, "T.J." Olivares of San Antonio, will play the part of Stephanie.

The world premiere of this movie is to be held in San Antonio a few days before the television premiere. Mrs. Haley and her husband are planning to attend.
