Explanation of Table

This table contains information on offenses in Texas statutory law classified as felonies. The offenses included are either expressly classified as felonies in statute or have been identified by Texas Legislative Council staff as felonies because an offense's punishment involves imprisonment in the Texas Department of Criminal Justice (TDCJ). The table includes the statute citation for each offense ("Code" and "Section Number" columns), a brief description of the offense ("Offense" column), and the felony category of the offense ("Felony Category" column). Links to each referenced statute section are provided in the "Section Number" column. The table is intended for informational purposes only.

The standard punishments for capital, first degree, second degree, third degree, and state jail felonies are set out in Sections [12.31](#), [12.32](#), [12.33](#), [12.34](#), and [12.35](#), Penal Code, and the standard punishments for Parks and Wildlife Code felonies and Parks and Wildlife Code state jail felonies are set out in Sections [12.407](#) and [12.4061](#), Parks and Wildlife Code. The table includes entries for offenses whose classification has been enhanced to a felony category. Offenses for which only the punishment, and not the felony category, has been enhanced are omitted and are not considered felonies for purposes of this publication. [Subchapter D, Chapter 12, Penal Code](#), provides information on common enhancements. Although a number of the offenses listed may also be classified as misdemeanors, the table addresses only the felonies.

Most felony offenses are assigned one of the standard felony categories. However, many of the offenses included in the table span multiple felony categories based on factors of the offense (e.g., a certain amount of money or controlled substance is involved or the offense is a subsequent offense). If an offense spans multiple categories, each felony category relevant to the offense has a separate entry in the table. If an offense potentially spans multiple felony categories without specification of the offense category, the felony category is listed as "Other"; for example, [Section 466.313, Government Code](#), sets the felony category for conspiracy with intent that a state lottery offense be committed at one category lower than the most serious offense that is the object of the conspiracy. In instances where a felony offense is not categorized as a standard felony, the felony category is listed as "Uncategorized" and a description of the punishment is provided in the "Punishment (nonstandard)" column. In instances where a statute section provides a standard felony category but specifies a nonstandard punishment, a description of the punishment is likewise provided. Effective April 1, 2019, statutes providing felonies under the Texas Racing Act in Vernon's Civil Statutes will be reorganized under the Occupations Code.

This publication is available in two electronic formats: a PDF version suitable for printing and easy reference by Code and Section Number (available at http://www.tlc.texas.gov/policy/felony_offenses.pdf) and an Excel version (available at http://www.tlc.texas.gov/policy/felony_offenses.xlsx).
