Feasibility Training Near

Every day, TRC counselors are faced with a challenging task. They must decided which of the thousands of people who apply for TRC services are, in fact, eligible. Though there are policy guidelines to follow, in some cases, the present guidelines aren't enough. This is especially true when an applicant has a minor impairment or a very severe disability.

To help the counselor with this dilemma, TRC officials are developing a Feasibility Training Program. The course is based on the findings of several feasibility studies conducted by committees composed of TRC personnel from around the state. By studying the disability groups TRC serves, these committes were able to determine, generally speaking, the factors that contribute to a person's success in the vocational rehabilitation program. By understanding which factors lead to the successful rehabilitation for a client, the counselor should be better prepared to determine which applicants would most benefit from services.

At present, Staff Development is working with employees from the field and Central Office to develop the training. By Jan. 1, the program will be ready to go.

Training for supervisors and regional staffs is scheduled for Jan. 1 through Feb. 15. All counselors will have participated in the training by April 15.

Hinojosa Named Program Officer

Bertha N. Hinoiosa is the new Program Officer for Region VI. Hinojosa, who has worked with the Commission for 14 years, received word of her promotion last month. replaces Jerry Martin, who left TRC to become a management consultant for a private firm.

Hinojosa started her career with TRC in 1967. By 1973, she had worked as a counselor in Harlingen, Edinburg, Pharr and North Dallas. In 1974, Hinojosa was promoted to supervisor of the Dallas West Field Office. For the past three years, she has supervised the Garland Field Office.

The new Program Officer

holds a bachelor's degree in psychology from Texas Woman's University. She earned a master's degree in human behavior management from Abilene Christian

University.

Regional Director Robert M. Marx says, "I've known Bertha since she was a counselor, and she has consistently done a good job in every position she's held. I am confident she will do well in her new position." Marx says the vacancy created by Hinojosa's promotion will not be filled. Instead, Region VI will experience "a reorganization of units" to redistribute the supervisory responsibilities to the remaining supervisors.

College Conference a First

College administrators, vocational rehabilitation counselors and others who work with disabled college students from around the state met in Austin last month to share ideas and solutions to problems encountered in making accessible college training a reality for disabled students. "Accessible College Training . . . The Dream Becoming a Reality for the Disabled" was sponsored by TRC, the University of Texas at Austin and the Coordinating Board, Texas College and University System.

The three day conference focused on the needs of disabled students and the ways colleges and universities are, or are not, meeting those needs. Subject matter ranged from legislative action affecting the disabled student and the college to sexuality and the handicapped to curing burnout among counselors and others who sometimes suffer the effects of a demanding caseload.

TRC Program Specialist Ron Trull, one of the organizers of the conference, says the need for such a program was identified several years ago. Trull adds that one of the most important aspects of the conference was giving people involved in the college and university program a chance to share information and ideas.

Bimonthly Payroll Nixed

TRC employees holding classified positions below salary group 12 have turned down an option to be paid on a bimonthly basis. During its regular session, the Texas Legislature passed a law which requires any state agency to pay employees below group 12 twice a month, if at least 30 percent of the eligible group wants to participate in the program.

Personnel Director Mike Mericle says the employees were polled, and less than 30 percent indicated they would like to be paid bimonthly. Therefore, the program will not be put into effect at TRC. Mericle has suggested, however, that the Commission resurvey eligible employees next summer.

Wheelchair Athletes Gearing Up

There's good news for wheelchair sports fans! Several exciting sporting events are planned for September and October.

The first event is scheduled for Saturday, Sept. 12, in Austin. Employee Safety Program Begins ...by Linda Dryden

As a result of recommendations made in the recent Operational Audit Report of the Governor's Office, the Texas Rehabilitation Commission is expanding its Employee Health and Safety Program. The administative responsibility for the program has been assigned to the Personnel Department and within this department, to me as the Accident Prevention Coordinator, Mr. James Jackson, Deputy Commissioner, has asked Regional Directors to designate the Personnel Officer/Assistant to coordinate the safety program at the regional level.

The Commission is vitally interested in the safety and health of its employees. Although TRC has a good safety record, there is room for improvement. Last fiscal year, the State of Texas paid over seven million tax dollars for medical bills as a result of on-the-job injuries of state employees. Some \$26,600 of this total was due to TRC employee accidents. Such

accidents are costly to the state not only in terms of medical bills paid, but in the reduction of the Commission's productivity and effectiveness due to employee absence. A major goal of the Health and Safety Program is to significantly reduce the number of jobrelated accidents.

The Health and Safety Program will continue to include safety surveys, analysis of agency accidents, and implementation of needed safety improvement. However, the program is being expanded with a major emphasis on employee safety awareness which will include both on and off job safety awareness. In the near future, we will be offering safety training in Fire Prevention, First Aid, Cardio-Pulmonary Resuscitation, and health related programs.

The success of TRC's Health and Safety Program depends on the acceptance of safety as a personal responsibility by all employees. All employees are urged to participate fully in our safety program. you have any special concerns relative to health and safety, please make them known to your Personnel Officer/Assistant. In the meantime, watch for safety notices, program announcements and seasonal safety tips in the "News and Views."
