## RULE 91a. DISMISSAL OF BASELESS CAUSES OF ACTION

\*\*\*

**91a.7 Award of Costs and Attorney Fees Required.** Except in an action by or against a governmental entity or a public official acting in his or her official capacity or under color of law, the court <u>must may</u> award the prevailing party on the motion all costs and reasonable and necessary attorney fees incurred with respect to the challenged cause of action in the trial court. The court must consider evidence regarding costs and fees in determining the award. Any award of costs or fees must be based on evidence.
