3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. The purpose of this Act is to ensure that the
5	Battleship "Texas," a national historic landmark whose engines are
6	national mechanical engineering landmarks and that is the only
7	remaining battleship to have fought in World War I and World War II,
8	is maintained and preserved in satisfactory condition for the
9	benefit of the citizens of this state.
10	SECTION 2. Section 22.261, Parks and Wildlife Code, is
11	amended to read as follows:
12	Sec. 22.261. JURISDICTION. The Battleship "Texas" is under
13	the jurisdiction of the department. The department shall enter
14	into a memorandum of understanding for a term of 99 years with an
15	appropriate nonprofit foundation for the operation and maintenance
16	of the Battleship "Texas."
17	SECTION 3. Subchapter T, Chapter 22, Parks and Wildlife
18	Code, is amended by adding Section 22.262 to read as follows:
19	Sec. 22.262. PRESERVATION STANDARDS. The memorandum of
20	understanding required by Section 22.261 must include provisions:
21	(1) governing the preservation, management, and
22	operation of the Battleship "Texas" consistent with the Standards
23	for Historic Vessel Preservation Projects with Guidelines for
24	Applying the Standards published by the Secretary of the United



2	January 1, 2019;
3	(2) requiring the nonprofit foundation described by
4	Section 22.261 to consult with the state historic preservation
5	officer on matters related to the preservation or repair of the
6	battleship; and
7	(3) regarding the protection of the public's interest
8	in maintaining and preserving a priceless historical asset in a
9	manner that ensures the public has access to the asset and an
10	opportunity to provide comment regarding the preservation of the
11	asset.
12	SECTION 4. The Parks and Wildlife Department shall enter
13	into the memorandum of understanding required by Section 22.261,
14	Parks and Wildlife Code, as amended by this Act, not later than the
15	later of:
16	(1) September 1, 2019; or
17	(2) the 90th day after the effective date of this Act.
18	SECTION 5. This Act takes effect immediately if it receives
19	a vote of two-thirds of all the members elected to each house, as
20	provided by Section 39, Article III, Texas Constitution. If this
21	Act does not receive the vote necessary for immediate effect, this
22	Act takes effect September 1, 2019.
