- 6 (b) Subsections (a)(5) and (6) do not apply to:
- 7 (1) a county with a population of less than 10,000;
- 8 (2) a municipality with a population of less than
- 9 5,000 located in a county with a population of less than 25,000; or
- 10 (3) a school district with a population of less than
- 11 5,000 in the district's boundaries and located in a county with a
- 12 population of less than 25,000.
- 13 SECTION 2. Sections 2051.152(a)(5) and (6), Government
- 14 Code, as added by this Act, apply only to a meeting held on or after
- 15 the effective date of this Act.
- SECTION 3. This Act takes effect September 1, 2019.
