5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter B, Chapter 531, Government Code, is
7	amended by adding Section 531.0221 to read as follows:
8	Sec. 531.0221. INITIATIVE TO INCREASE MENTAL HEALTH
9	SERVICES CAPACITY IN RURAL AREAS. (a) In this section, "local
10	mental health authority group" means a group of local mental health
11	authorities established under Subsection (b)(2).
12	(b) Not later than January 1, 2020, the commission, using
13	existing resources, shall:
14	(1) identify each local mental health authority that
15	is located in a county with a population of 250,000 or less or that
16	the commission determines provides services predominantly in a
17	county with a population of 250,000 or less;
18	(2) in a manner that the commission determines will
19	best achieve the reductions described by Subsection (d), assign the
20	authorities identified under Subdivision (1) to regional groups of
21	at least two authorities; and
22	(3) notify each authority identified under
23	Subdivision (1):
24	(A) that the commission has identified the

2	(B) which local mental health authority group the
3	commission assigned the authority to under Subdivision (2).
4	(c) The commission, using existing resources, shall develop
5	a mental health services development plan for each local mental
6	health authority group that will increase the capacity of the
7	authorities in the group to provide access to needed services.
8	(d) In developing a plan under Subsection (c), the
9	commission shall focus on reducing:
10	(1) the cost to local governments of providing
11	services to persons experiencing a mental health crisis;
12	(2) the transportation of persons served by an
13	authority in the local mental health authority group to mental
14	health facilities;
15	(3) the incarceration of persons with mental illness
16	in county jails that are located in an area served by an authority
17	in the local mental health authority group; and
18	(4) the number of hospital emergency room visits by
19	persons with mental illness at hospitals located in an area served
20	by an authority in the local mental health authority group.
21	(e) In developing a plan under Subsection (c):
22	(1) the commission shall assess the capacity of the
23	authorities in the local mental health authority group to provide
24	access to needed services; and
25	(2) the commission and the local mental health
26	authority group shall evaluate:
27	(A) whether and to what degree increasing the

capacity of the authorities in the local mental health authority 1 2 group to provide access to needed services would offset the cost to state or local governmental entities of: 3 4 (i) the transportation of persons for 5 mental health services to facilities that are not local providers; 6 (ii) admissions to and inpatient 7 hospitalizations at state hospitals or other treatment facilities; 8 (iii) the provision of services by hospital emergency rooms to persons with mental illness who are served by or 9 10 reside in an area served by an authority in the local mental health 11 authority group; and 12 (iv) the incarceration in county jails of 13 persons with mental illness who are served by or reside in an area served by an authority in the local mental health authority group; 14 (B) whether available state funds or 15 grant 16 funding sources could be used to fund the plan; and 17 (C) what measures would be necessary to ensure 18 that the plan aligns with the statewide behavioral health strategic 19 plan and the comprehensive inpatient mental health plan. 20 (f) each mental health services development plan In produced under this section, the commission, in collaboration with 21 22 the local mental health authority group, shall determine a method 23 of increasing the capacity of the authorities in the local mental 24 health authority group to provide access to needed services. 25 The commission shall compile and evaluate each mental (g) 26 health services development plan produced under this section and 27 determine:

1	(1) the cost-effectiveness of each plan; and
2	(2) how each plan would improve the delivery of mental
3	health treatment and care to residents in the service areas of the
4	authorities in the local mental health authority group.
5	(h) Not later than December 1, 2020, the commission, using
6	existing resources, shall produce and publish on its Internet
7	website a report containing:
8	(1) the commission's evaluation of each plan under
9	Subsection (g);
10	(2) each mental health services development plan
11	evaluated by the commission under Subsection (g); and
12	(3) a comprehensive statewide analysis of mental
13	health services in counties with a population of 250,000 or less,
14	including recommendations to the legislature for implementing the
15	plans developed under this section.
16	(i) The commission and the authorities in each local mental
17	health authority group may implement a mental health services
18	development plan evaluated by the commission under this section if
19	the commission and the local mental health authority group to which
20	the plan applies identify a method of funding that implementation.
21	(j) This section expires September 1, 2021.
22	SECTION 2. The Health and Human Services Commission is
23	required to implement a provision of this Act only if the
24	legislature appropriates money specifically for that purpose. If
25	the legislature does not appropriate money specifically for that

27 required to, implement a provision of this Act using other

2 SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2019. 6
