2	relating to the creation of the Montgomery County Municipal Utility
3	District No. 176 of Montgomery County; granting a limited power of
4	eminent domain; providing authority to issue bonds; providing
5	authority to impose assessments, fees, and taxes.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle F, Title 6, Special District Local Laws
8	Code, is amended by adding Chapter 8084 to read as follows:
9	CHAPTER 8084. MONTGOMERY COUNTY MUNICIPAL UTILITY DISTRICT NO.
10	176 OF MONTGOMERY COUNTY
11	SUBCHAPTER A. GENERAL PROVISIONS
12	Sec. 8084.0101. DEFINITIONS. In this chapter:
13	(1) "Board" means the district's board of directors.
14	(2) "City" means the City of Willis, Texas.
15	(3) "Commission" means the Texas Commission on
16	Environmental Quality.
17	(4) "Director" means a board member.
18	(5) "District" means the Montgomery County Municipal
19	Utility District No. 176 of Montgomery County.
20	Sec. 8084.0102. NATURE OF DISTRICT. The district is a
21	municipal utility district created under Section 59, Article XVI,
22	Texas Constitution.
23	Sec. 8084.0103. CONFIRMATION AND DIRECTOR ELECTION
24	REQUIRED. The temporary directors shall hold an election to

1	confirm the creation of the district and to elect five permanent
2	directors as provided by Section 49.102, Water Code.
3	Sec. 8084.0104. CONSENT OF MUNICIPALITY REQUIRED. The
4	temporary directors may not hold an election under Section
5	8084.0103 until each municipality in whose corporate limits or
6	extraterritorial jurisdiction the district is located has
7	consented by ordinance or resolution to the creation of the
8	district and to the inclusion of land in the district.
9	Sec. 8084.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
10	(a) The district is created to serve a public purpose and benefit.
11	(b) The district is created to accomplish the purposes of:
12	(1) a municipal utility district as provided by
13	general law and Section 59, Article XVI, Texas Constitution; and
14	(2) Section 52, Article III, Texas Constitution, that
15	relate to the construction, acquisition, improvement, operation,
16	or maintenance of macadamized, graveled, or paved roads, or
17	improvements, including storm drainage, in aid of those roads.
18	Sec. 8084.0106. INITIAL DISTRICT TERRITORY. (a) The
19	district is initially composed of the territory described by
20	Section 2 of the Act enacting this chapter.
21	(b) The boundaries and field notes contained in Section 2 of
22	the Act enacting this chapter form a closure. A mistake made in the
23	field notes or in copying the field notes in the legislative process
24	does not affect the district's:
25	(1) organization, existence, or validity;
26	(2) right to issue any type of bond for the purposes
27	for which the district is created or to pay the principal of and

1	interest on a bond;
2	(3) right to impose a tax; or
3	(4) legality or operation.
4	Sec. 8084.0107. EFFECT OF ANNEXATION. Notwithstanding any
5	other law, if any of the territory of the district is annexed by the
6	city into the city's corporate limits, the district:
7	(1) retains all of the district's outstanding debt and
8	obligations; and
9	(2) is not dissolved.
10	SUBCHAPTER B. BOARD OF DIRECTORS
11	Sec. 8084.0201. GOVERNING BODY; TERMS. (a) The district is
12	governed by a board of five elected directors.
13	(b) Except as provided by Section 8084.0202, directors
14	serve staggered four-year terms.
15	Sec. 8084.0202. TEMPORARY DIRECTORS. (a) On or after
16	September 1, 2019, the owner or owners of a majority of the assessed
17	value of the real property in the district may submit a petition to
18	the commission requesting that the commission appoint as temporary
19	directors the five persons named in the petition. The commission
20	shall appoint as temporary directors the five persons named in the
21	petition.
22	(b) Temporary directors serve until the earlier of:
23	(1) the date permanent directors are elected under
24	Section 8084.0103; or
25	(2) September 1, 2023.
26	(c) If permanent directors have not been elected under
27	Section 8084.0103 and the terms of the temporary directors have

No. 4640 1 expired, successor temporary directors shall be appointed or reappointed as provided by Subsection (d) to serve terms that 2 3 expire on the earlier of: 4 (1) the date permanent directors are elected under 5 Section 8084.0103; or 6 (2) the fourth anniversary of the date of the 7 appointment or reappointment. (d) If Subsection (c) applies, the owner or owners of a 8 majority of the assessed value of the real property in the district 9 10 may submit a petition to the commission requesting that the commission appoint as successor temporary directors the five 11 persons named in the petition. The commission shall appoint as 12 successor temporary directors the five persons named in the 13 14 petition. 15 SUBCHAPTER C. POWERS AND DUTIES Sec. 8084.0301. GENERAL POWERS AND DUTIES. The district 16 17 has the powers and duties necessary to accomplish the purposes for which the district is created. 18 19 Sec. 8084.0302. MUNICIPAL UTILITY DISTRICT POWERS AND 20 DUTIES. The district has the powers and duties provided by the 21 general law of this state, including Chapters 49 and 54, Water Code, 22 applicable to municipal utility districts created under Section 59, 23 Article XVI, Texas Constitution. 24 Sec. 8084.0303. AUTHORITY FOR ROAD PROJECTS. Under Section 52, Article III, Texas Constitution, the district may design, 25 26 acquire, construct, finance, issue bonds for, improve, operate, 27 maintain, and convey to this state, a county, or a municipality for

1	operation and maintenance macadamized, graveled, or paved roads, or
2	improvements, including storm drainage, in aid of those roads.
3	Sec. 8084.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
4	road project must meet all applicable construction standards,
5	zoning and subdivision requirements, and regulations of each
6	municipality in whose corporate limits or extraterritorial
7	jurisdiction the road project is located.
8	(b) If a road project is not located in the corporate limits
9	or extraterritorial jurisdiction of a municipality, the road
10	project must meet all applicable construction standards,
11	subdivision requirements, and regulations of each county in which
12	the road project is located.
13	(c) If the state will maintain and operate the road, the
14	Texas Transportation Commission must approve the plans and
15	specifications of the road project.
16	Sec. 8084.0305. COMPLIANCE WITH MUNICIPAL CONSENT
17	ORDINANCE OR RESOLUTION. The district shall comply with all
18	applicable requirements of any ordinance or resolution that is
19	adopted under Section 54.016 or 54.0165, Water Code, and that
20	consents to the creation of the district or to the inclusion of land
21	in the district.
22	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
23	Sec. 8084.0401. ELECTIONS REGARDING TAXES OR BONDS. (a)
24	The district may issue, without an election, bonds and other
25	obligations secured by:
26	(1) revenue other than ad valorem taxes; or
27	(2) contract payments described by Section 8084.0403.

1 (b) The district must hold an election in the manner provided by Chapters 49 and 54, Water Code, to obtain voter approval 2 before the district may impose an ad valorem tax or issue bonds 3 4 payable from ad valorem taxes. (c) The district may not issue bonds payable from ad valorem 5 6 taxes to finance a road project unless the issuance is approved by a vote of a two-thirds majority of the district voters voting at an 7 election held for that purpose. 8 Sec. 8084.0402. OPERATION AND MAINTENANCE TAX. (a) If 9 authorized at an election held under Section 8084.0401, the 10 district may impose an operation and maintenance tax on taxable 11 12 property in the district in accordance with Section 49.107, Water 13 Code. (b) The board shall determine the tax rate. The rate may not 14 15 exceed the rate approved at the election. Sec. 8084.0403. CONTRACT TAXES. (a) In accordance with 16 Section 49.108, Water Code, the district may impose a tax other than 17 18 an operation and maintenance tax and use the revenue derived from the tax to make payments under a contract after the provisions of 19 20 the contract have been approved by a majority of the district voters 21 voting at an election held for that purpose. (b) A contract approved by the district voters may contain a 22 23 provision stating that the contract may be modified or amended by the board without further voter approval. 24 25 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS Sec. 8084.0501. AUTHORITY TO ISSUE BONDS AND OTHER 26 OBLIGATIONS. The district may issue bonds or other obligations 27

payable wholly or partly from ad valorem taxes, impact fees, 1 revenue, contract payments, grants, or other district money, or any 2 combination of those sources, to pay for any authorized district 3 4 purpose. Sec. 8084.0502. TAXES FOR BONDS. At the time the district 5 issues bonds payable wholly or partly from ad valorem taxes, the 6 7 board shall provide for the annual imposition of a continuing direct ad valorem tax, without limit as to rate or amount, while all 8 or part of the bonds are outstanding as required and in the manner 9 provided by Sections 54.601 and 54.602, Water Code. 10 11 Sec. 8084.0503. BONDS FOR ROAD PROJECTS. At the time of

12 issuance, the total principal amount of bonds or other obligations 13 issued or incurred to finance road projects and payable from ad 14 valorem taxes may not exceed one-fourth of the assessed value of the 15 real property in the district.

16 SECTION 2. The Montgomery County Municipal Utility District 17 No. 176 of Montgomery County initially includes all the territory 18 contained in the following area:

11 BEGINNING at a point whose Northing is 10,146,094.75 and whose 12 Easting is 3,827,643.55;

13 THENCE South 17°29'19" East, a distance of 718.64 feet to a 14 calculated point;

15 THENCE along a curve to the right, having a radius of 2645.09 feet, 16 a delta angle of 18°19'36", and whose long chord bears North 17 50°23'19" West, a distance of 842.45 feet to a calculated point;

21 SECTION 3. (a) The legal notice of the intention to 22 introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a 23 24 copy of this Act have been furnished to all persons, agencies, 25 officials, or entities to which they are required to be furnished 26 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 27 Government Code.

(b) The governor, one of the required recipients, has
 submitted the notice and Act to the Texas Commission on
 Environmental Quality.

4 (c) The Texas Commission on Environmental Quality has filed 5 its recommendations relating to this Act with the governor, the 6 lieutenant governor, and the speaker of the house of 7 representatives within the required time.

8 (d) All requirements of the constitution and laws of this 9 state and the rules and procedures of the legislature with respect 10 to the notice, introduction, and passage of this Act are fulfilled 11 and accomplished.

SECTION 4. (a) If this Act does not receive a two-thirds vote of all the members elected to each house, Subchapter C, Chapter 8084, Special District Local Laws Code, as added by Section 1 of this Act, is amended by adding Section 8084.0306 to read as follows: <u>Sec. 8084.0306. NO EMINENT DOMAIN POWER. The district may</u> not exercise the power of eminent domain.

(b) This section is not intended to be an expression of a
legislative interpretation of the requirements of Section 17(c),
Article I, Texas Constitution.
