L1	Sec. 8044.0102. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.
L2	(a) The district is created to serve a public purpose and benefit.
L3	(b) The district is created to accomplish the purposes of:

L5	general law and Section 59, Article XVI, Texas Constitution; and
L6	(2) Section 52, Article III, Texas Constitution, that

- Sec. 8044.0301. BONDS FOR ROAD PROJECTS. At the time of

- 20 valorem taxes may not exceed one-fourth of the assessed value of the
- 21 <u>real property in the district.</u>
- 22 SECTION 2. (a) The legal notice of the intention to
- 23 introduce this Act, setting forth the general substance of this
- 24 Act, has been published as provided by law, and the notice and a
- 25 copy of this Act have been furnished to all persons, agencies,
- 26 officials, or entities to which they are required to be furnished
- 27 under Section 59, Article XVI, Texas Constitution, and Chapter 313,

- SECTION 3. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2019.
