SECTION 2. Subchapter C, Chapter 418, Government Code, is amended by adding Sections 418.054 and 418.055 to read as follows: <u>Sec. 418.054</u>. UNMANNED AIRCRAFT STUDY GROUP. (a) In this section, "study group" means the unmanned aircraft study group established under this section.
