4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 29, Education Code, is
6	amended by adding Section 29.023 to read as follows:
7	Sec. 29.023. NOTICE OF RIGHTS. (a) The agency shall
8	develop a notice for distribution as provided by Subsection (c) and
9	posting on the agency's Internet website that indicates:
10	(1) the change made from 2016 to 2017 in reporting
11	requirements for school districts and open-enrollment charter
12	schools regarding the special education representation indicator
13	adopted in the Performance-Based Monitoring Analysis System
14	Manual; and
15	(2) in plain language, the rights of a child under both
16	federal and state law and the general process available to initiate
17	a referral of a child for a full individual and initial evaluation
18	under Section 29.004 to determine the child's eligibility for
19	special education services.
20	(b) A school district or open-enrollment charter school
21	shall include in the notice developed by the agency under
22	Subsection (a) information indicating where the local processes and
23	procedures for initiating a referral for special education services
24	eligibility evaluation may be found.

1	(c) By a date established by the commissioner, each school
2	district or open-enrollment charter school shall provide the notice
3	to the parent of each child who attends school in the district or at
4	the school at any time during the 2019-2020 school year. A school
5	district or open-enrollment charter school shall also make the
6	notice available on request to any person. The notice must be
7	available in English and Spanish, and a school district or
8	open-enrollment charter school shall make a good faith effort to
9	provide the notice in the parent's native language if the parent's
10	native language is a language other than English or Spanish.
11	(d) The notice is in addition to requirements imposed by
12	Section 26.0081.
13	(e) The commissioner may adopt rules necessary to implement
14	this section.
15	(f) This section expires September 1, 2023.

SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2019.
