H.B. No. 80

1 AN ACT
2 relating to a study and report regarding shortages in certain
3 health professions.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Subchapter C, Chapter 61, Education Code, is
6 amended by adding Section 61.06691 to read as follows:

7 Sec. 61.06691. STUDY ON SHORTAGES IN CERTAIN HEALTH
8 PROFESSIONS. (a) Subject to the availability of funds, the board
9 shall conduct a study in collaboration with the Texas Health
10 Professions Resource Center, the Texas Center for Nursing Workforce
11 Studies, and the Texas Demographic Center to identify statewide and
12 regional shortages in health professions, with an emphasis on
13 shortages in doctoral-level training in those health professions.
14 Using existing information to the extent possible, the board shall
15 develop an inventory of existing health science education programs
16 at institutions of higher education and private or independent
17 institutions of higher education and note the enrollment capacity
18 for each of those programs. The study must include an analysis of
19 shortages in the following health professions for which
20 doctoral-level training is offered:

21 (1) medicine, including a doctor of medicine degree
22 (M.D.) and a doctor of osteopathic medicine degree (D.O.);

23 (2) dentistry, including a doctor of dental surgery
24 degree (D.D.S.) and a doctor of dental medicine degree (D.M.D.);

1 (3) nursing, including a doctor of philosophy degree
2 and a doctor of nursing practice degree;

3 (4) physical therapy, including a doctor of philosophy
4 degree and a doctor of physical therapy degree;

5 (5) occupational therapy, including a doctor of
6 philosophy degree and a doctor of occupational therapy degree;

7 (6) audiology, including a doctor of philosophy degree
8 and a doctor of audiology degree;

9 (7) psychology, including a doctor of philosophy
10 degree and a doctor of psychology degree;

11 (8) pharmacy, including a doctor of philosophy degree
12 and a doctor of pharmacy degree;

13 (9) public health, including a doctor of philosophy
14 degree and a doctor of public health degree; and

15 (10) speech-language pathology, including a doctor of
16 philosophy degree and a doctor of speech-language pathology degree.

17 (b) The board shall make recommendations regarding the
18 establishment of new programs and expansion of existing programs to
19 meet the increased need for health professionals in the state,
20 including in particular the increased need for health professionals
21 with doctoral-level training who serve rural communities in this
22 state.


23 (c) Not later than December 1, 2023, the board shall submit
24 to the governor, the lieutenant governor, the speaker of the house
25 of representatives, and each legislative standing committee with
26 primary jurisdiction over higher education the results of its study
27 under this section and recommendations for legislative or other

1 action.


2 (d) The board may solicit and accept gifts, grants, and
3 donations from any public or private source to conduct the study,
4 prepare the report, and develop recommendations as required under
5 this section.

6 (e) This section expires January 1, 2024.

7 SECTION 2. This Act takes effect immediately if it receives
8 a vote of two-thirds of all the members elected to each house, as
9 provided by Section 39, Article III, Texas Constitution. If this
10 Act does not receive the vote necessary for immediate effect, this
11 Act takes effect September 1, 2019.




