4	SECTION 1. Section 247.002(1), Health and Safety Code, is

9	and shelter to four or more persons who are unrelated to the
10	proprietor of the establishment;
11	(B) provides:
12	(i) personal care services; or
13	(ii) administration of medication by a
14	person licensed or otherwise authorized in this state to administer

16	(C) may provide assistance with or supervision of
17	the administration of medication; [and]
18	(D) may provide skilled nursing services for the
19	following limited purposes:
20	(i) coordination of resident care with
21	outside home and community support services agencies and other
22	health care professionals;
23	(ii) provision or delegation of personal
24	care services and medication administration as described by this

- 2 (iii) assessment of residents to determine

- 8 defined by rule by the Texas Board of Nursing.
- 9 SECTION 2. Section 247.025, Health and Safety Code, is
- 10 amended to read as follows:
- 11 Sec. 247.025. ADOPTION OF RULES. (a) The executive
- 12 commissioner shall adopt rules necessary to implement this chapter,
- 13 including requirements for the issuance, renewal, denial,
- 14 suspension, and revocation of à license to operate an assisted
- 15 living facility.
- 16 (b) The executive commissioner shall adopt rules
- 17 distinguishing and providing guidelines on the scope of services
- 18 that an assisted living facility may provide under this chapter.
- 19 SECTION 3. As soon as practicable after the effective date
- 20 of this Act:
- 21 (1) the Texas Board of Nursing shall adopt the rules
- 22 necessary to implement Section 247.002(1), Health and Safety Code,
- 23 as amended by this Act; and
- 24 (2) the executive commissioner of the Health and Human
- 25 Services Commission shall adopt the rules required by Section
- 26 247.025, Health and Safety Code, as amended by this Act.
- 27 SECTION 4. This Act takes effect September 1, 2019.
