HOUSE CONCURRENT RESOLUTION

- 1 WHEREAS, George P. Mitchell, a Houston oil magnate and
- 2 philanthropist and one of the world's most influential energy
- 3 pioneers, is being posthumously inducted into the Petroleum Hall of
- 4 Fame on May 2, 2019; and
- 5 WHEREAS, Based at the Permian Basin Petroleum Museum in
- 6 Midland, the Petroleum Hall of Fame recognizes individuals who have
- 7 made outstanding contributions to the development of the petroleum
- 8 industry in the region; and
- 9 WHEREAS, Born in Galveston on May 21, 1919, George Mitchell
- 10 became fascinated by petroleum exploration while working one of the
- 11 many summer jobs of his youth; he went on to study petroleum
- 12 engineering and geology at Texas A&M University, where he graduated
- 13 first in his class in 1940; his training in A&M's Corps of Cadets
- 14 led to his service as a captain in the U.S. Army during World War II,
- 15 and when the war ended, he joined a newly formed wildcatting
- 16 company, Oil Drilling Inc.; after starting out as a consulting
- 17 geologist and engineer, he rose to become a partner in the firm and
- 18 was eventually named president in 1959; under his leadership, the
- 19 company grew into one of the country's largest independent oil and
- 20 gas producers; and
- 21 WHEREAS, During his career, Mr. Mitchell was involved in the
- 22 drilling of more than 10,000 wells that yielded several hundred oil
- 23 and gas discoveries; he is best remembered for his experimental and
- 24 ultimately successful efforts to employ hydraulic fracturing in the

- 1 Barnett Shale, which ushered in the shale gas revolution and
- 2 forever transformed the United States energy industry; and
- WHEREAS, Mr. Mitchell served his profession as a member of
- 4 the National Petroleum Council and, for three terms, as president
- 5 of the Texas Independent Producers and Royalty Owners Association;
- 6 he was also a director of the Gas Research Institute and a member of
- 7 the World Resources Institute Council; along the way, he strongly
- 8 supported the National Academy of Sciences in promoting
- 9 sustainability practices, and he provided endowments to further the
- 10 sustainability goals of the Houston Advanced Research Center and
- 11 other institutions; and
- WHEREAS, George P. Mitchell is recognized today as the father
- 13 of one of the most significant technological innovations of the
- 14 21st century, and his myriad achievements over the course of his
- 15 life have distinguished him among his peers and rightfully earned
- 16 him a place among the industry greats who are enshrined in the
- 17 Petroleum Hall of Fame; now, therefore, be it
- 18 RESOLVED, That the 86th Legislature of the State of Texas
- 19 hereby honor the memory of George P. Mitchell on the occasion of his
- 20 posthumous induction into the Petroleum Hall of Fame and pay
- 21 tribute to him for his remarkable life and legacy; and, be it
- 22 further
- 23 RESOLVED, That an official copy of this resolution be
- 24 prepared for Mr. Mitchell's family as an expression of high regard
- 25 by the Texas House of Representatives and Senate.
