6 (c) The department shall establish a procedure, on a license 7 holder's qualification for office as a federal or state judge as defined by Section 13.0021, Election Code [572.002, Government 8 Code], to omit the residence address of the judge and the spouse of 9 10 the judge on the license holder's license and to include, in lieu of that address, the street address of the courthouse in which the 11 license holder or license holder's spouse serves as a federal judge 12 or state judge. 13
