To the Texas Library and Historical Commission:

I have the honor to submit, in accordance with Texas Revised Civil Statutes, 1925, Article 5446, a report for the twenty-first biennium of the Texas Library and Historical Commission.

Since this report necessarily is written after the close of the biennium, it is not possible to obtain a report written by Mr. Francis H. Henshaw, who is no longer with the Texas State Library, though he served as Librarian during the whole of the 1948/1950 biennium. As a consequence, no separate report for the Librarian is submitted, but the reports of divisions will serve to cover the work of the Library for this biennium.

DIVISION OF ARCHIVES AND HISTORY

The work of making the Texas State Archives more readily available to the general public as well as to students, writers, lawyers, etc., has gone steadily forward during the biennium. The following collections of documents have been brought into chronological order: Democratic Correspondence, 1824-1872; Governors Letters including the administration of Governor Lubbock; Adjutant General's Correspondence, 1848-1900. The master rolls of rangers were arranged by companies.

Thousands of reference cards have been added to our General index, and hundreds of items of our Biographical and Historical Notes and Miscellaneous Item collections. These two collections, consisting of valuable reference material as newspaper clippings and personal informations, are in constant use. Our Musical Collection has been indexed. Because of many calls for notaries, whose names do not appear in printed lists, an index of these persons was started and about 11,000 cards completed, only a small part of the whole. A large number of Spanish translations, some in French and German have been made for other departments.

The sale of the Lamar Papers, the Journal of the Fourth and Sixth congresses and other publications of the Archives Division has been as usual.

The work of the mending division was employed chiefly by repairing the newspaper collection and documents.

Additions to the Archives by purchase are as follows: A large number of books to our Books and Rare Books collections; A Greenville Dowell Papers consisting of correspondence with George W. Littlefield, miscellaneous correspondence and scrap-books; a number of scrapbooks—pictures and text—; Letterbook of Jacob De Cordova.

The students records and correspondence of the Military Institute, Terrell, Texas, were turned over to the Archives, after the school closed.

The following gifts were received: Pattison Papers, a collection of letters and legal papers, from Representative James B. Pattison, Pattison, Texas; the Craven Bible, from Mr. R. W. Craven, 714 Henderson Street, Austin, Texas; History and Minutes of Department of Texas Spanish War Veterans 1909-1946 through courtesy of Judge G. Barcus, Austin, Texas.

During the last week of July the order was received to start packing books, newspapers and documents. By the end of August, 1950, this task (about 1200-1500 boxes on the upper floor) was accomplished.

LEGISLATION REFERENCE DIVISION

From September 1, 1948 to the convening of the Fifty-first Legislature on January 11, 1949, for its Regular Session, work was done in collecting material for anticipated requests, and also for specific requests sent in by the members of the Legislature who had been nominated in the Democratic primaries.

The legislative session lasted for 177 days, ending July 6. Its unusual length was a heavy burden on the Division, and the remaining summer months had to be spent in answering inquiries as to new laws, in cleaning up and rearranging pamphlet material, and in collecting material for several interim committees and the new Board for Texas State Hospitals and Special Schools.

Beginning September 1, 1949, the Division added a stenographer, thus freeing the Legislative Reference Librarian and Assistant of much typing and routine.

The special session of the Fifty-first Legislature was held from January 31 through March 1, 1950. Immediately following, a great deal of work was done with the Texas Legislative Council, and with such interim committees as that on the Water Code. This work continued at high pressure during the summer, placing a very heavy load on the Division staff that was handicapped by the absence on sick leave of the head of the Division during that time.

During the biennium the Division prepared several special studies, such as a history of amendments to the Texas Constitution since 1876, and issued a *Directory of Texas State Officials* on February 1, 1950 and a *List of State Executive and Legislative Agencies* on April 5, 1950.

State documents are still handled by this Division as to exchange and distribution and the list of such publications handled during the two years is attached to this report.

LOAN AND GENERAL REFERENCE DIVISION

There were increased demands on all of the services of this division during the biennium. Many requests for books and reference information were received from State officials, individuals who have no library service, families, clubs, libraries, and blind readers. 70,720 books were circulated. Of this number 33,414 circulated the first year and 37,306 the second.

The need for more adequate library service in Texas is emphasized by the letters received in the State Library from rural and small town families. Requests for books covered a wide range of subjects including information on science, the atomic age, religion, homemaking, child psychology, psychology of personality, sewing, cooking, house plans, farm buildings, house decoration, handicrafts, art, music, carpentry, engineering, mechanics, many phases of farming, gardening, radio, nature, animals, international problems, travel, biography, sports, health, recreation, history, politics, the oil industry, and on many other subjects.

A collection of the books recommended by the Education Committee of the Texas Home Demonstration Association to the members of the County Home Demonstration Clubs is maintained by the Library for circulation to the clubs that are without library service. During the biennium these clubs borrowed 5,466 books.

SERVICE FOR THE BLIND

The book collection of the State Library which serves the blind citizens of the State is supplied to the Library without cost by the Federal Government through the Library of Congress. In this Braille and recorded library are books of established merit and currently popular titles of fiction and nonfiction.

Since the production of Talking Book machines for the blind was resumed after the end of World War II, there has been a steady increase each year in the number of these machines supplied to the blind of the State. Consequently there has been a corresponding increase in the number of readers who have registered for service with the State Library. In August 1950 there were 3,619 containers of records in the Library. During the biennium these circulated 27,866 times to 858 readers. The average number of records for one Talking Book is 18. These records are contained in a single box and weigh about 12 pounds. During the second year of the biennium 15,136 containers were circulated. This is an average of 58 books a day and an average for each reader of 18 books a year or of one book borrowed every third week. For each Talking Book returned to the Library an-

other is sent automatically in exchange. Therefore, an average of 1,392 pounds of records was handled in the Library each day. An effective service to the blind must be automatic because few blind persons can communicate directly with the Library. Much physical and clerical work is involved in this kind of service. To avoid duplication in sending books, a record of all books read by each person must be kept and checked before a book is sent. Also careful consideration is given to the selection of books for each reader. The physical work involved in the handling of the records is difficult because of crowded working quarters and inconvenient and inadequate shelving space.

The popularity of the Talking Books has caused a marked decrease in the use of Braille books, which are read by the sense of touch. However, during the biennium 110 persons read 4,490 volumes of Braille. The Braille books are located in the storage annex about three miles from the Capitol. The handling of these books is complicated by the necessity of carrying them to and from the Capitol and the annex.

EXTENSION DIVISION

The Extension Division, consisting of Director and part-time clerical assistance, carried on the usual work, though in even more than usual limited way, during the biennium beginning September 1, 1948, ending August 31, 1950. The Division was without a Director for part of the biennium, from September, 1949, through February, 1950, because the position had been eliminated by the Legislature when the request for funds for the Division was denied. The position was restored by the Special Session in February, 1950. During that six-month interval, field work and desk work were curtailed, a limited amount carried on by the State Librarian or some member of the Library staff. Correspondence was handled, reports received, conferences with librarians carried on in the State Library. Publication of the Division's periodical, Texas Libraries, was suspended, other usual activities not initiated.

Conferences were held with officers and members of these organizations, committee and program assignments were accepted and carried out, talks were made, book lists prepared, displays of books arranged, and loans of books for special reading programs negotiated.

As usual, annual and special reports were requested, received, and cared for, from public libraries.

Lists were made, by the Extension Director, of all public libraries and their head librarians, and such lists widely distributed.

Card files were reorganized and kept up to date, of all towns, cities, and counties having libraries or showing desire for help in establishing libraries.

Files were prepared, in cooperation with Texas Library Association's District Planning Committee, listing every librarian working in a Texas library, with much-needed information about the person and the position.

Newsletters were prepared and sent out frequently, to heads of public libraries, as a regular and more personal substitute for the suspended *Texas Libraries*.

An informal placement file was kept, to assist librarians find positions or to fill vacancies on their staffs.

During the biennium some progress was noted in public libraries in many parts of the state. With few exceptions library budgets increased, book collections grew, salaries showed small increases, public interest was high in many communities. New buildings were planned and built in Andrews, Alpine, Burnet, Denton, Goldthwaite, Columbus, Mexia, McAllen, Richmond, and Anahuac, in many cases after some consultation with the Extension Division. In a few cases the Director was present at opening ceremonies and had parts in some of them. A few more trained librarians are employed in Texas public libraries, with some credit due to the new Library School in The University of Texas, and with continued activity in the older library schools or departments.

Needs remain great, for more trained librarians, for increased appropriations for all city and county libraries, for more formal and informal cooperation between neighboring librarians, for larger units of service there, and in the areas not covered by libraries but seeking book outlets. More professional contacts are needed through the Extension Division, with librarians and groups of citizens asking for assistance.

The Director needs to stay longer in a library or a community when she can visit it, and give extended advice and assistance as needs indicate. She sees lack of training on many librarians' parts, and among the assistants, and realizes that many of these fine workers can not attend the regular library schools. She believes that a number of widely scattered workshops or institutes are needed, and would be gladly attended by many people. The Director believes that collections of books should be made, for loan to small or to new libraries, particularly books in the professional field. In these and other ways, the public librarians can be helped to help themselves and to combine to bring Texas library development a step nearer our goals.

PROCESSING DIVISION

This Division has charge of processing the books, beginning with the typing of book orders, and continuing by receiving the incoming books, checking these with the bills, accessioning, classifying and cataloging, typing catalog cards, pocketing, stamping, marking, and finally sending the completed books to the shelves of the several divisions of the library for circulation.

An important phase of the library work carried on here is the preparation of Texas state documents and other Texas material for binding. Unremitting effort is made to get copies of all current Texas state documents not received by the library as specified under the law. This is frequently difficult, as some departments type, mimeograph or lithograph their publications and are not required by law to send copies to the State Library. Many of the files of departmental documents have skips in them, particularly for early years. A constant search is being made for these. Missing Texas documents are obtained from numerous sources, many times from other states which have duplicates or copies no longer needed. Two copies of all state documents are bound for permanent use. Much valuable material besides state publications is collected here, which when bound and cataloged is sent to the Archives Division. This consists mainly of publications of industries—oil, cattle, agriculture, manufacturing—special editions of Texas newspapers and other historical material. These give useful information on the resources and development of the state, as well as much of its history. The assistant who have been in charge of this work for several years, has done excellent work by filling in breaks in the files of Texas state documents and in collecting other valuable Texas publications.

The United States documents and documents from states other than Texas are taken care of in this Division. These are classified and cataloged. The United States documents are shelved in a section to themselves. The government documents, both federal and state, form a veritable storehouse of valuable information. During the past biennium, this source has been drawn on extensively by the Attorney General's Office, particularly in regard to the Submerged Land hearings, the Legislative Council, oil interest, state departments, students, and others.

Another part of the work is the preparation of books for the bindery and the pamphlet binding of material. The binding of Texas newspapers and of certain other periodicals was discontinued in 1946, as these are obtained on microfilm or microcards. No newspapers were kept after the microfilms were received from August, 1945 to October, 1950, except the *Dallas Morning News*. All newspapers are now put in order each month and boxed so that they are easily accessible. Much material that does not have hard usage or the nature of which does not justify permanent binding is pamphlet bound. The mending of books and other material is done in this Division.

During the biennium there were cataloged 9,178 volumes, and 14,412 cards were added to the catalog. United States government documents not included in the above figures were cataloged and analyzed as follows: Pamphlets 5,996, periodicals

132, serials 46, maps 1,415, total 7,589. Hundreds of maps from the United States Army Map Service, War Department, have continued to be received but not cataloged. The library has received on exchange from other states 2,174 documents, of which 1,325 were added to the catalog and 849 transferred to The University of Texas and Prairie View A. and M. College. Gifts received totaled 486 items, other than state documents received on exchange numbered 122; and official Texas documents received on deposit, which were accessioned for cataloging, numbered 491. Binding was done as follows: Books 206, magazines 282, Texas state documents 581. Four hundred thirty-nine books (1,253 volumes in Braille, and 430 recorded "talking books" for the blind were received and briefly cataloged. During the first year of the biennium 4,189 books were withdrawn. A total of 6,180 volumes were accessioned.

APPENDIX F

STATE BOARD OF LIBRARY EXAMINERS 1948-1950

Following the methods of issuance of county librarian's certificates as provided at the January 1947 meeting, the Chairman and Secretary have issued and renewed the types of certificates, calling for votes by all members of the Board only when an application disclosed failure of applicant to hold the prescribed qualifications.

No meeting was held in 1948, but in November 1949, a meeting was held in Fort Worth, at which Miss Wells was re-elected for a term ending in 1953.

At this meeting a resolution was adopted to extend all temporary certificates for another year—until December 31, 1950.
