# INTRODUCTION

In 1995, Texas public transportation operators provided nearly 245 million one-way passenger trips to Texans and state visitors. This feat was accomplished by the state's 29 urbanized transit systems, 42 nonurbanized transit systems and more than 250 nonprofit agencies operating vehicles for the transportation of the elderly and disabled. This impressive array of services provides extensive transportation options for many Texans, but still leaves 22 percent of the state's urbanized areas and 3 percent of the state's counties without scheduled public transportation services.

Residents in seven of the state's major urbanized areas have approved a sales tax dedicated to the local financing of public transportation services, totaling more than a billion dollars in 1995. These figures show an increasing awareness and commitment by Texans that public transportation is an important element in the mobility of Texans.

This report is published on an annual basis and is based on data compiled from reports completed by public transportation providers which receive assistance through the Texas Department of Transportation and/or the Federal Transit Administration.

The Federal Transit Act has been codified in the U.S. Code. Federal agencies have adopted a new series of numbers to describe transit programs. The following table displays this information. Beginning with this issue of the Texas Transit Statistics, the U.S. Code numbers will be used.




FIGURE 1

# **URBANIZED TRANSIT SYSTEMS**



## **SUMMARY**

### **Urbanized Transit Systems**

In 1995 more than 236.1 million one-way passengers were carried by Texas urbanized public transit systems. This is a 2.1 percent decrease from the 241.2 million passengers carried in 1994. The decline in ridership across the state has contributed to a fare increase for most systems.

Total vehicle miles decreased about 1.0 percent to 170.8 million miles in 1995 as compared to 171.6 million miles in 1994.

Operating costs for the urbanized transit systems rose a modest 4.4 percent from \$558.4 million in 1994 to \$583.2 million in 1995. Total public expense includes net operating costs of \$428.6 million and capital costs of \$167.1 million for 1995.







Calendar Year 1995**






### **Nonurbanized Transit Systems**

Urban Texans aren't the only ones riding public transportation. During calendar year 1995, \*41 rural transportation agencies provided over four million one-way passenger trips. The agencies maintained and operated more than 900 vehicles. Those vehicles traveled over 19.6 million miles, carrying 7.1 percent more passengers than they did during 1994. Total operating expenses of these nonurbanized systems increased from \$25.4 million in 1994 to \$27.6 million in 1995.

**NOTE:** A 42nd system, El Paso, was under contract in 1995 but had no vehicles in service.





## **SUMMARY**

### **Elderly and Disabled Transportation Services Provided by Nonprofit Entities**

Calendar year 1995 saw across-the-board increases for transportation services for the elderly and disabled. During this year, over four million one-way passenger trips were provided by nonprofit entities operating vehicles purchased through the Federal Transit Administration's Section 5310 program. The number of vehicles maintained and operated by such entities jumped from 983 in 1994 to 1,123 in 1995. These vehicles were driven over 15 million miles in 1995, compared to 13 million in 1994. The nonprofit entities responsible for these vehicles spent over \$13.0 million in 1995 providing transportation services for elderly and disabled Texans.


