





An eighth generation Texas farmer and rancher, Sid Miller is the 12th Commissioner of the Texas Department of Agriculture. He has devoted his life to promoting Texas agriculture and rural communities.

Since taking office in January 2015, Commissioner Miller has brought real, common sense reform to the Texas Department of Agriculture. He increased consumer protection in everything from fuel pumps to commercial scales to organic certifications. A former ag teacher and school board member, Commissioner Miller has also led the fight against childhood obesity through nutrition programs for Texas schoolchildren, including Farm Fresh Fridays and other farm-to-school initiatives.

Commissioner Miller is the state's leading advocate around the world for Texas agriculture. He and his staff have visited every continent on the globe representing Texas agriculture and the GO TEXAN marketing program. Commissioner Miller is on a mission to spread the word about Texas' world-renowned agriculture industry and showcase the best Texas has to offer to the world.

Commissioner Miller breeds and trains American Quarter Horses and is a recognized rodeo cowboy with nine world championship titles.

Miller and his wife, Debra, have been married for more than 40 years. They have two sons, two daughters-in-law and four grandchildren.




### **BOB TALLMAN**

Bob Tallman is known far and wide for his voice. He uses it to entertain and educate people about rodeo and the Western lifestyle at rodeos across North America and through his agricultural endeavors.

Bob was born and raised in Nevada, lived in California, Montana and Oregon, and while all those places have a special place in his heart, he is now proud to call Texas home. He and his wife, Kristen, live west of Poolville in Parker County where they raise registered Angus cattle and all-natural beef.

Bob has received numerous awards and been inducted into nearly every hall of fame that involves rodeo and being a cowboy. However, all the awards and accolades are not nearly as important as his faith, his family and his friends. He loves children and headlines several fundraisers each year for charities.

Bob is a proud American who is busy with business endeavors day-in and day-out. No matter what, he always makes time for God, family and friends, because in his opinion, "That's the cowboy way."



### RED STEAGALL

For more than 40 years, Red Steagall has entertained people around the globe as a recording artist, songwriter, television and motion picture personality, and cowboy poet.

In 1991, the Texas Legislature named Red the Official Cowboy Poet of Texas. By 1994, he launched his one-hour syndicated radio show, "Cowboy Corner," which is now heard in approximately 165 markets across 43 states.

Musically, Red has won eight Wrangler Awards from the National Cowboy and Western Heritage Museum in Oklahoma City. He has also authored four books.

In recognition of Red's significant contribution to the western way of life, he was inducted into the Texas Trail of Fame in October 1999. In 2003, he joined the National Cowboy, and Western Heritage Museum's Hall of Great Westerners. A year later, Red was inducted into the Texas Cowboy Hall of Fame.

In 2006, Red was awarded the prestigious Charles Goodnight Award and also was named the Poet Laureate for the State of Texas.

Red's television show, "In the Bunkhouse with Red Steagall," first aired in 2009. His current show, "Red Steagall is Somewhere West of Wall Street," airs nationwide on RFD-TV.



### HALM RANCH

### COMAL COUNTY

17 miles north of New Braunfels in Sattler

FOUNDED: 1865

FOUNDER: Friedric Pantermuehl CURRENT OWNERS: Barney S. Halm, Leslie R. Halm and Phyllis (Halm) Jones Friedric Pantermuehl and his family sailed to America from Germany in 1850 and landed in Indianola, Texas. He would travel to Comal County near the Guadalupe River. In 1865, Friedric bought 480 acres, and he continued acquiring more land where he raised cotton, corn, oats, cattle and horses.

Friedric and his wife, Ernestine, had five children: Carl, Robert, Heinrich, Hugo and Pauline. Robert acquired a separate 160 acres of land from the State of Texas Survey No. 952 in 1890, and in 1907, Robert inherited 968 acres.

Pauline married Hugo Halm, and they had five children: Arthur, Lydia, Erna, Robert "Bob" and Walter. Hugo purchased 1,128 acres from his brother-in-law, Robert, in 1916 and continued to add acreage. Walter would later purchase the land from his father in 1955. Walter and his wife, Verde Lee, raised four children: Barney, Joe, Leslie and Phyllis.

Barney and his wife, Sharon, have three children: Monica, Melissa and Matthew. Leslie and his wife, Barbara, have two children, Josephine and Jessica. Phyllis and her husband, Joseph, have two children, Kevin and Paula.


Barney, Leslie and Phyllis inherited the land in 2000, and today, they raise cattle and hay.

FOUNDED: 1867

FOUNDER: Paul Arnold

**CURRENT OWNER: Clemens F. Waskow** 

Paul Arnold immigrated from Alsace, France, to DeWitt County in 1867. Paul and his wife, Mary, had four children. Their son, Joseph Blaise (JB), purchased his three siblings' shares of the land in 1913. JB and his wife, Ella, had one child, Claude. Together, JB and Claude worked the land until JB's death in 1956.

Claude continued to work and improve upon the land. He married Mildred, and they had four children. Their daughter, Doris, married Clemens F. Waskow in 1964, and they had three daughters: Valerie, Gayle and Grace. Claude passed away in 1985, and in 1987, Doris inherited 286 acres from her father's estate.

Together, Clemens and Doris continue to maintain and improve the land, including purchasing Brahman cattle and Hereford bulls to raise and crossbreed. Doris passed away in 2008, and her family has continued to farm and ranch the land, just as she requested.

William Walker Sorell purchased this land in March 1867; it was an undivided half interest in 400 acres. William and his wife, Lucy Ann, had 13 children. They raised cotton and sugar cane on the land. In 1889, William's son, Thomas, acquired the land. Thomas and his wife, Susan, had one child, Cecil.

Cecil and his wife, Bessie, had one child, Kathleen, who was born in 1915. Before Kathleen was two years old, Cecil was involved in an accident in which he was thrown from a horse. He passed away a few months later in San Antonio.

Kathleen and her husband, Bruce, helped Bessie manage the ranch.

After Kathleen's passing, the land was left to her two daughters, Susan and Sally. Susan's daughter, Tracee, lives on the land with her husband, Kyle, and son, Cooper.

FOUNDERS: Reuben and Rhoda Billings Brown

CURRENT OWNER: Travis W. Brown

Rueben Brown bought 320 acres in the Arch McMillan survey from Edward Linn in 1855. In 1856, Rueben sold 143 acres to his son-in-law, Aaron Watts. Rueben ran cattle and farmed the land. His first wife passed away, and he later remarried. Among his children, he had a son, Rueben Jr., who acquired title to the land in 1895.

Rueben Jr. ran cattle on the land. He passed away, and the land was given to his son, Samuel Travis Brown. When Samuel passed away in 2000, his son, Travis, inherited the land and continues to run cattle on it.

### ABOUT THE TEXAS AGRICULTURE MEMORIAL DAY

Last year, by state proclamation, November 21 was named Texas Agriculture Memorial Day. It is a day to remember the lives and honor the sacrifices of our farmers and ranchers who produce the food and fiber for Texas families.

Each year, applications will be accepted to nominate honorees to the agriculture memorial through three categories: memorial, honor and memorial service.

The memorial category honors men and women who have lost their lives while engaged in agricultural-related pursuits such as working livestock, transporting agricultural goods or operating machinery.

The honor category recognizes those who

have had a severe debilitating accident while engaged in agricultural-related pursuits.

Those who passed away due to natural causes or in a non-agricultural accident but had an active role in an agricultural operation will be honored in the memorial service category.

Future plans include an interactive kiosk in the Agricultural Museum in the Texas State Capitol. The kiosk will allow visitors to search for honorees, read about their contributions to Texas agriculture, as well as nominate a new honoree. The kiosk will also include accident prevention and safety education provided by The Southwest Center for Agricultural Health, Injury Prevention, and Education at the University of Texas in Tyler.

### STAFFORD'S MEADOW FARM

FOUNDED: 1889

FOUNDER: Uriah Monroe Stafford CURRENT OWNER: Slattery Family

Uriah Monroe Stafford was born in 1841 and was the youngest of seven children. In 1874, Uriah married Margaret Anna Seaglar and they had six children together, three of whom lived.

Seymour Seagler Stafford, along with his two siblings, inherited the farm. Seymour later bought his siblings' shares. Seymour opened a Buick dealership in Palestine in 1920, while he continued to tend to the farm.

By the 1960s, Seymour's operations expanded from hay to cattle. In 1968, his daughter, Elisabeth Stafford Hutchinson, inherited the farm. In 2012, Ann H. Slattery inherited the Stafford's Meadow Farm and lives on the land today.



CURRENT OWNERS: Robbie Ray Gage Prideaux, Nancy Jane Gage Allen, Billie Marie Gage and Mary Beth Gage Simpson Monteville Ray came to Bell County, Texas, from Tennessee in a covered wagon. In 1892, Mont married May Ranne, a descendant of Stephen F. Austin's "Old 300 Colony."

In 1917, the couple purchased 741 acres and eventually moved their eight children to the ranch. In 1938, May passed away, and Mont sold the farm to his son Wayne Ray.

Wayne and his wife, Flossye, successfully ran stocker yearlings for more than 40 years, while accumulating adjoining acreage. Wayne's daughter, Robbie Gage,

took over the land in 2001. At age 89, she continues sustainable agricultural practices.

Edward Dow (Edd) Harrell, Ealong with his wife, Samuella (Sammie) Barks Harrell, and his son, Newton Samuel Harrell, bought 34,775 acres of land from the JA Ranch in 1917. Edd and Sammie worked their cattle operation together until Edd turned over the operation to Newton after his college graduation.

Newton married Helen Croson in 1924, and the couple had two children, Shirley and Edward (Ed) Charles. Ed eventually joined Newton on the ranch and took over operations in 1991 after Newton's passing.

Ed married Carol Flynn in 1957 and they had three children, the youngest of whom was Samuel Edward. Later, Sammie incorporated her portion of the ranch into the "Home Camp Company," and she gave shares to Ed, Carol and their three children.

Samuel and his wife, Mary, had two daughters, Helen Grace and Samantha Faith. In 2005, Samuel took over operations, and he continues to ranch and farm the land today.



Edward Discher immigrated to America from Germany in the late 1800s. He met and married Martha Broeker Discher in the early 1900s, and they had one daughter, Adele Discher Haar. In September 1915, the Dischers purchased 69 acres of property in Austin County from Fritz Glaser. They raised cotton, corn, hay, tobacco and livestock.

Adele met and married Frtiz W. Haar in 1929 and had one daughter, Dorothy. After the death of her parents, Adele inherited her family's property and raised cattle and feed products. In 1962, Fritz and Adele bought an additional property nearby. Dorothy and her husband, Albert Tesch Jr., acquired the title to this property in 1971 and built a home on it to be closer to her parents. Dorothy

and Albert had two children, Brenda Tesch Dunn Goggans and Troy A. Tesch.

Dorothy still lives on the property today, and her son, Troy, has taken over the cattle operation.

Edmund Ashorn married Emma Findeisen and bought the land that is known as Ashorn Farm in 1910. Together with their five children, the Ashorn family added on to their property in 1915, increasing the acreage to 381 acres.

Edmund always strived to improve his knowledge of farming as a business and pursued adult education classes. He instilled a love of learning and farming into his children. His youngest daughter, Lillian Ashorn Wilhelm, inherited parts of the farm and bought the remainder of the land from her siblings. Lillian still lovingly owns and manages the Ashorn Farm today.

Cenek Marek and Theresa immigrated to the United States from Czechoslovakia in 1860. Ladislav Ludwig Marek, a descendent of Cenek Marek, purchased 147.5 acres of land with his wife, Mary, in 1910. They had 10 children and raised cattle and crops.

Ladislav passed away in 1914, leaving the land to Mary and their nine surviving children: V.L., Mary, Annie, Olga, Martha, Ludie, Ben, Nora and Rubie. Ben bought his mother's and siblings' interests in the land in 1938. Ben and his wife, Mary, raised two sons, Ben Darold and Harold Gene, on this land.

Ben Darold and his wife, Joyce, have three daughters: Marie, Linda and Nancy. Harold Gene, and his wife, Carmon, have two sons, Harold Jr. and James Thomas. The families continue to live on the land and raise cattle.

FOUNDED: 1908

FOUNDERS: Simon and Marie Bartos CURRENT OWNERS: Carolyn Marie Bartos Waterfield, Bobbie Faye Bartos Loving and Melanie Gayle Bartos Gooch Simon and Marie Bartos immigrated to Texas from Czechoslovakia and married in 1890. In 1908, the couple purchased 128.75 acres in Baylor County and moved there with their ten children. Milton Bartos was the first of two sons to be born on the land.

In 1916, Simon and Marie bought an additional 101.13 adjacent acres. On the land, they built a home, grew crops and tended to livestock. They even raised hens that were "Baba's grocery money."

In 1969, Faye and Milton Bartos bought the 229.88 acres to combine with 207 acres they had purchased in 1949. Milton farmed and ranched on the land until his death in 2000. Milton's children, Carolyn, Bobbie and Melanie, inherited the farm and

ranch. Today, Three B Farm and Ranch is managed by Bobbie, her husband, Dean Loving, and their son, Tommy.



James Clinton Dorward was born in Burleson County in 1875. In 1904, James married Hattie Crossett Dorward, and the couple had two daughters, Ophelia and Estine.

In 1951, James passed away and Hattie conveyed sections of the land to Ophelia over the following years. In 1967, Ophelia conveyed her interest to Clinta Barbara Blackard Williams. The land is currently owned by the Ophelia Blackard Trust and the Clinta B. Williams Revocable Trust.

In 1913, C.W. George bought 100 acres from E.W. Crenshaw in Brazos County. This purchase the George/Davidson/ began Patranella family ownership of the Davidson Ranch.

In 1921, Robert Lee Davidson, nephew of C.W., purchased the acreage and moved his family there. The Davidson family raised cattle, cotton and corn on the land. Later, Robert ran a cow-calf operation.

Robert and his wife, Emma, had five children: Mary Ruth, Agnes, Marjorie, Edgar and Robert Duard. After Robert passed in 1976, his heirs continued to farm the land.

Later the land was divided between Mary Ruth and Marjorie. Mary Ruth's son, Mark, also helps her tend to the land and maintain the property. The family is committed to keeping the land for generations to come.

ay William Harris (J.W.) was born on January 2, 1871 in Upshur County, Texas. His family moved to Brazos County the same year and settled on a farm that was across the road from the land that J.W. would purchase 38 years later.

In 1908, J.W. and his wife, Lucy Sample Harris, moved to Young County and rented a farm. However, the couple missed living in Brazos County and decided to buy 121 acres of land. by mail from W.G. Reynolds in 1909. J.W. and Lucy had eight children: Edna, Victor, Dua, Guy, Norman, Winnie, Henry and Mary Frances. The family was involved with daily farm chores and attended Harris School, which was located on the farm.

Mary Frances Harris Robert, the youngest child, and her husband, Walter Lee Robert, acquired the land in 1961 after the death of J.W. and Lucy. 



Three days after their wedding in 1892, W.J. and Laura Morton left Tennessee for Texas by train. They first settled in Greer County, which would later become the town of Hollis, Oklahoma. Looking for greener pastures, W.J. traveled to the Texas Panhandle with a friend. It was there that he acquired land in eastern Moore County.

In March 1902, W.J. and Laura moved their family, livestock and household goods by wagon to Texas. In 1943, W.J. and Laura passed their land down equally to their six children. The land would be traded amongst the children until W.J. Morton Ir. and his wife, Willie, retained ownership of the original homeplace. W.J. Jr. and Willie had three children: Jim Ed, Genevieve and Harold Dean.

Kathy and Willy. The land is used to raise cattle and goats, as well as for hunting.

As of January 2017, Carl operates the Vinegarroon Ranch Company with his great-grandchildren: Makenzie, Roy, Kallan, Daphne and Gus.




Marvin Sr. farmed the land, raising wheat and milo, and later, cattle. He currently still lives on the homestead.

Clarence Clifton "Cliff" Bushong was born in 1885 in the Mary Meade Community of Kerr County, Texas. At age 10, he started working on local farms to help support his family. Cliff would later work as a ranch hand and save his money to purchase a place of his own, which he did in 1917 when he bought 800 acres on Cypress Creek.

Cliff married Jewett Mear, and they moved to the ranch on their wedding day. They had two children, Lucille and Luther, who were both born on the ranch. In 1930, they added 640 acres to the ranch.

When Luther graduated high school in 1946, he began working full-time on the ranch. In 1954, he acquired title to the land and became a partner with his parents. In 1956, Luther married Lois, and they had one daughter, Martha.

At 88 years old, Luther is still actively involved in the day-to-day operations of the ranch. His nephew, Jesse C. Luxton, and his wife, Betty, lease part of the land for their cattle operation. Martha and her husband, William, moved to the ranch in 2014 and also help with operations.

Shelia and her husband, Jack, took over management of the ranch in 1978, and they continue operations today. They have three sons: John, Monte and George Thomas.



J.L. Vineyard was born in Georgia and traveled to Texas with his young family. They settled in Scurry County in 1903. In 1916, J.L. acquired 200 acres from the estate of W M Prescott. J.L. farmed the land with his brother, I.M., and two eldest sons, M.C. and L.E., until 1926. After this time, his youngest son, Bishop, became the sole tenant of the land.

Bishop was married in 1927 and moved to the farm in 1928, where he lived as a tenant until he acquired ownership of the land in 1942.

Bishop and his wife, Dovie, raised three children on the farm: Douglas, Nelda and Don. Each of the children inherited 1/6 interest of the land when Bishop passed away in 1978. Dovie would retain control and management of the 200 acres during this time. Eventually,

in 1988, Dovie gifted her share of the land equally to her children.

Upon Douglas' passing in 1999, his interest was given to his children and ultimately gifted to J.L.'s great-great-grandson, Cody. Nelda gifted her portion of the land to J.L.'s great-grandson, Michael. Don is still the owner and operator of his share of the land.

Mary Elizabeth Moore was born in 1829 in Alabama. She traveled to Texas with her family, and acquired 137 and ¾ acres of land from a patent issued to her by the State of Texas. She put down roots on this land and raised her family here. She raised mostly corn and garden items to feed her family, along with raising cattle.

Mary Elizabeth passed the land to her daughter, Martha Ann, and husband, James Robert Ingram, in 1922. Their son, John Edgar "J.E.," and his wife, Lillie, continued the family traditions on the land. J.E. was the first in his family to receive a college degree when he graduated from Sam Houston State Teacher's College in 1916.

J.E. and Lillie had a daughter, Elaine, who inherited the land in 1958. They also deeded land to Elaine's sons, Wayne and John. Elaine continued to love the land and cattle, as did her predecessors. Elaine also deeded property to her daughter, Denise. The family has always valued the importance of land conservation and continued to improve upon their land.

Dave Young arrived in the United States via a slave ship to Virginia. Records show he moved to Oklahoma as a freed slave. When Dave moved to the community of Prairie Creek, Texas, he had the opportunity to purchase land. Originally covered in timber, the land would be cleared by hand, and crops were grown to provide food for Dave's family.

After Dave's passing, his son, Phillip, became caretaker of the land. Phillip added sugar cane with a syrup mill and timber production to the family's operation. Phillip's son, Lewis, became caretaker of the land after Phillip's passing. While what is grown on the land has changed, the mainstay of corn and cattle continue to exist on the

property. Today, Lewis continues to oversee the land with help from his siblings and their children.

The Dave Young Estate has been in existence for 116 years, and the family is determined to keep the property in the family for generations to come.

Lawrence Mangan was born in Ireland in 1840. At age six, he traveled to America with his family, settling in Ohio. Lawrence moved to Tennessee and then later to Texas with his wife, Mary Jane. In 1885, Lawrence purchased 200 acres of land in southwest Van Zandt County.

Until his death in 1906, Lawrence farmed the land, which he would leave to his children. His son, John Lawrence, and wife, Oda, owned and continued to farm approximately 130 acres of the land. John Lawrence passed away in 1949. His son, Clarence, inherited a portion of the land after his father's passing.

Clarence operated a diary, and he and his wife, Thelma, lived on the farm until their deaths in 1983.

Their two daughters, Virginia Ruth and Betty Jo, inherited the land. Virginia continued to operate the farm with her sons, Paul and Perry. In 2000, Paul and Perry were deeded 59.75 acres. They continued to operate the land and purchased back portions of the original tract that had been lost over the years.

The seventh generation of the family lives on the farm today.

In 1948, Louise acquired the property after Henry's passing, and with the help of her children, continued operations. She raised livestock, cotton and corn. William Henze Sr. was born in Bergwitz, Germany, in 1855. His sisters had already settled in America, so William, along with his wife, Auguste and their children immigrated to America. William purchased several farms after arriving in Texas, amassing more than 1,000 acres. In 1900, he purchased the 110 acres now known as the Krieg Ranch.

William and Auguste lived on the farm until 1920, when they decided to let their son, Herman and his wife, Elfrieda, live there. Shortly after, Auguste passed away.

In 1931, he deeded the 110 acres to William Jr., Fritz, Herman, and Otto's children: Robert, Ozell and Carl. In 1936, Herman sold his interest in the land back to his family. In 1941, William Sr. passed away, leaving his one-fourth interest in the land to Herman. Shortly after, in 1949, William Jr. died of a heart attack. Between July and November 1949, Fritz and his wife, Lena, would purchase 100 percent interest in the family's 110 acres. They had three

children: Lydia, Walter and Frances.

In 1970, Fritz passed away, and his estate was left to Lena. In 1973, Lena gave each of her children a farm, with the 110 acres going to her daughter, Lydia. She rented the farm to her nephew, Glenn, who was already living on the land with his wife, Cindy, and their children, Kevin and Lisa. Eventually, in 1976, Lydia sold the land to Glenn and Cindy. They would build their home and raise their family on this land.


