







#### **COMMISSIONER SID MILLER**

Sid Miller is serving as the 12th Texas Commissioner of Agriculture, with his first term beginning in January 2015. Commissioner Miller brings a wealth of knowledge to the Texas Department of Agriculture. He is recognized as one of the state's most dynamic and effective conservative leaders, as well as one of the state's staunchest defenders of constitutional freedoms.

During his six terms as a member of the Texas House of Representatives, Commissioner Miller brought his real world agricultural experience to the table. He's your everyday man who's made a difference in his community and for the Lone Star State by working as a small businessman, community leader, school teacher, agriculturist and former school board member. In every aspect of his work, Commissioner Miller has proven his convictions in being pro-business and pro-job creation.



Commissioner Miller was born in De Leon, Texas, and is an avid rodeo and horseshow participant who holds nine World Championships. He is a graduate of Tarleton State University in Stephenville, where he received a Bachelor of Science in Vocational Agriculture Education. #### JIM SPENCER

Jim Spencer is an award-winning weathercaster for KXAN in Austin. He joined KXAN in 1990 and became the first weathercaster on Austin's first hour-long morning newscast. In 1993, Jim became chief weathercaster and took over the evening broadcasts. Jim has been forecasting weather on KXAN for 25 years.

Jim grew up in Lindsay, Oklahoma, in the heart of tornado alley, to which he credits his life-long fascination with weather.

He began his broadcasting career at East Central University in Ada, Oklahoma. Jim spent two years at KADA-AM Radio before moving into television at Ada's KTEN-TV in 1983. He became chief weathercaster at KTEN upon graduating college and remained there until joining KXAN.



Jim has received numerous accolades and national recognition for his work. He is a past recipient of the National Weather Association's Weathercaster of the Year award. Jim is a five-time winner of the Texas Associated Press Best Weathercast award, and he has been voted Austin's Best Weathercaster by readers of the Austin Chronicle for 16 years. He has been named TV Personality of the Year by Austin's American Women in Radio and Television Chapter four times.


In addition to forecasting the weather, Jim has a long history of involvement in community and charitable organizations. Jim also lends his time to teaching hundreds of school children about severe weather safety every year. Football officiating is another of Jim's passions, and he has officiated high school football for 31 years.

#### RED STEAGALL

For more than 40 years, Red Steagall has entertained around the globe as a recording artist, songwriter, television and motion picture personality, and cowboy poet.

In 1991, the Texas Legislature named Red the Official Cowboy Poet of Texas. By 1994, he launched his one-hour syndicated radio show, "Cowboy Corner," which is now heard in approximately 165 markets across 43 states.

Musically, Red has won eight Wrangler Awards from the National Cowboy and Western Heritage Museum in Oklahoma City. As a writer, he has authored four books.



In recognition of Red's significant contribution to the western way of life, he was inducted into The Texas Trail Of Fame in October 1999. In 2003, he joined the National Cowboy and Western Heritage Museum's Hall of Great Westerners. A year later, Red was inducted into the Texas Cowboy Hall of Fame.

In 2006, Red was awarded the prestigious Charles Goodnight Award and also was named The Poet Laureate for the State of Texas.

Red's television show, "In the Bunkhouse with Red Steagall," first aired in 2009 and is currently in its sixth year of production.

#### CONSTANT CREEK RANCH

**AUSTIN COUNTY - SEVEN MILES SOUTH OF BELLVILLE** 

FOUNDED IN: 1865

FOUNDERS: AUGUST AND HELENE GOEBEL

CURRENT OWNERS: VICKIE AND J. FRANK MONK

Current owners Frank and Vickie Monk have a daughter, Kyndal, who was born in 1985 and raised on the ranch. She grew up attending horse events and participating in youth rodeo activities. Kyndal also showed pigs and horses at the county fair through 4-H.



Frank and Vickie continue working the land and have become involved in restoring grasses. They have continued to acquire land and currently own 783 acres. They built a new home in 2000 and still use an old shed that is more than 100 years old.

#### **BRAUTIGAM FARM**

MONTGOMERY COUNTY - 40 MILES NORTHWEST OF HOUSTON

FOUNDED IN: 1862

FOUNDER: CHRISTOPH BRAUTIGAM

CURRENT OWNERS: JOHN BRAUTIGAM AND SANDRA KAY

BRAUTIGAM

Christoph Brautigam arrived in Texas from Germany on Christmas Day 1856. In 1862, he staked his claim to 190 acres and began operations. He married Martha Peters and they had four children Levies. Coorgan Friedman

married Martha Peters, and they had four children: Louisa, George, Friedrick and Maria.



Friedrick acquired land from his father in 1867. He became a naturalized American citizen after serving in the Civil War. With his first wife, Martha Eghling, he had two children, Maria and Friedrick Jr.

Friedrick Jr. acquired land from his father around 1906. Friedrick Jr. married Ida Hirsch, and they had six children: Martha, Edward, Lydia, Alma, Ida and Walter. Edward inherited portions of the land in 1948 and 1970. He married Cecilia Chunda, and they had three children: Edward Jr., Walter and Cecilia.

Walter, who goes by John, inherited a portion of the land in 1979. In 2005, his daughter, Sandra Kay Brautigam, purchased five acres from him. She lives in the original house and continues operations.

## BUTLER RANCH SMITH COUNTY - 12 MILES NORTHEAST OF TYLER FOUNDED IN: 1854

FOUNDERS: WILLIAM BOOKER AND ELIZABETH BUTLER CURRENT OWNER: MICHELLE FLOWERS DIAL

In 1854, William Booker Butler left Alabama for a better life in Texas. He heard about a Texas town where a new log courthouse stood on the square. That town was Tyler. Booker moved with several slaves to Starrville, east of Tyler, where he purchased land. With the help of the men, he built the antebellum-style home. Upon its completion, Booker's wife, Elizabeth, and their seven children made the journey to their new home.



Robert Henry Clay, their youngest son, acquired the land in 1884. Robert and his wife, Lila, lived there until his death in 1933. Lila eventually began selling land, and their grandson, Jack, bought 100 acres from her in 1947.

Jack passed away in 2001, and the land was left to his granddaughter, Michelle Dial. Michelle, along with her husband and three children, continue to make memories on the land where so many other Butlers did long before.

# RANCHO SANTO NIÑO WEBB COUNTY - SEVEN MILES NORTH OF BRUNI FOUNDED IN: 1836 FOUNDERS: JOSE ANTONIO AND MARIA ANTONIA C. LEAL CURRENT OWNERS: ADRIAN S. PEREZ JR. AND CARMEN A. PEREZ

Jose Antonio Leal was born in Mexico. He married Maria Antonia Cantu in 1817. They had five sons. Jose and Maria lived in part of Mexico, which later became part of Texas after the Treaty of Guadalupe Hidalgo.



Hilario, their son, and his wife, Maria Trinidad Rios, raised 10 sons on the land. Hilario remained on the land and built a house in 1870, which still stands today. Hilario acquired title to the land in 1874. Hilario died in 1890, and the ranch became property of his sons.

Pedro, his son, married Concepcion in 1900. They had one son. Pedro died in 1903, and Concepcion remarried Severiano Perez. Together, they had four children. After Concepcion's death in 1908, Severiano remarried San Juana Guerra, and they had six children. Severiano died in 1928, and his children inherited the land.

One of the heirs, Estela Perez, married Adrian, and they had six children. Their son, Adrian Perez Jr., has since acquired portions of the original acreage.

#### LA LIBERTAD RANCH

ZAPATA COUNTY - 10 MILES SOUTH OF ZAPATA

FOUNDED IN: 1852

FOUNDERS: RAFAEL VELA AND JOSEFA A. SAENZ CURRENT OWNERS: MR. AND MRS. JOSE EMILIO VELA

Emiliano Vela was born in 1880. He married Matiana Saenz in 1912. She died only five years after they were married. They had one daughter, Matiana. Emiliano remarried in 1922 to Felipa Vela. They had two sons, Emiliano Jr. and Octavio. Both sons died before Emiliano.

Felipa died in 1971. Emiliano died in 1979. In 1983, the estate was partitioned and equally divided between the estates of his two deceased sons. Emiliano Jr.'s estate kept the land together for 15 years. After that, the estate was divided amongst his eight married children. Jose E. Vela inherited his land in this way.

LOESCH RANCH
AUSTIN COUNTY - NINE MILES NORTH OF BELLVILLE
FOUNDED IN: 1897
FOUNDER: CHARLES (CARL) FRIEDRICH LOESCH SR.
CURRENT OWNERS: DONALD AND BARBARA LOESCH

Charles Friedrich Loesch Sr. was born in Wehdem, Westphalia, Germany, in 1840 and traveled with his family to the United States in 1858. He initially settled in the Cedar Hill area of Washington County. In 1897, Charles purchased 357 acres of land in Austin County.



Charles and his wife, Henriette Heitmann Loesch, worked the farm before selling 101 acres to their son, Carl (Charlie) Jr., in 1910. Carl Jr. continued farming with his wife, Minnie Winkelmann Loesch, until they sold the land to their son, Paul Heinrich Karl Fritz Loesch, in 1955.

Paul continued farming operations with his wife, Adeline Sternberg Loesch, before selling 76 acres to their son, Donald Loesch, in 2009. Donald and his wife, Barbara Williams Loesch, continue ranching operations today.

#### HELLINGER FARM



In 1906, Louis acquired 110 acres of land in the Kovar community in Bastrop and Fayette counties.



Louis and Elizabeth's daughter, Bessie, married Beno Hellinger in 1920. Beno and Bessie acquired the land in 1954. They continued farming and ranching operations. At one time, four generations were living in the farmhouse.

In 1965, Beno and Bessie sold tracts of land to their sons, Alfred and Beno A. Alfred and his wife, Evelyn, raised cattle on their 45 acres. In 2000, Alfred Jr. acquired this portion of the land, and he has continued raising cattle.

Beno and his wife, Jane, have continued raising cattle and growing crops on their 65 acres. They have 10 children and 22 grandchildren.

MCCLAIN

In 1850, brothers Frank and Dominic Schott came to Texas from France.

They were part of the Castro Colony. Frank married Margartha Haby and settled in Medina County. One year after their marriage, Margartha died during childbirth. Frank married Mary, and they had 13 children. One of their children, August, moved to the Pipe Creek area.

August married Lonie Callaham in 1899. They had three sons: Adolph, Leo and Howard. August bought land and gave 1,553 acres to Howard in 1950. Howard married Lucille Christilles, and they had three children: Betty Lou, Leslie and Gary.

Gary inherited the homestead. Gary and his wife, Madelyn, moved to the homestead in 2004. They have three children: Hank, Luke and Katie, along with six grandchildren.

WIEDERSTEIN, DEANNE AND RONALD HULETT

Albert Herman Wiederstein was born in 1877 in Comal County. In 1915, Albert purchased acreage from Magdalena Stapper. Albert and his wife, Augusta, had two sons, Alfred and Richard. They worked the land and raised mules. Their mules were often startled by planes from Randolph Air Force Base flying overhead.

Alfred and Richard inherited the land. Richard transferred his ownership to Alfred in 1925. Alfred and his wife, Leonie, had a son, Lee Jay Wiederstein. Upon the death of his parents, Lee continued to work the land.

Lee and his wife, Lucille, had two children, Jeanne and Allen. Their children inherited the land and continued farming and ranching operations. In 2009, Allen deeded 11 acres to his daughter, DeAnne, and her husband, Ronald Hulett.

In 1908, William Hannibal Brigance married Juliette Parker Harris in Wisconsin after having met in Texas. In 1909, they bought property near Brazoria and established Holly Farms.



Juliette wanted a dairy farm. However, conditions were not conducive to this, so the family turned to other operations. Juliette's brother, Joseph Earl Harris, joined their operation and helped out as he could.

William and Juliette's son, Joseph Harris Brigance, was born in 1918. Joseph married Marie Phillips in 1938, and together, they built a small home near his parents. They had three children: Mary Ruth, JoAnne and Philip.

In 1868, John N. Scasta arrived in Galveston with his family from Czechoslovakia. He was just 3 years old. They settled in the Steep Hollow Community in Brazos County. In 1905, John purchased 405 acres. Along with his wife and children, he worked the land.



Shortly thereafter, John sold 100 acres to his brother, Charley Adolph. Charley and his wife raised two children and worked the land. Their son, William Charles, was very active in farm operations. He married and had a son, William Jr.

In 1949, William Charles Jr. purchased additional acreage from John Scasta's original tract. He worked the land until 1957 when he sold the acreage to his father. William Charles Sr. and his wife, Nora, lived on the land until their deaths. Their son inherited the land and continues ranch operations today.

Green Clay Holt was born in Tennessee. When his father died, he traveled with his mother and their family to Erath County. Once there, he met his wife, Emma. Green and Emma traveled with their two small

children to Briscoe County in 1906. They bought land and worked it. Green and Emma had 10 children: Ina, Annie, Charlie, Lorena, Minnie, William Alfred, John Edgar, Blain, Avie and Mattie Laura.

Green passed away in 1933. William Alfred acquired 160 acres in 1934. He and his wife, Leona, had four children: Hattie Lorena, Reba Iweta, Rex Gilbert and Peggy Jean.

In 1977, Rex acquired the land from his father and continued farming. Rex and his wife, Theta, had four children: Karen Inez, David Gilbert, William Clay and Kent Stephen.

Thomas passed away while still living on the land, and Louisa lived to be 92 years old. The land and the house were left to Alma May Welch Davenport who would work the land until leaving it to their only child, Oneita Louise Davenport Early.



Oneita and her husband, Roy, moved back to the farm. Oneita's parents passed away in 1988 and 1997. Oneita and Roy plan to live on the land until they can pass it along to their three children.

In 1905, Gustav Shultz purchased 200 acres from Peter Urban. Gustav married Mary Benn, and they raised five children on the farm. Gustav later conveyed five acres to the local school district for the Birch community school. This is where his daughter, Grace, went to school.



After Gustav's death, Robert and Betty Schultz operated the farm. The land was then purchased and inherited by Grace and Ernest Knesek who continued to work the land. They conveyed the land to their sons, Kenneth and Timothy, in 2005.

Today, the Knesek brothers continue to run cattle operations, while enhancing conservation practices and promoting wildlife management.

In 1850, brothers Frank and Dominic Schott came to Texas from France. They were part of the Castro Colony. Frank Mathias Britten was born in Germany in 1854. He immigrated to the United States. Mathias ended up in Iowa where he

married Eva Bosen in 1882. He homesteaded land along a new railroad built through the Texas Panhandle. Mathias and Eva had seven children: Mary Loretta, John Mathias, Mathias Nicholas, Frank Sebastian, Lena E., Henry Sebastian and Emma E.

Mary Loretta acquired section 91 as an inheritance in 1932. She married George Kuehler and built a house. They had eight children: Paul Nicholas, Albin Mathias, Eva Lorraine, Cletus John, Francis, Robert Joseph, Rosella Marie and James.

George W. West came to Texas in the 1850s with his family. As a teenager, he was the trail boss of the longest cattle drive on record. After he retired from the trail, George and his wife, Kittie, purchased land in Live Oak County in 1881. He added to this land over time. However, a devastating drought in 1882 killed off so many of his cattle that he was forced to sell half of his acreage.

Several years later, George sold land to Charles Simmons who used it to establish the town of Simmons. In 1910, George also founded a town, appropriately named George West, and successfully enticed the railroad to come through.
