# Department Strategy

## Plan It.

This strategy includes all of the planning and environmental design for the state's highway projects. It also supports planning for transportation modes such as rail, air, marine, pipeline, bicycle and pedestrian traffic. It includes acquiring right of way for transportation projects and providing relocation expenses when necessary. Funding and management of research programs that help save lives and money are also part of this strategy.

## Build It.

This strategy oversees construction projects that add capacity to the state's transportation system, either through new projects or those which supplement the existing infrastructure. Projects in this category could include widening an existing tax-supported highway or toll road, constructing a new bridge, purchasing a new ferryboat or lengthening a runway at an airport.

## Maintain It.

## Use It.

This strategy ensures that people are using Texas' transportation in the safest, most efficient ways. It includes issuing motor vehicle titles and registration documents, providing grants to improve public safety, supporting public transportation outside of major metropolitan areas, regulating motor vehicle dealers, preventing auto theft and providing information to the traveling public.

This strategy ensures that existing transportation investments remain safe and usable. It covers the reconstruction, rehabilitation and maintenance of the state highway system, maintenance of highway signals and signage, support of the Gulf Intracoastal Waterway and operation of the ferry systems at Galveston and Port Aransas. It also includes emergency repair and restoration of damaged structures on the state highway system.

## Manage It.

This strategy covers administration, human resources, information resources, purchasing, training, fiscal services, legal services, occupational safety and other management services.

## TEXAS LICENSE PLATES BOOK

### MULTI-YEAR LICENSE PLATES



**Apportioned (Transportation Code §502.054).** One multi-year license plate per vehicle is issued for Texas-based commercial power units and trucks that operate interstate into states where license fees have been apportioned or prorated. The plate issued for power units must be displayed on the front of the vehicle. The fee is \$2, plus the regular registration fee and other applicable fees. A department issued cab card validates the current registration.



**City Bus (Transportation Code §§502.161; 504.503).** Two license plates are issued for buses to transport persons for compensation within the limits of a municipality. The registration fee is the same as for a passenger car, plus other applicable fees. An additional fee of \$40 is required for personalized license plates.



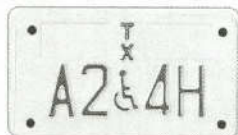
**Converter (Transportation Code §503.0618).** Instead of registering under Chapter 502, a vehicle that a converter operates or permits to be operated on a public street or highway, the converter may apply for, receive, and attach metal converter license plates to the vehicle if it is the type of vehicle that the converter is engaged in the business of assembling or modifying. The fee for this plate is \$20.



**Cotton Vehicle (Transportation Code §504.505).** One license plate is issued for vehicles used only in the cultivation, harvesting, and transporting of cotton. The fee is a one-time \$8 charge, plus the regular registration fee and other applicable fees.



**Dealer (Transportation Code §503.061).** Separate general distinguishing numbers are issued for the sale of motor vehicles, motorcycles, travel trailers, trailers or semitrailers. The fee for the dealer's general distinguishing number for a new entry is \$500 and \$200 for renewal. Once a number is obtained, the dealer may purchase a metal dealer license plate and have buyers' cardboard tags (red numbers) and temporary cardboard tags (black numbers) printed. The fee for the dealer metal plate is \$45.30. An additional fee of \$40 is required for personalized license plates.



**Disabled Person (Transportation Code §504.201).** Two license plates are issued for motor vehicles with a manufacturer's rated carrying capacity of 2 tons or less and one license plate is issued for motorcycles, regularly operated for noncommercial use by or for the transportation of permanently disabled persons. Disabled means a condition in which a person has mobility problems that substantially impair the person's ability to ambulate; visual acuity of 20/200 or less in the better eye with correcting lenses or visual acuity of more than 20/200, but with a limited field of vision in which the widest diameter of the visual field subtracts an angle of 20 degrees or less. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized plates. (For additional information refer to Transportation Code §681.001).



**Disabled Person (Vans & Buses) (Transportation Code §504.203).** Two license plates are issued for a van or bus operated by an institution, facility, or residential retirement community for the elderly with a manufacturer's rated carrying capacity of 2 tons or less, regularly operated by or for the transportation of "permanently disabled" persons. The fee is \$3 for the first set of license plates and \$15 for a second set in addition to the regular registration fee and other applicable fees. Only two sets total may be issued.





**Farm Trailer (Transportation Code §504.504).** One license plate is issued to owners of farm trailers or farm semitrailers with a gross weight of less than 4,000 pounds, but not more than 34,000 pounds and used exclusively for the transportation of agriculture products, livestock or farm supplies. The fee for this plate is \$5.30.



**Farm Truck (Transportation Code §504.504).** Two license plates are issued for commercial vehicles used as farm vehicles. The registration fee is one-half of the commercial motor vehicle fee, plus other applicable fees, if the vehicle is used for commercial purposes only to transport: the person's own poultry, dairy, livestock products, timber in its natural state, or farm products to market or another place for sale or processing; laborers from their place of residence to the owner's farm or ranch; or to transport without charge, materials, tools, equipment, or supplies from the place of purchase or storage to the owner's farm or ranch exclusively for the owner's use or for use on the farm or ranch.



**Farm Truck Tractor (Transportation Code §504.504).** One license plate, mounted on the front of the vehicle, is issued for commercial vehicles used as farm vehicles. The registration fee is one-half of the regular truck tractor registration fees plus other applicable fees.



**Forestry Vehicle (Transportation Code §504.507).** One license plate is issued annually for vehicles used exclusively for transporting untreated ties; stave bolts, plywood bolts, pulpwood billets, wood chips, stumps, sawdust, moss, bark, wood shavings, and property used in the production of those products, including logs and debarked logs. The fee is \$8, plus the regular registration fee and other applicable fees.



**Log Loader (Transportation Code §504.506).** One license plate is issued for vehicles that have log-loading equipment mounted on them, but do not transport logs. The fee is \$62.80 for each registration year or portion of a registration year.



**Machinery (Transportation Code §504.504).** One license plate is issued to owners of machinery used solely for drilling water wells or to construction equipment (unconventional vehicles). The fee is \$5.30.



**Manufacturer (Transportation Code §503.064).** One license plate is issued annually to manufacturers located in Texas for the purpose of testing their new vehicles that are manufactured or assembled in this state. The fee for this plate is \$40.30.



**Moped (Transportation Code §502.007).** One license plate is issued for certified mopeds. The fee for registration is \$30.30 per year, plus other applicable fees. An additional fee of \$40 is required for personalized license plates.



**Motor Bus (Transportation Code §502.168).** Two license plates are issued. The fee for registration is \$25 per year, plus an amount according to the gross weight of the vehicle and other applicable fees.





**Motorcycle (Transportation Code §502.160).** One license plate is issued. The fee for registration is \$30.30 per year, plus other applicable fees. An additional fee of \$40 is required for personalized license plates.



**Passenger (Transportation Code §502.161).** Two license plates are issued. The fee is based on model year or weight of the vehicle. Other applicable fees are also charged annually. An additional fee of \$40 is required for personalized license plates.

Model year more than six years before the year registration begins . . . . . \$40.80  
 Model year more than three years but six years or less before the year Registration begins . . . . . \$50.80  
 Model year three years or less before the year registration begins . . . . . \$58.80

The fee for registration of a passenger car, municipal bus, or a private bus that weighs more than 6,000 pounds is \$25 plus 60 cents for each 100 pounds.



**Permit License (Transportation Code §§623.142, 623.144).** One license plate is issued for commercial vehicles that are used solely for servicing, cleaning out, and for drilling oil wells, provided such vehicles consist of a mast, an engine for power, a draw works, and a chassis permanently constructed for such purpose. To operate legally, owners of vehicles with permit license plates must also obtain oversize and/or overweight permits. The fee for this plate is \$5.30.



**Private Bus (Transportation Code §§502.161, 504.503).** Two license plates are issued for buses that are not operated for hire. License plates issued under this section must include the words "private bus." The fee is the same as for passenger cars plus other applicable fees. An additional fee of \$40 is required for personalized license plates.



**Rental Trailer (Five-year) (Transportation Code §502.166).** One license plate is issued, for up to a 5-year period, for rental trailers having a gross weight not exceeding 4,000 pounds. The owner of a rental trailer fleet must file a licensing agreement with the Vehicle Titles and Registration Division, in order to qualify for rental trailer plates. The annual registration fee is the same registration fee as for a trailer.



**Token Trailer (Transportation Code §502.167).** One license plate issued only for semitrailers having a gross weight in excess of 6,000 pounds to be pulled by vehicles displaying a Combination, Apportioned, Forestry, NAFTA Annual Permit, or Seasonal Agriculture license plate. The fee is \$15.30. An additional fee of \$40 is required for personalized license plates.



**Token Trailer (Five-year) (Transportation Code §502.167)** One license plate issued for a five year period expiring March 31, in years ending in "0" or "5". The owner of the token trailer fleet must file a licensing agreement with the Vehicle Titles and Registration Division in order to qualify for the five-year token trailer license plates. The fee is based on the token trailer rate and is paid for the entire five-year period or remainder thereof.



**Tow Truck (Large) (Transportation Code §504.508).** Two license plates are issued to tow truck owners registered with the Texas Department of Transportation Motor Carrier Division. The fee is \$15, plus the regular registration fee and other applicable fees.





**Tow Truck (Small) (Transportation Code §504.508).** The current small, single Tow Truck license plate will be issued for the following vehicles: 1) out-of-state registered tow trucks that operate in Texas, 2) all tow trucks displaying apportioned registration (including Texas apportioned registration) and 3) commercial vehicles displaying Texas Combination license plates which are also used as tow trucks. All other tow trucks operating in Texas will be issued the new large Tow Truck license plates according to the vehicle's regular registration. The regular registration fee and other applicable fees are charged annually.



**Tractor (Transportation Code §502.165).** One license plate is issued to road tractors. These plates are multi-year license plates issued on a staggered basis. The registration fee is \$25 plus an additional amount based on the weight of the tractor as certified by a public weigher or a license and weight inspector of the Department of Public Safety.



**Trailer (Transportation Code §502.166).** One license plate is issued for trailers and semitrailers. The registration fee is based on empty weight plus the weight of the heaviest load to be carried. The registration fee plus other applicable fees are charged annually. An additional fee of \$40 is required for personalized license plates.



**Travel Trailer (Transportation Code §502.166).** One license plate is issued for camper trailers and house trailer-type vehicles that are less than 8 feet wide and less than 40 feet long (not including hitch), or are of the Park Model-type with 400 square feet or less. The registration fee is based on actual weight of the vehicle, including all furnishings. The registration fee, plus other applicable fees are charged annually. An additional fee of \$40 is required for personalized license plates.



**Truck (Transportation Code §502.162).** Two license plates are issued. The regular registration fee and other applicable fees are charged annually. The regular registration fee is based on the gross weight of the vehicle. An additional fee of \$40 is required for personalized license plates.

#### SPECIALTY LICENSE PLATES (Multi-year) QUALIFY TO PURCHASE



**Airborne Parachutists (Transportation Code §504.307).** Two license plates are issued for passenger cars and light trucks to active and former members of the United States armed services who have satisfactorily completed the prescribed proficiency tests while assigned or attached to an airborne unit or the Airborne Department of the United States Army Infantry School or participated in at least one combat parachute jump. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.

**American Legion (Transportation Code §504.413).** Two license plates are issued for passenger cars and light trucks to members of the American Legion. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the American Legion, Department of Texas account in the state treasury. Money in the account may only be used by the Texas Veterans Commission in making grants to the American Legion Endowment Fund for scholarships and youth programs sponsored by the American Legion, Department of Texas. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Antique (Transportation Code §504.502).** One license plate issued, for up to a five-year period, for a passenger car, truck, or motorcycle (4" x 7" plate size) that is at least 25 years old. The plate must include the words "Antique Auto," "Antique Truck" or "Antique Motorcycle." The vehicle must be used for exhibitions, club activities, parades, and other functions of public interest and in no case for regular transportation. The specialty license plate fee for the five-year period for vehicles manufactured in 1921 or later is \$50.30 and for vehicles manufactured in 1920 or before is \$40.30.

**Antique Validation Tab (Transportation Code §504.502).** One plate sticker is affixed to a tab for display on old Texas license plates (passenger or truck) that were originally issued the same year as the model year of the antique vehicle. The fee for this sticker is the same as for the antique plate. The dimensions of the sticker are 1" x 2."

**Armed Forces Reserve (Transportation Code §504.305).** Two license plates are issued for passenger cars and light trucks to members of the U.S. Armed Forces Reserve. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Classic Auto/Truck (Transportation Code §504.501)** Two license plates are issued for passenger cars (Classic Auto) and light trucks (Classic Truck) that are 25 or more years old. The specialty license plate fee is \$15 annually, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. The license plates will be validated with a windshield validation sticker. An additional fee of \$40 is required for personalized license plates.

**Classic Motorcycle (Transportation Code §504.501).** One license plate is issued for motorcycles that are 25 or more years old. The specialty license plate fee is \$15 annually, plus the regular registration fee and other applicable fees. The license plate will be validated with a license plate validation sticker. An additional fee of \$40 is required for personalized license plates.

**Coast Guard Auxiliary (Transportation Code §504.304).** Two license plates are issued for passenger cars and light trucks to members of the Coast Guard Auxiliary. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Congressional Medal of Honor (Transportation Code §504.315).** Two license plates are issued annually for passenger cars and light trucks. The plates are numbered one through thirty. A recipient of a Congressional Medal of Honor who resides in Texas is entitled to register one passenger car or light truck without payment of a registration fee or specialty license plate fee. This specialty license plate cannot be personalized.

**Desert Shield/Desert Storm Veterans (Transportation Code §504.313).** Two license plates are issued for passenger cars and light trucks for persons who served in the United States armed forces after August 1, 1990, and before April 12, 1991. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Disabled Veteran (Transportation Code §504.202).** Two license plates are issued for motor vehicles with a manufacturer's rated carrying capacity of 2 tons or less, that are owned by a veteran who has at least a 50 percent service-connected disability or a 40 percent service-connected disability due to the amputation of a lower extremity. The fee for the first set of license plates is \$3. There is no fee for a second set; however, regular registration fees and other applicable fees are not waived. Only two sets of license plates may be issued.



**Disabled Veteran Motorcycle (Transportation Code §504.202).** One license plate is issued for a motorcycle that is owned by a veteran who has at least a 50 percent service-connected disability or a 40 percent service-connected disability due to the amputation of a lower extremity. The fee for the first set of license plates is \$3. There is no fee for a second set; however, regular registration fees and other applicable fees are not waived. Only two license plates total may be issued.



**Distinguished Flying Cross (Transportation Code §504.308).** Two license plates are issued for passenger cars and light trucks to persons who have received the Distinguished Flying Cross medal. The fee for this license plate is \$3 annually, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



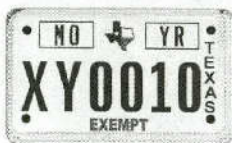
**Emergency Medical Services Personnel (Transportation Code §504.410).** Two license plates are issued for passenger cars and light trucks to emergency medical services personnel certified by the Texas Department of Health under Subchapter C, Chapter 773, Health and Safety Code. The specialty license plate fee is \$8 annually, plus the regular registration fee and other applicable fees. A person may be issued only one set of the specialty license plates. An additional fee of \$40 is required for personalized license plates.



**Enduring Freedom (Transportation Code §504.314).** Two license plates are issued for passenger cars and light trucks to persons who served in the United States armed services and participated in Operation Enduring Freedom. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Exempt Vehicle (Transportation Code §502.202).** Two license plates are issued to vehicles owned and used exclusively in the service of the U.S. Government, the State of Texas or any county, city, or school district. The plates are permanent and remain with the vehicle until it ceases to be owned by the exempt agency.



**Exempt Vehicle (Motorcycle) (Transportation Code §502.202).** One license plate is issued for motorcycles and mopeds owned and used exclusively in the service of the U.S. Government, the State of Texas or any county, city, or school district. The plates are permanent and remain with the vehicle until it ceases to be owned by the exempt agency.



**Foreign Organization (Transportation Code §504.412).** Two license plates are issued for passenger cars and light trucks owned by an instrumentality established by a foreign government recognized by the United States before January 1, 1979, that is without official representation or diplomatic relations with the United States. These plates are exempt from regular registration fees and remain valid for five years from issuance.





**Former Military Vehicle (Transportation Code §504.502).** One license plate is issued for passenger cars, trucks, motorcycles, or trailers that were manufactured for use by any country's military forces and are maintained to accurately represent its military design and markings. The plate is required for display and must be attached to the rear of the vehicle. These vehicles are used solely for exhibitions, club activities, parades and other functions of public interest and in no instance, public transportation. The vehicle may be registered accordingly, regardless of vehicle size, weight, or year of manufacture, and are exempt from safety inspection requirements. In lieu of plate issuance, the number assigned by military may be used, if affixed to the vehicle in a manner consistent with the serial number originally displayed on the vehicle. The registration receipt for vehicles without license plates must be carried in the vehicle at all times. The fee for vehicles manufactured in 1921 and after is \$50 and vehicles manufactured in 1920 or before is \$40.



**Former Prisoner of War (Transportation Code §504.315).** Two license plates are issued for passenger cars and light trucks to persons who were captured and incarcerated by an enemy of the United States during a period of conflict with the United States. The fee for the first set of license plates is \$3. The fee for each additional set is \$15, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification.



**Gold Star Mother (Transportation Code §504.408).** Two license plates are issued for passenger cars and light trucks to the mother of a person who died while serving in the U.S. Armed Forces. The specialty license plate fee is \$10 annually, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. Only one set of license plates will be issued.



**Korean War Veteran (Transportation Code §504.311).** Two license plates are issued for passenger cars and light trucks to persons who served in the United States armed forces after June 26, 1950, and before February 1, 1955. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Legion of Valor (Transportation Code §504.315).** Two license plates are issued for passenger cars and light trucks. The owner must be the recipient of the Air Force Cross or Distinguished Service Cross, the Army Distinguished Service Cross, the Navy Cross, or the Medal of Honor. The fee for the first set of license plates is \$3. The fee for each additional set is \$15, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification.



**Marine Corp League (Transportation Code §504.304).** Two license plates are issued for passenger cars and light trucks to members of the Marine Corps League or its auxiliary. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. An additional fee of \$40 is required for personalized license plates.

**Merchant Marine (Transportation Code §504.306).** Two license plates are issued for passenger cars and light trucks to persons retired from service in the merchant marine of the United States. Only one set of plates per person will be issued under this section. The specialty license plate fee is \$10 annually, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Military Academy (U.S. Air Force Academy, U.S. Military Academy, and U.S. Naval Academy) (Transportation Code §504.309).** Two license plates are issued for passenger cars and light trucks to persons who are graduates of the United States Air Force Academy, United States Military Academy, or the United States Naval Academy and are current or former commissioned officers of the United States armed forces. The regular registration fee and other applicable fees are charged annually. An additional fee of \$40 is required for personalized license plates.



**Operation Iraqi Freedom (Transportation Code §504.3135).** Two license plates are issued for passenger cars and light trucks to persons who served in the United States armed forces on or after November 8, 2002, or on or before May 1, 2003. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Parade (Transportation Code §502.283).** One license plate is issued for motor vehicles owned and operated by nonprofit organizations that are designed, constructed and used primarily for parade purposes. No fee is required. The license plate is issued for a five year period.



**Peace Officer (Transportation Code §504.407).** Two license plates are issued for passenger cars and light trucks. To qualify, the applicant must have been wounded in the line of duty as a peace officer or a surviving spouse, parent, brother, sister or adult child, including an adopted child or stepchild, of a person killed in the line of duty as a peace officer. The specialty license plate fee is \$20 annually, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Pearl Harbor Survivor (Transportation Code §504.315).** Two license plates are issued for passenger cars and light trucks to survivors of the attack on Pearl Harbor on December 7, 1941. The fee for the first set of license plates is \$3. The fee for each additional set is \$15, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Professional Fire Fighter (Transportation Code §504.801).** Two license plates are issued for passenger cars and light trucks and one license plate is issued for motorcycles. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$29.50 will be deposited to the state highway fund. The remaining \$.50 will be sent to the county in which the owner resides. The regular registration fee is charge according to classification. An additional fee of \$40 is required for personalized license plates.



**Purple Heart Recipient (Transportation Code §504.315).** Two license plates are issued for passenger cars and light trucks owned by recipients of the Purple Heart Medal. The fee for the first set of license plates is \$3. The fee for each additional set is \$15, plus the regular registration fee and other applicable fees. The regular registration fee is charge according to classification. An additional fee of \$40 is required for personalized license plates.





**Radio Operator (Transportation Code §504.509).** Two license plates are issued for a person who holds an amateur radio station license issued by the Federal Communications Commission and who operates receiving and transmitting mobile amateur radio equipment in a passenger car or light truck. The specialty license plate fee is \$2 for the first year and \$1 for each subsequent year of registration as applicable, plus the regular registration and other applicable fees. The regular registration fee is charged according to classification. A person may register more than one vehicle under this section using the same call letters.



**Texas Constable (Transportation Code §504.406).** Two license plates are issued for passenger cars and light trucks to Texas constables. There is no charge other than the regular registration fee for the license plates. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas Guard (Transportation Code §504.305).** Two license plates are issued for passenger cars and light trucks owned by active members or retired members of the Texas National Guard or Texas State Guard who have completed 20 or more years of satisfactory federal service as members of a reserve component of the United States armed forces. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification.



**Texas Wing Civil Air Patrol (Transportation Code §504.304).** Two license plates are issued for passenger cars and light trucks owned by members of the Civil Air Patrol. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**U.S. Air Force (Transportation Code §504.303).** Two license plates are issued to passenger cars and light trucks owned by active or retired members of the U.S. Air Force. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**U.S. Army (Transportation Code §504.303).** Two license plates are issued for passenger cars and light trucks owned by active or retired members of the U.S. Army. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**U.S. Coast Guard (Transportation Code §504.304).** Two license plates are issued for passenger cars and light trucks owned by active or retired members of the U.S. Coast Guard. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**U.S. Marine Corp (Transportation Code §504.303).** Two license plates are issued for passenger cars and light trucks owned by active or retired members of the U.S. Marine Corps. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**U.S. Navy (Transportation Code §504.303).** Two license plates are issued for passenger cars and light trucks owned by active or retired members of the U.S. Navy. The specialty license plate fee is \$10 for the first set of license plates and \$15 for each additional set, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Vietnam Veteran (Transportation Code §504.312).** Two license plates are issued for veterans who served in the United States armed forces in the Republic of Vietnam during the period beginning on February 28, 1961 and ending on May 7, 1975; or, in all other cases, during the period beginning August 5, 1964 and ending May 7, 1975. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Volunteer Firefighter (Certified) (Transportation Code §504.409).** Two license plates are issued for passenger cars and light trucks owned by a volunteer firefighter certified by the Texas Commission on Fire Protection or the State Firemen's and Fire Marshal's Association of Texas. The fee is \$4, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**World War II Veteran (Transportation Code §504.310).** Two license plates are issued for passenger cars and light trucks owned by persons who served in the United States or Allied armed forces during World War II. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

## GENERAL PUBLIC



**Air Force Association (Transportation Code §504.630).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Air Force Association of Texas account in the state treasury. Money in the account may be used by the Texas Veterans Commission in making grants to benefit projects sponsored by the Air Force Association of Texas. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**All Terrain Vehicle Validation Sticker (Transportation Code §502.006).** One validation sticker (no license plate) is issued annually to owners of ATVs with three or more wheels who wish to operate their vehicle off-highway on public property. The fee for this sticker is \$6.30. The dimensions of the sticker are 1-3/4" square.



**Animal Friendly (Transportation Code §504.605).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the animal friendly account established by Section 828.014, Health and Safety Code. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Be a Blood Donor (Transportation Code §504.641).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee \$22 shall be deposited to the credit of the blood donor account under Section 162.016, Health and Safety Code. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Be an Organ Donor (Transportation Code §504.801).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee \$29.50 shall be deposited to the general revenue fund. The remaining \$.50 will be sent to the county in which the owner resides. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Big Bend National Park (Transportation Code §504.606).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee \$22 shall be deposited to the credit of the Big Bend National Park account in the state treasury. Money in the account may be used only by the Parks and Wildlife Department to support the activities of a designated nonprofit organization whose primary purpose is the improvement or preservation of Big Bend National Park. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Boy Scouts of America (Transportation Code §504.608).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund and may be appropriated only to the Texas Commission on Alcohol and Drug Abuse for drug abuse prevention programs provided by nonprofit organizations that primarily serve children. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Coastal Conservation Association (Transportation Code §504.801).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$29.50 will be deposited in the state highway fund. The remaining \$.50 will be sent to the county in which the owner resides. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Conservation (Transportation Code §504.618).** (Bluebonnet, Horned Lizard, Large-Mouth Bass, and White-Tailed Deer). Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas parks and wildlife conservation and capital account. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. The Fish Texas license plates are also available for trailers.







**Cotton Boll (Transportation Code §504.636).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund for use only by the Texas Higher Education Coordinating Board in making grants to benefit Texas Cotton Producers, Inc., for the sole purpose of providing scholarships to students who are pursuing a degree in an agricultural field related to the cotton industry while enrolled in an institution of higher education, as defined by Section 61.003, Education Code. An additional fee of \$40 is required for personalized license plates.



**Dallas Cowboys (Professional Sports Team) (Transportation Code §504.614).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be sent to the public entity that provided public funds for the construction or renovation of the facility in which the professional sports team plays its home games or that provides public funds for the operation of that facility. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Dallas Mavericks (Professional Sports Team) (Transportation Code §504.614).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be sent to the City of Dallas to be used towards the upkeep of the American Airlines Center, in which the professional sports team plays its home games. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Dallas Stars (Professional Sports Team) (Transportation Code §504.614).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be sent to the public entity that provided public funds for the construction or renovation of the facility in which the professional sports team plays its home games or that provides public funds for the operation of that facility. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Eagle Scout (Transportation Code §504.654).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Eagle Scout account in the general revenue fund. Money in the account may be used by the Texas Higher Education Coordinating Board in making grants to support projects sponsored by Boy Scout councils in this state. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**El Paso Mission Valley (Transportation Code §504.634).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the El Paso Mission Restoration account in the state treasury. Money in the account may be used by the Texas Historical Commission in making grants to Socorro Mission Restoration Effort to be used only for the purpose of preservation and rehabilitation of the Socorro Mission. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**4-H (Transportation Code §504.645).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund and shall be used only by the Texas Cooperative Extension of the Texas A&M University System for 4-H and Youth Development Programs and to support the Texas Cooperative Extension's activities related to 4-H and Youth Development Programs. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Fight Terrorism (Transportation Code §504.647).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$29.50 shall be deposited to the credit of the state highway fund. The remaining \$.50 will be sent to the county in which the owner resides. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Girl Scouts (Transportation Code §504.622).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Girl Scout account in the state treasury. Money in the account may be used by the Texas Higher Education Coordinating Board in making grants to benefit educational projects sponsored by the Girl Scout Councils of Texas. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**God Bless America (Transportation Code §504.648).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$40 annually, plus the regular registration fee and other applicable fees. Of the \$40 specialty license plate fee, \$32 shall be deposited to the credit of the state highway fund and may only be used for the Safe Routes to School Program. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**God Bless Texas (Transportation Code §504.648).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$40 annually, plus the regular registration fee and other applicable fees. Of the \$40 specialty license plate fee, \$32 shall be deposited to the credit of the state highway fund and may only be used for the Safe Routes to School Program. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Houston Livestock Show and Rodeo (Transportation Code §504.613).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited in the Houston Livestock Show and Rodeo scholarship account in the state treasury. Money in the account may be used only by the Higher Education Coordinating Board in making grants to benefit the Houston Livestock and Rodeo. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Houston Texans (Professional Sports Team) (Transportation Code §504.614).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be sent to the public entity that provided public funds for the construction or renovation of the facility in which the professional sports team plays its home games or that provides public funds for the operation of that facility. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**I Love Texas (Texas Commission for the Deaf and Hard of Hearing) (Transportation Code §504.619).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund and may be appropriated only to the Texas Commission for the Deaf and Hard of Hearing for direct services programs, training and education. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Keep Texas Beautiful (Transportation Code §504.602).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be used in connection with the department's litter prevention and community beautification programs. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Keeping Texas Strong (Transportation Code §504.650).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas Alliance Education Program account in the general revenue fund. Money in the account may be used only by the Texas Education Agency to finance the education programs of the Texas Alliance of Energy Producers. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Knights of Columbus (Transportation Code §504.638).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the State Council of Charities account in the general revenue fund. Money in the account shall be used only by the Texas Education Agency to make grants to State Council of Charities to carry out the purposes of that organization. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Lone Star Proud for Kids (Transportation Code §504.611).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the attorney general volunteer advocate program account in the general revenue fund. Money in the account may be used only by the attorney general to fund a contract entered into by the attorney general under Section 264.602, Family Code. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**March of Dimes (Transportation Code §504.651).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas Department of Health for use in the Birth Defects Registry. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund. Money in the account may only be used by the attorney general to support the Texans for Equal Justice mother-child survivors educational scholarship fund for educational scholarships to surviving spouses of homicide victims who have one or more minor children and who need further education to adequately support the family and surviving children of homicide victims entering an institution of higher education or vocational school for the first time. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Native Texan (Daughters of the Republic of Texas) (Transportation Code §504.637).**

Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Daughters of the Republic of Texas account in the state treasury. Money in the account may be used only by the Texas Department of Economic Development or its successor agency in making grants to the Daughters of the Republic of Texas to be used only for the purpose of preserving Texas historic sites or funding educational programs that teach Texas history. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates. These license plates are also available for motorcycles.



**Personalized (Transportation Code §504.101).**

Two license plates are issued provided the number does not conflict with an existing alpha-numeric pattern, does not duplicate another personalized number, or might be offensive to any member of the public. One license plate is issued for motorcycles and trailers. The fee for personalized license plates is \$40, plus the regular registration fee and other applicable fees. The regular registration fee is charged according to classification.



**Read to Succeed (Transportation Code §504.607).**

Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the "Read to Succeed" account in the general revenue fund. Money in the account may be used only to provide educational materials for public school libraries. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Red Grapefruit (Texas Citrus Industry) (Transportation Code §504.626).**

Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the general revenue fund that may be appropriated only to Texas A&M University-Kingsville, to provide financial assistance to graduate students in the College of Agriculture and Human Sciences. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**San Antonio Mission National Historical Park (Transportation Code §504.634).**

Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of Los Compadres de San Antonio Missions National Historical Park account in the state treasury. Money in the account may be used only by the Texas Historical Commission in making grants to Los Compadres de San Antonio Missions National Historical Park to be used for the purpose of preservation and rehabilitation of the San Antonio Missions National Historical Park. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Share the Road (Transportation Code §504.633).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of share the road account in the state treasury to be used only by the Texas Education Agency to support the activities of a designated nonprofit organization whose primary purpose is to promote bicyclist safety, education, and access through education and awareness programs and training, workshops, educational materials and media events. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Smile Texas Style (Transportation Code §504.646).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund to be used only by the Texas Department of Health in making grants to benefit the Texas Dental Association Financial Services for the sole use of providing charitable dental care. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Space Shuttle Columbia (Transportation Code §504.640).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the general revenue fund and may be used only by the Texas Aerospace Commission or its successor agency in making grants to benefit the Aviation and Space Foundation of Texas for the purpose of furthering aviation and space activities in Texas and providing Columbia Crew memorial scholarships to students. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Special Olympics Texas (Transportation Code §504.621).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the Special Olympics Texas account established by Section 533.018, Health and Safety Code. An additional fee of \$40 is required for personalized license plates.

**STAR Day School Library Readers are Leaders (Transportation Code §504.643).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the general revenue fund and used only by the Texas Education Agency in making grants to benefit the State of Texas Anniversary Remembrance (STAR) Day Foundation to be used only for the purpose of providing supplementary reading and service programs in partnership with public schools in this state for seventh and eighth grade public school students. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**State of the Arts (Texas Commission on the Arts) (Transportation Code §504.604).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas Commission on the Arts operating fund established under Section 444.027, Government Code. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**State Capitol (Transportation Code §504.603).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Tejano Monument (Transportation Code §504.655).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Tejano Monument account in the general revenue fund. Money in the account may be used by the State Preservation Board to design and erect a Tejano Monument for placement on the Capitol grounds or related educational programs. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texans Conquer Cancer (Transportation Code §504.620).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texans Conquer Cancer account established by Section 102.017, Health and Safety Code. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas Aerospace Commission (Transportation Code §504.610).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the general revenue fund. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Texas County Child Welfare Board (Transportation Code §504.642).** Two license plates are issued for passenger cars and light trucks. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of a special account for abused and neglected children established at the Department of Protective and Regulatory Services. Money in the account may be used only by the Department of Protective and Regulatory Services to fund programs and services supporting abused and neglected children under Section 264.004, Family Code. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Texas Ducks Unlimited (Transportation Code §504.627).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the state treasury. Money in the account may be used only by the Parks and Wildlife Department to support the activities of a designated nonprofit organization whose primary purpose is the conservation of waterfowl and wetlands. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas. It's like a whole other country. (Transportation Code §504.617).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the tourism account in the general revenue fund to finance the Texas Department of Economic Development's tourism activities. The regular registration is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Texas Juneteenth (Transportation Code §504.649).** Two license plates are issued for passenger cars and light trucks. Money in the account may be used only by the Parks and Wildlife Department to support the activities of a designated nonprofit organization that is accredited by the American Camping Association and is licensed by the Texas Department of Health and whose primary purpose is to provide, without charge, a camp for physically disabled, hearing or vision impaired, and diabetic children who reside in this state, regardless of race, religion, or national origin. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas Marine Mammal Recovery (Transportation Code §504.644).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the state treasury. Money in the account may be used only by the Parks and Wildlife Department to support the activities of the Texas Marine Mammal Stranding Network in the recovery, rehabilitation, and release of stranded marine mammals. The Parks and Wildlife Department shall establish reporting and other mechanisms necessary to ensure that the money spent for purposes for which it is dedicated. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Texas Master Gardener (Transportation Code §504.652).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of an account in the general revenue fund. Money in the account may be used only by Texas Cooperative Extension for graduate student assistantships within the Texas Master Gardener program and to support Texas Cooperative Extension's activities related to the Texas Master Gardener program. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas Music (Transportation Code §504.639).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas Music Foundation account established by Section 7.027, Education Code. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

**Texas Reads (Transportation Code §504.616).** Two license plates are issued for passenger cars and light trucks. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Texas YMCA (Transportation Code §504.623).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the YMCA account established by Section 7.025, Education Code. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.





**Texas Young Lawyer's Association (Transportation Code §504.612).** Two license plates are issued for passenger cars and light trucks. An additional fee of \$40 is required for personalized license plates.



**United We Stand (Transportation Code §504.628).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the Texas mobility fund. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.



**Urban Forestry (Transportation Code §504.632).** Two license plates are issued for passenger cars and light trucks. The specialty license plate fee is \$30 annually, plus the regular registration fee and other applicable fees. Of the \$30 specialty license plate fee, \$22 shall be deposited to the credit of the urban forestry account in the state treasury. Money in the account may be used by the Texas Forest Service in making grants to support the activities of a nonprofit organization located in Texas whose primary purpose is to sponsor projects involving urban and community tree planting, tree preservation, and tree education programs. The regular registration fee is charged according to classification. An additional fee of \$40 is required for personalized license plates.

## ANNUAL LICENSE PLATES



**Combination (Transportation Code §502.167).** One license plate, to be mounted on the front of the vehicle, is issued annually for trucks greater than one ton and truck tractors having manufacturers rated carrying capacity in excess of one ton, operated in combination with semitrailers that have a gross weight in excess of 6,000 pounds. The registration fee is based on the combined gross weight of all vehicles in combination and other applicable fees. An additional fee of \$40 is required for personalized license plates.



**County Judge (Transportation Code §504.405).** Two license plates are issued annually for passenger cars and light trucks to county judges of this state. A maximum of three sets of plates may be issued. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification.



**Disaster Relief (Transportation Code §502.203).** One license plate, mounted on the front of the vehicle, is issued annually to owners of commercial motor vehicles, truck tractors, trailers, and semitrailers used exclusively, in emergencies only, by nonprofit, disaster relief organizations. The fee for this plate is \$5.30.



**Fertilizer Truck (Transportation Code §504.504).** One license plate is issued annually for a motor vehicle that has been designed or modified exclusively to transport and spread fertilizer, including agricultural limestone. The fee for this plate is \$75.30.



**Honorary Consul (Transportation Code §504.411).** Two license plates are issued for passenger cars and light trucks owned by a person who is an honorary consul authorized by the United States to perform consular duties. The specialty license plate fee is \$40, plus the regular registration fee and other applicable fees.



**In Transit (Transportation Code §§503.031, 503.035).** One license plate is issued annually to any person engaged in transporting and delivering, by means of the full mount, saddle mount, tow bar, or any other combination, new vehicles from the manufacturer or any other point of origin to any point of destination within the state of Texas. The fee for this license plate is \$50.30 and any additional license plates are \$5.30.



**Manufacturer (Transportation Code §503.064).** One license plate is issued annually to manufacturers located in Texas for the purpose of testing their new vehicles that are manufactured or assembled in this state. The fee for this plate is \$40.30.



**Soil Conservation (Transportation Code §502.188).** One plate is issued annually for trucks, truck tractors, lowboy trailers, and semitrailers. The license plate can only be used by owners of commercial vehicles transporting their own soil conservation machinery or equipment used in clearing real property, terracing, or building farm ponds, levees, or ditches. The owner may register only one truck or truck tractor and one trailer or semitrailer with this type of license plate. These license plates are nontransferable. The registration fee is one-half of the regular commercial fee plus other applicable fees.





**State Judge (Transportation Code §504.403).** Two license plates are issued annually to a justice of the Supreme Court, a judge of the court of criminal appeals, a district court judge, a presiding judge of an administrative judicial district, or a statutory court judge. A maximum of three sets of license plates is allowed. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification.



**State Official (Transportation Code §504.401).** Two license plates are issued annually per vehicle to members of the Legislature and also to elected State Officials. A maximum of three sets of license plates is allowed. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification.



**U.S. Congress-House (Transportation Code §504.402).** Two license plates are issued annually to vehicles of the members of the United States House. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. A maximum of three sets of plates may be issued.



**U.S. Congress-Senate (Transportation Code §504.402).** Two license plates are issued annually to vehicles of the members of the United States Senate. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. A maximum of three sets of plates may be issued.

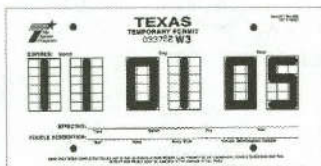


**U.S. Judge-Federal (Transportation Code §504.403).** Two license plates are issued annually for vehicles owned by judges of the Fifth Circuit Court of Appeals, a judge or magistrate of a United States District Court, or a judge of a United States Bankruptcy Court. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. A maximum of three sets of plates may be issued.

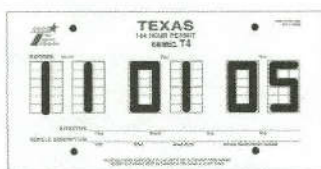


**U.S. Judge-Federal Administrative Law (Transportation Code §504.404).** Two license plates are issued to vehicles owned by current federal administrative law judges. The regular registration fee and other applicable fees are charged annually. The regular registration fee is charged according to classification. A maximum of three sets of plates may be issued.

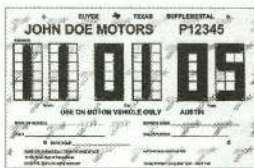


**15-Day Temporary Registration Permit (Form VTR-24-SP) (Point of Sale Sticker Printing Back-up Plan).** One temporary cardboard tag issued at no charge, in the event a sticker cannot be printed through the Registration and Title System (RTS) due to a power failure or equipment failure. The tag will be valid for 15 working days from the date of issuance. A temporary tag will only be issued when the customer provides a renewal and is intended for use only by the county tax office.

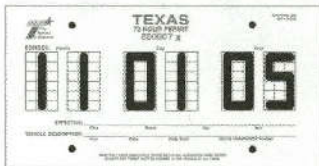


**30-Day Temporary Registration Permit (Transportation Code §502.354).** One cardboard tag, valid for 30 days, issued to passenger cars, private buses, trailers and semitrailers not exceeding 10,000 pounds gross weight, light commercial vehicles not exceeding the one-ton manufacturer's rated carrying capacity, or light commercial vehicles exceeding a one-ton rating provided the vehicle is operated unladen. The fee for this permit is \$25.

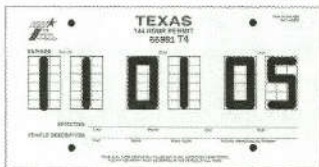




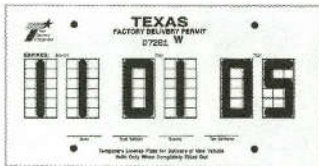
**30-Day Temporary Registration Permit (Motorcycle) (Transportation Code §502.354).** One 4" x 7" cardboard tag, valid for 30 days, issued to motorcycles and mopeds. The fee is \$25.



**72-Hour Permit (Transportation Code §502.352).** One cardboard tag, valid for 72 hours, issued to residents of the U.S., Canada, or Mexico for unregistered commercial vehicles to provide full temporary registration. The fee is \$25.



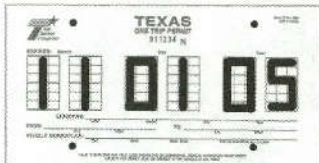
**144-Hour Permit (Transportation Code §502.352).** One cardboard tag, valid for 144 hours, issued to residents of the U.S., Canada, or Mexico for unregistered commercial vehicles to provide full temporary registration. The fee is \$50.



**Factory Delivery (Transportation Code §503.065).** One cardboard tag, valid for 30 days, is issued only to owners of new vehicles. These tags are not issued to manufacturers, dealers, or representatives of dealers and cannot be used on a vehicle transporting property. The fee is \$3.



**NAFTA Annual Permit (Transportation Code §502.353).** One license plate and one windshield sticker issued to foreign commercial motor vehicles, trailers and semitrailers subject to registration in Texas, but are not authorized to travel on the public roads of Texas for lack of registration for lack of registration or lack of reciprocity with the state or country in which such vehicles are registered. The fee is the regular commercial registration fee prescribed by Texas law based on the gross weight of the vehicle.

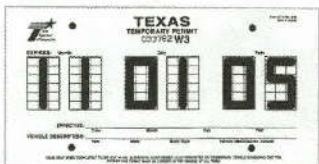


**One-Trip Permit (Transportation Code §502.354).** One cardboard tag, valid for 15 days, issued for the temporary movement of an unregistered new or used unladed vehicle. The fee is \$5.

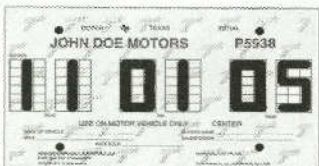


**Seasonal Agricultural (Transportation Code §502.1586).** One license plate issued to combination vehicles used exclusively to transport seasonal agricultural products. Trucks, farm trucks, and farm truck tractors will display plates that correspond with the normal classification of the vehicle. Registration is issued for a period of one to six months. The fee for registration under this section is computed at a rate of one-twelfth the standard annual registration fee for the vehicle, multiplied by the number of months in the requested period. Registration is collected in whole month increments only.

### DEALER ISSUED TAGS



**Buyer's Blue Supplemental Temporary Tag (Transportation Code §503.063).** The blue supplemental tag is to be used only when a dealer has paid the lien on a vehicle and the lienholder has not issued a release of lien within 21 days of the payment. In this instance a dealer may issue a blue tag when the red tag expires. The tag is valid for a maximum of 21 days after the date of issue.



**Buyer's Red Temporary Tag (Transportation Code §503.063).** The temporary red tag is used only on vehicles sold to retail purchasers. Only one red tag can be issued to a buyer and that tag is valid for 21 calendar days.





**Charitable Organization's Green Temporary Tag (Transportation Code §503.062).** The green cardboard tag has an assigned dealer number and is displayed on an unregistered vehicle owned by a dealer and loaned to a charitable organization. It is valid for a maximum of 30 days from the date of issue.

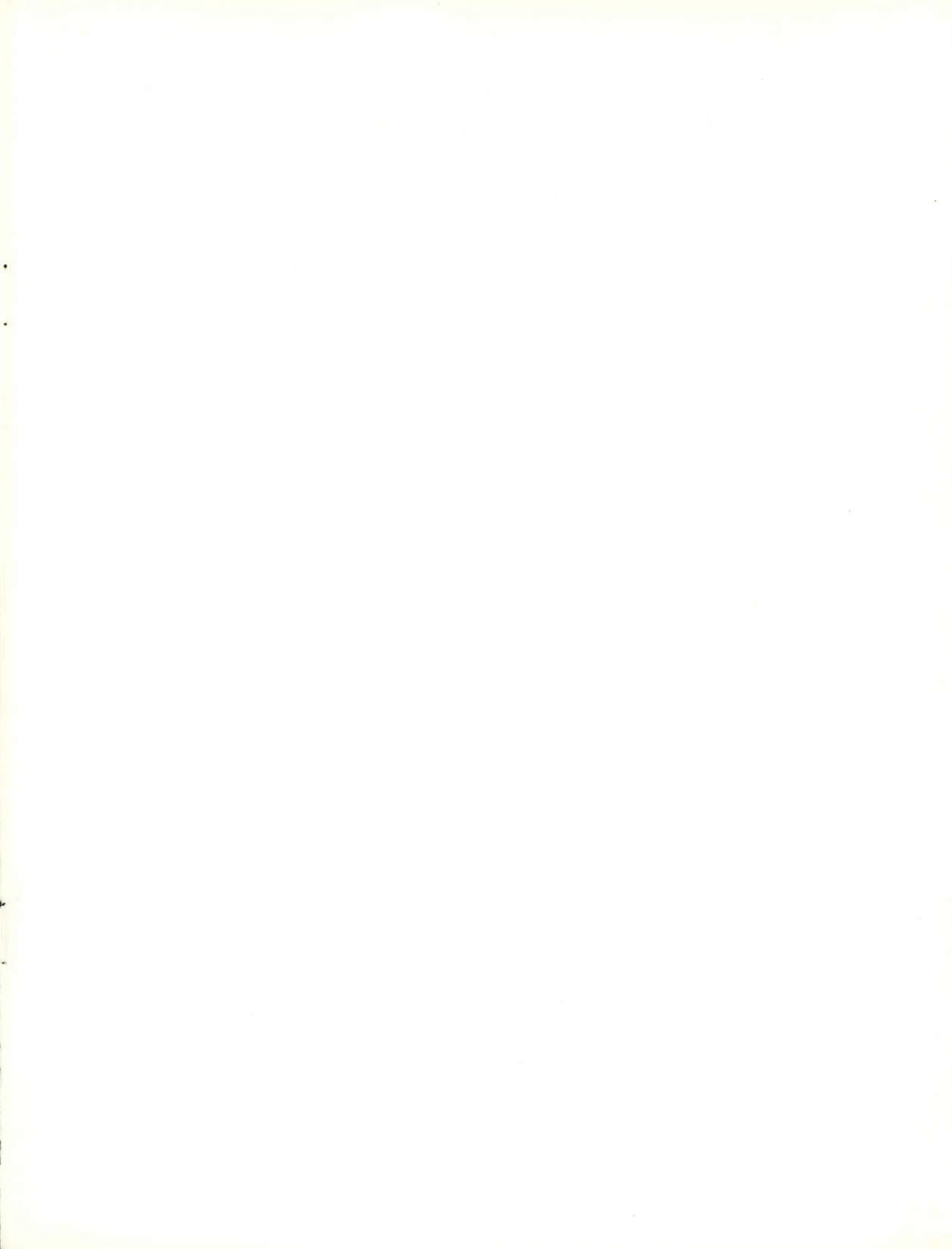


**Converter's Temporary Cardboard Tag (Transportation Code §503.0625).** A converter may issue a temporary cardboard tag for use on an unregistered vehicle for demo drives, to move the vehicle from one of the converter's places of business to another, to road test the vehicle, or to transport the vehicle for repair or reconditioning. A converter or employee of a converter may not use the temporary tag for personal use.



**Dealer's Black Temporary Demonstration/In-transit Tag (Transportation Code §503.062).** The temporary black tag is an "in-transit" tag and is used for demo drives and transporting vehicles for repair or reconditioning. When a dealer purchases vehicles at auction or from another dealer, the vehicles should be driven to the lot with a black tag displayed.
