BIENNIAL REPORT OF THE TEXAS STATE LIBRARY

SEPTEMBER 1, 1946-AUGUST 31, 1948*

LEGISLATIVE REFERENCE DIVISION

The principal event of the past two years was the 144-day session of the Fiftieth Legislature of Texas. It was the first post-war session, and the members were faced by many new problems that called for unremitting, grinding work on the part of the Legislature, its employees and the Legislative Reference Division.

Research that ranged from trivial routine to difficult questions of constitutional law kept the staff under constant strain.

In addition to this work there were the regular tasks of the daily Legislative journals, the history of bills and resolutions, distribution of copies of the state constitution and Texas bulletins and the answering of the many questions that came by mail.

Some bill drafting was handled. However, due to the Division's being undermanned, the Office of the Attorney General did most of this work.

A new phase of work was that of obtaining copies of bills and resolutions immediately upon introduction and sending them by air express to the Legislative Reference Service of the Library of Congress.

Shipments of state documents, with accompanying check lists, were made at intervals during the biennium. A compiled list of these documents is included as an appendix to this report. (See Appendix C)

A considerable amount of research was done for various officials and departments. One tedious undertaking was the thinning of the extensive pamphlet files; a task that, fortunately, arises only at intervals of several years.

STATE ARCHIVES

In spite of the fact that the Archives are still scattered in various unsuitable places, causing the meager personnel endless hours of shifting, waiting for elevators and climbing stairs, the department accomplished a great deal of work during the biennium.

**In the absence of an approved biennial report from the Librarian for this period, the reports from the various divisions of the Texas State Library must suffice for this report.*

The indexing of the Navy rolls and the Pension Papers of the soldiers of the Republic was completed. The Custom Papers, a large and valuable collection, was filed by ports of entry and partially indexed. There was a number of additions to the miscellaneous newspapers filed and thousands of cards were added to the general reference index. Many of the reports of the departments, which were typed or mimeographed during the paper shortage of the war period were filed and indexed. A number of translations from the Spanish, also some from the French and German, were made for the different departments, chiefly the Governor's Office and Board of Pardons. Editorial work on the Senate Journal of the Ninth Legislature, which had not been printed, was begun, but is a slow and difficult task because of the paucity of records due to the confusion of the war years of the sixties and the reconstruction period. The most important and difficult work of the biennium was the rearrangement of the Ranger records in their proper order. The sale of the Lamar Papers, the Journals of the Fourth and Sixth congresses and other publications of the Archives were as usual. A mimeographed copy of the original Declaration of Independence was made for distribution. The work of the mending division was handicapped because of the scarcity of material.

The following additions to the Archives were made through purchase: The Lindsay Papers, consisting chiefly of correspondence and surveyor's notes; a small collection of Washington D. Miller, an addition to the file already in the Archives; a group of Confederate Naval flags, among them a signal flag of the famous steamship *Alabama*.

The following gifts were received: A scrapbook of the clippings of the "Birds-Eye View of the World," from Miss Laura Aline Hobby of Dallas, a member of the Library and Historical Commission; a number of History scrapbooks from the students of Austin High School; a scrapbook of "Revolutionary War Soldiers" compiled and given the Archives by Mrs. Mabel Taylor Quebedeaux of Austin; a large collection of papers dealing with the men of the Mier Expedition and Dawson's Company, bequeathed by Mr. Houston Wade of Schulenburg; papers of Colonel Willrich's Regiment in the Spanish-American War, a gift from Miss Adina de Zavala of San Antonio; a life of William Jones Cowan of Rowan County, North Carolina, who was slain with Fannin March 27, 1836, from Mr. William D. Kizziah of Salisbury, North Carolina; a manuscript volume "An Army Cook" by George E. Cowan, ex-army cook in World War I, from Mr. A. T. Jackson of Austin; a collection of Lowry-McKinney papers and pictures, from Mr. Reynolds Lowry of Austin, Texas. Mr. Fred Cotten of Weatherford has supplied the Archives with valuable material concerning early members of the Texas Legislatures, which serves as a beginning of a Directory of the Texas

Legislature. Manuscript volumes of the genealogy of the Carley and allied families were presented by Mr. W. H. Carley of San Angelo, Texas.

The following copies of documents were made through the courtesy of the owners: the papers of Prince Eugene Freeman, a citizen of Brazoria County, who was active in the Civil War and the years immediately following, property of Mr. George W. Glass, Houston; military notes and sketches covering the period from the Mexican War through World War I, by Col. H. M. Henderson, U. S. Army, Retired; sketches of pioneer citizens of Guadalupe County and Confederate letters, from Mrs. Max Weinert of Seguin; notes on the Blackwell family of Brazoria County, and the Gentry-Herford Genealogy, through Mr. W. E. Bard of Dallas; the diary of Rev. O. A. Fisher, 1872-1876, through the courtesy of Rev. H. L. Ledbetter, Austin, Texas; the Post Office records of Spring Branch, Comal County, Texas, C. Gottlieb Elbel, Post-master, 1867-1872, through Mr. Otto Haas of New Braunfels, Texas. Also, framed lists of voters of Travis County for 1840 and 1861 were given to the Archives by Mrs. D. B. Gracy, Austin. Mr. Emory Bailey of Dallas, Texas, presented to the Archives portraits of the following citizens of Texas: Thomas Jefferson Moore, Charles William Wallace, T. L. Burnett, Ernest Emory Bailey, T. C. Crosson, and Henry T. Staiti.

Very few transfers of documents from other departments were made during the biennium. A number of redemption receipts were transferred from the Comptroller's Office, and campaign expense accounts for 1945, 1946, 1947 from the State Department. The results of the Tax Board Survey, a WPA project were transferred to the State Archives by The University of Texas.

LOAN AND GENERAL REFERENCE SERVICE

During the first period of the biennium the loan and general reference service to individuals and small groups was handled by the Loan Assistant and a clerk who assisted in the service for the blind. With the reorganization of the Library on a functional basis at the beginning of the second period the Loan and General Reference Division was created and took over all the lending services of the Library with the exception of large loans to libraries, which are the responsibility of the Extension Division.

The services include loan of books directly to individuals and families who have no other library service, loans to individuals through local libraries and schools, and loans of collections to clubs, libraries and communities. Since the patrons of the State Library are scattered throughout the State, most of the circula-

tion and reference work is carried on by mail. The reference service includes the answering of requests for information, selection of books to meet specific needs of individuals and groups and compiling books lists for the use of individuals, groups and organizations.

A service of special interest during the biennium was that to the County Home Demonstration Clubs. In so far as its limited resources permitted, the State Library cooperated with the Texas Home Demonstration Association in its educational program by lending collections of books on the reading list approved by the Association to the local clubs requesting them.

In spite of extremely crowded conditions and almost inaccessible shelves, the service to the blind was improved in all phases of its activities during the second period of the biennium. At the beginning of the period additions to the staff made it possible for the Assistant Loan and General Reference Librarian to devote half of her time to this service, and to direct the work of the full-time clerk. The State Library is the distributing center for Texas of books in Braille and those recorded on records which are called "Talking Books." Readers are supplied with books sent to them automatically at regular intervals. The enlargement of the staff has resulted in more prompt and regular service to the readers of Talking Books. However, the service to those who read Braille will remain largely ineffective as long as much of the book stock is inaccessible. Many blind readers who should receive prompt service from their own State will continue to borrow from distant sources, calling on efficient services in Denver, Cincinnati, New York and other cities.

A long needed weeding of obsolete material from overcrowded shelves was undertaken during the biennium. The entire book collection was culled and rearranged for more effective use and to provide space for new books.

EXTENSION DIVISION

The Extension Division was without a director for the first part of the biennium. The position was filled on April 1, 1947, and the work done during the remaining seventeen months of the biennium laid a sound basis for future activities of the State Library in a state-wide library development program.

The Division assisted the Texas Library Association's County division through regional meetings and talks to groups and special suggestions to individuals; led a three day County Division workshop; cooperated with Friends of Libraries throughout the State; assisted Texas Home Demonstration Association and Texas Congress of Parents and Teachers in developing their reading programs.

Assistance was also given to organizations whose work and objectives are related to those of the State Library; and in building a State Library Collection of books for loan to small libraries.

PROCESSING DIVISION

The processing, which should be one of the prime factors in the general scheme, is done in two small rooms in the basement of the capitol building. Ventilation is poor and there is not ample space for the material nor the number of people required for the work. Books, periodicals and other material must be stacked on tables, chairs, or any inch of available space on the floor.

In spite of this fact, during the past biennium, the following work was done by the department: There were processed 7,755 volumes and 14,895 cards were added to the main card catalog and the extension catalog.

The following United States Government documents were cataloged and analyzed: 271 books, 5,466 pamphlets, 72 periodicals, 88 serials, 567 maps. The maps mentioned here do not include the hundreds of maps received from the United States War Department and Army Map Service which have not been cataloged.

During the biennium the Library received on exchange 1,948 official documents from states other than Texas; 1,731 of these

were cataloged and 217 were transferred to The University of Texas. Ninety-eight additional items, not state documents, were received on exchange. Four hundred sixty-seven items were received as gifts. Nine hundred forty-one volumes of books in Braille and 276 Talking Books were received. The total of 8,246 books were accessioned and a total of 5,883 worn out, duplicate, out-of-date or otherwise useless books were withdrawn. A total of 821 books were bound, and 283 magazines, 5 newspapers and 947 items were pamphlet bound.
