

AN OVERVIEW OF THE COMMISSION

Governor Mark White appointed 28 members to the fifth Governor's Commission for Women. The commissioners were appointed in May 1985 and served until January 1987. The members represented a variety of groups, vocations, and geographical areas of the state. The Commission met seven times over the 20 month period. An Executive Committee, composed of the chair, vice-chair, committee chairs and vice-chairs and executive director, met between Commission meetings.

The Commission continued the legacy established by the 1983-1985 White Commission. The work of the Commission was conducted through four committees: Issues, Information and Publications, Program Development, and Public Relations.

Major accomplishments of the Commission were:

- . Sesquicentennial Report on the Status of Women in Texas
- . Texas Women's Hall of Fame
- . Developing networks among women's groups
- . 1987 Legislative Agenda

The executive order to create and establish the Governor's Commission for Women states, "the goal of equal legal, social, political, economic, and educational opportunity and advancement of all women and men is critical to the future of our state."

In pursuit of this goal, the Commission

SESQUICENTENNIAL REPORT ON THE STATUS OF WOMEN Public/Private Policy Initiatives for Women in Texas

The Sesquicentennial Report on the Status of Women was the culmination of the work of the 1985-87 Commission. The project was a joint effort with the Lyndon B. Johnson School of Public Affairs and the School of Social Work at the University of Texas at Austin.

The project has several components:

Known Statistics: Statistics about issues covered in the project are scattered widely throughout Texas. Graduate students contacted agencies, libraries, and individual researchers in an effort to gather all possible statistics on the issues of concern.

Issues Survey: Commission members designed an issues survey that asked the respondent to identify the five most important issues from a list of 25. These 25 were the most important identified from a list of 80 in a survey conducted by the 1983-85 Governor's Commission for Women. Commission members circulated the surveys throughout the state between November 1985 and November 1986. Sharon A. Scott of the Psychology Department of West Texas State University and Commission member Nancy Garms analyzed over 14,000 responses.

The rankings below show the number of people who rated an issue in the top five. The issues identified as most serious by women of Texas were:

Forums: The Commission sponsored 17 regional forums between February and November 1986. Over 1600 women attended the meetings. The "Can We Talk" forums identified issues of importance to Texas women and gathered ideas for public/private sector programs that could be implemented around the state. Participants attended one of three concurrent workshops to "Write an Agenda that Works".

- . Women in the Workplace: Writing the Economic Agenda
- . Women in the Community: Writing the Public Agenda
- . Women in the Home: Writing the Family Agenda

Telephone Survey A telephone survey was conducted between October 10 and 19 by members of the University of Texas at Austin project team. The random sample included 673 Texans. The survey included questions on the attitudes of Texans toward policies with an impact on women's lives. The results, "Texans and Government: What Citizens Want," were released December 15, 1986. Project directors were Susan G. Hadden, Laura Lein, and Martha Williams.

<u>Legislation</u>: The project team made an analysis of all legislation proposed in the 69th Legislature for potential effects on women. Components of the project contributed to the formulation of a Legislative Agenda by the Commission.

At the 1985 Texas Women Hall of Fame, Governor White honored women from all branches of the armed forces who served with distinction in World War II.

As a part of Texas' Sesquicentennial observances, the Governor's Commission for Women appointed a Blue Ribbon Committee to select for special recognition 150 women who had made particularly notable contributions to the history of Texas. Brief sketches about the women were included in the program of the 1986 Texas Women's Hall of Fame.

DEVELOPING NETWORKS AMONG WOMEN'S GROUPS

Women have advanced in Texas through the efforts of many groups. The active collaboration among an increasing number of women in organizations and networks maximizes the energy of women. The networks include:

STATE AGENCY LIAISON GROUP

Liaisons represent state agencies, and they provide support and encourage programs for women in the public sector. Fran Herrington-Borre chaired the 1985 Group; Helen George chaired the 1986 Group; and Lillie Gilligan chairs the 1987 Group. Over 1000 attended the second Women in the Public Sector Conference, January 1986. Awards were given to the state agencies that make innovative efforts to promote women to executive levels and aid in the advancement of women. The 1986 winners were the Office of Secretary of State, the Department of Human Resources, and the Texas Employment Commission. The conference and awards program was selected as a regional finalist in a competition to identify innovative personnel programs in state government by the Council of State Governments.

THE TEXAS WOMEN'S COMMISSION FOUNDATION

The Foundation was incorporated in the spring of 1985. The Foundation is a non-profit organization which assists the Governor's Commission for Women by raising funds for research and educational programs. The Foundation has assisted with the Texas Women's Hall of Fame, the Sesquicentennial Research Project, the Texas Athletic Equity Project, and Envision's video of the 1985 and the 1986 Texas Women's Hall of Fame. The 1986-87 Board of Directors is composed of Chair Lunelle Anderson, Secretary Gay Erwin, Treasurer Pam Reznick, Pat Bailey, Anne Dickson, Sharon Lovick, Aurora Sanchez, Lynn Searcy, Carol Whitcraft, and Martha Whitehead. Other members who served on the 1985-86 Board included Helen Farabee, Jo Floyd, Mary Hardesty, Ann Simmons, and Martha Williams.

LOCAL WOMEN'S COMMISSIONS

Tyler, Cameron County, and Galveston formed women's commissions during the 1985-1987 biennium. One commission is organized on a regional basis—Southeast Texas Commission for Women includes Jefferson, Orange and Hardin Counties. Women's groups in Amarillo, El Paso, and Temple organized outside city government. Other local women's commissions are in Austin, Fort Worth, Longview, Lubbock, San Antonio, Temple, and Wichita Falls. In 1985, over 6,000 persons in 22 communities celebrated Women in Texas Week with local celebrations. Local commissions also assisted in sponsoring regional forums for the Sesquicentennial Research Project.

WOMEN'S LEGISLATIVE DAYS STEERING COMMITTEE

The Steering Committee for Women's Legislative Days strongly supported the Commission during the biennium. Women's Legislative Days, February 16 & 17, 1987 is co-sponsored by 37 organizations. Peggy Romberg chaired the Steering Committee.

1987 LEGISLATIVE AGENDA

At its July 1985 meeting, the Commission set as one of its five goals: "To encourage action on women's issues and concerns, with priority given to economic issues, family-related issues, and violence against women and children." After listening to women throughout the state speak out on a women's agenda and analyzing the issues surveys, the Commission adopted the following legislative agenda at its November 1986 meeting. Advocacy groups were identified as leadership organizations for each issue.

The Issues Committee provided leadership for a landmark Project on the Status of Women in Texas. A survey instrument was designed, circulated and tabulated, and 17 regional forums were held to further develop survey results. The LBJ School of Public Affairs and the School of Social Work at the University of Texas at Austin were enlisted to co-sponsor a Policy Research Project to identify and refine issues of concern of Texans. As a result of the Project, a legislative agenda was developed and presented to the 70th Session of the Texas Legislature.

An appointments flyer, "I would have appointed a woman, but..." was prepared, and 20,000 were printed. The Information and Publications Committee updated and reprinted Statewide Hotline Numbers card; 15,000 were distributed. How the Legislature Works, A Citizen Handbook, was reprinted, and 5,000 copies were distributed. Six editions of Texas Women, a newsletter of the Governor's Commission for Women were produced. The Committee disseminated information about the Commission and prepared a resource information packet for Commissioners.

PROGRAM DEVELOPMENT COMMITTEE

The committee served as a clearinghouse and encouraged replication of model programs found throughout the state. Three local commissions, Tyler, Galveston and Cameron County were organized during the biennium. Support and materials were supplied to local commissions throughout the state.
